Background

The state emergency operations plan assigns roles to certain state agencies in the event of an emergency or disaster. As required by Minnesota Statutes, section 12.09, subdivision 10, those state agencies must designate at least one employee to complete the emergency management training curriculum offered by the Minnesota Department of Public Safety division of Homeland Security and Emergency Management (DPS-HSEM). The statute also requires an agency to file a compliance plan with DPS-HSEM when all employees who have emergency management certificates leave the agency. A compliance plan designates another employee and provides a target date for the employee to complete the training

The current DPS-HSEM emergency management certificate program requires completion of 30 courses representing approximately 150 training hours. It typically takes two to three years to finish the program, which consists of independent study and classroom instruction. In-person classes were again postponed for most of calendar year 2021 due to social distancing guidance from the Centers for Disease Control and Prevention and the Minnesota Department of Health. This continued to delay the efforts of some agencies in completing DPS-HSEM's emergency management certification program. To alleviate these delays, DPS-HSEM developed a remote learning platform and curriculum.

Status Report

Three agencies filed compliance plans in 2020 and 2021 following the departure of designated employees:

- Office of the Attorney General
- Emergency Medical Services Regulatory Board
- Department of Military Affairs
- Department of Natural Resources
