RE: Semi-Annual Appointment Report, July 1 – December 31, 2021

Twice a year, MMB provides an Appointment Report that outlines the numbers of appointments that Minnesota state agencies made during the reporting period. This report fulfills the requirements outlined in Minnesota Statutes 43A.04, Subd. 7.

Takeaways from the report

- Minnesota state agencies made 4,943 appointments across all appointment categories between July 1 –
 December 31, 2021.
- This is a 45 percent increase (or 1535) in total appointments from the same reporting period last year. The statewide hiring freeze was lifted on July 1, 2021, which contributed to the increase in total appointments during this period.
- Competitive open appointments realized a 100 percent increase (or 1304 appointments) from the same reporting period in the previous year.

As a reminder, this number of appointments does not reflect the number of new employees. One employee may have several different appointments throughout the reporting period.
