## Introduction

The 2015 Minnesota Legislature enacted the Teacher Shortage Loan Forgiveness Program, effective August 1, 2015, <u>Minnesota Statutes 136A.1791<sup>1</sup></u>. The 2021 Minnesota Legislature amended the name of the Teacher Shortage Loan Forgiveness Program to the Teacher Shortage Loan *Repayment* Program (TSLRP) to better align the program's name to its design. The Minnesota Office of Higher Education (OHE) was tasked with establishing rules and administering the program. <u>Minnesota Administrative Rules<sup>2</sup></u> were adopted on Tuesday, February 28, 2017.

TSLRP is designed to provide student loan debt relief, in the form of repayment awards, to teachers working in licensure shortage areas identified by the Professional Educator Licensing and Standards Board (PELSB) in coordination with the OHE Commissioner using data collected for the "Teacher Supply and Demand Report." The loan repayment program was created as an incentive to encourage qualified licensed teachers to work in identified licensure shortage areas and rural school districts.

OHE is required to submit an annual report by February 1 to the chairs of the K-12 and higher education committees of the Legislature. The report must include (1) the number of individuals who received loan repayment, (2) the race or ethnicity of the teachers participating in the program, (3) the licensure areas and school districts in which the teacher taught, (4) the average amount paid to a teacher participating in the program, and (5) other summary data identified by the commissioner as outcome indicators.

Currently, 2020 TSLRP applications have been awarded, 2021 applications are in the process of review, and the 2022 application is anticipated to launch in spring of 2022.

### **Shortage Areas**

The shortage area categories and identification process used in the application and awarding process were significantly amended as a result of legislation signed into law in 2021. These changes went into effect beginning in Fiscal Year 2022. Please see previous annual reports for more details on shortage areas used in prior years.

### **License Shortage Areas**

OHE coordinates with PELSB to identify license shortage areas on an annual basis for the purposes of administering this program. However, some of the data used to identify license shortage areas is not collected annually because the "Teacher Supply and Demand Report" under section Minnesota Statutes <u>122A.091</u>, <u>subdivision 5</u> is only produced every two years. According to Minnesota Statutes 136A.1275, subdivision 1, only licensure areas within the following fields may be identified as a license shortage area for purposes of this section:

- (1) English as a second language;
- (2) early childhood;
- (3) special education;
- (4) career and technical education;
- (5) science, technology, engineering, arts, and math; and
- (6) world languages.

## **Application and Award Process**

A TSLRP applicant may receive a maximum of \$1,000 per year, not to exceed the balance of the applicant's qualified educational loans, including principal and interest. An applicant may receive a lifetime maximum of five awards.

OHE assumed the likelihood of receiving more applications from eligible teachers than available funding, so OHE adopted the Minnesota Administrative Rules 4830.9130 addressing the criteria for how applicant awards will be prioritized. There were changes to the statute for the Teacher Shortage Loan Repayment Program in the 2021 Legislative session that were in conflict with the Rules. OHE assumed C, D, and E in Rules no longer apply and these items are no longer part of the application process. Then, the Race/Ethnicity and Rural School District requirements were incorporated into our prioritization process. The following elements addressed in the Rules and Statute were used to prioritize the awards among eligible applicants:

- A. Financial need of an applicant, considering the applicant's income (without regard to spousal income, if applicable), household size, and total qualified educational loan
- B. Previous awards to the applicant from TSLRP
- C. Whether the applicant is employed to provide classroom instruction in a license shortage area
- D. Whether the applicant taught in a rural school district
- E. Whether the applicant meets the Racial and Ethnic Groups Shortage Area requirement
- F. Statewide distribution of funds

### **Applicants**

To be an eligible applicant, an individual must:

- A. Hold a teaching license issued by the Minnesota Professional Educator Licensing and Standards Board;
- B. Be employed by a school district to provide classroom instruction in a license shortage area, teach in a rural school district, or belong to a racial or ethnic group underrepresented in the Minnesota teacher workforce;
- C. Not have received five annual awards from this program;
- D. Provide a completed application;
- E. Have outstanding qualified educational loan debt;
- F. Not submit false or misleading information on any application to this program; and
- G. Provide verification of the application of previously awarded funds toward eligible qualified educational loans, if the applicant has previously received an award.

### **Application Review and Verification**

Using the prioritization outlined in Adminstrative Rules and Statute, applications from eligible applicants are ranked. The applications with the highest priority are selected for review and verification within the amount of available funding.

Applicants selected for verification are provided with notice to submit additional supporting documentation. The additional supporting documentation included:

- A. Application Data Verification Form
- B. Employment Verification Form (completed by school or school district representative)
- C. Verification of Qualified Educational Loans (statements from lenders and servicers)
- D. Verification of Income and Household Size (federal tax forms)

All applicants are notified of their application status by email communication.

### **Award Process**

Awards are made to selected applicants after verification is complete. Recipients receive award funds directly. Within 60 days of the disbursement date, recipients must submit verification that the full amount of loan repayment disbursement was applied toward one or more qualified educational loan. Recipients who do not provide the required documentation are not eligible for future program awards and may be subject to other penalties described in the statute.

## **Applications**

To date, six application periods have been made available:

- 2016 Applications (2015-2016 teaching assignments): May 26, 2016 June 30, 2016
- 2017 Applications (2016-2017 teaching assignments): May 20, 2017 June 30, 2017
- 2018 Applications (2017-2018 teaching assignments): May 10, 2018 June 30, 2018
- 2019 Applications (2018-2019 teaching assignments): June 11, 2019 July 15, 2019
- 2020 Applications (2019-2020 teaching assignments): August 1, 2020 September 30, 2020
- 2021 Applications (2020-2021 teaching assignments): August 2, 2021 September 30, 2021




