## Introduction

The 2021 Legislature enacted the Student Teacher Grants in Shortage Areas (Formerly Teacher Candidate Grants), Minnesota Statutes 136A.1275.

The Student Teacher Grants in Shortage Areas (STSA) program is designed to provide postsecondary financial assistance to eligible students enrolled in Minnesota teacher preparation programs during one term in which the student is completing a required 12 week or more student teaching experience and intend to teach in a license shortage area or rural school district after graduating and receiving their teaching license.

The Minnesota Office of Higher Education (OHE) is required to submit an annual report by February 1 to the chairs and ranking minority members of the legislative committees with jurisdiction over E-12 and higher education finance and policy. The report must include: (1) the total number of awards, the total dollar amount of all awards, and the average amount, (2) the number of eligible applicants and the number of student teachers receiving an award, each broken down by postsecondary institution, (3) the licensure areas and school districts in which the student teachers taught, and (4) other summary data identified by the commissioner as outcome indicators, including how many student teachers awarded in a rural teacher grant were employed in a rural school district after graduation.

This report will provide preliminary data for fiscal year 2022 as of December 31, 2021. Currently, only fall 2021 term awards have been disbursed.

## **Application and Award Process**

A complete application must be on file in order for student to be eligible to receive funds. Complete applications include both a student section and a postsecondary institution section. The Complete Application Date is the date all documentation needed for a complete application has been submitted to OHE.

To meet statutorily required application processing requirements and award notification deadlines, OHE sets priority application deadlines for each term. Applications received by the priority application deadline are equally considered for an award regardless of when the application was received. Applications are still be accepted after the priority application deadline but students are much less likely to be awarded depending on the availability of funds. If funds are available, eligible applications are awarded based on the Complete Application Date.

## Applicants

To be an eligible applicant, an individual must:

- Be enrolled in a Minnesota teacher preparation program approved by the MN PELSB that requires at least 12 weeks or more of student teaching experience;
- Must be completing an eligible student teaching experience in the term applying to receive grant.
- Meet Satisfactory Academic Progress (SAP) as defined by the institution;
- Not be in default on a federal or state student loan;
- Have not received a grant from this program in a previous term;
- Demonstrate financial need; and
- Meet one or more of the following requirements:
  - o Intend to teach in a designated Rural School District in Minnesota.
  - o Intend to teach in an identified license shortage area.

## **Award Selection Process**

The amount of available funds for the fiscal year is separately allocated by term. One-third to fall terms and twothirds to spring/summer terms. This is to account for a greater number of students completing eligible student teaching experience in spring terms compared to fall terms.

Complete applications from eligible students are processed by term (fall or spring/summer). All complete and eligible applications received by the priority application deadlines are processed and equally considered for an award regardless of the application date. If there are insufficient funds to make awards to all eligible applicants with applications received by the priority application deadlines, awards are prioritized based on the following:

- Applicant financial need based on Expected Family Contribution (EFC), Family Income and unmet financial need.
- Whether or not the applicant intends to teach in both a rural school district and a license shortage area.

Eligible applicants with complete application dates after the priority application deadline date for the term are not awarded and then placed on a waiting list. If funds become available, awards are made to students on the waiting list based on the complete application date.

## **Award Process**

Award amounts are based on the student's unmet financial need using the following calculation:

Student Total Cost of Attendance for the Term (Federal Title IV Cost of Attendance which is used for federal financial aid programs and includes tuition, fees, books, supplies, transportation, room and board and miscellaneous expenses)

- Federal Pell Grant
- Federal SEOG Grant
- Federal TEACH Grant
- Minnesota State Grant
- Minnesota Postsecondary Child Care Grant
- Minnesota GI Bill
- Tribal Scholarships
- Institutional Scholarships or Grants
- Tuition Waivers
- All other scholarships or grants
- = STSA Award (< Maximum Award Amount)

Award amount guidelines:

- Maximum award amount is \$7,500.
- OHE may reduce award amounts based on the amount of available funding.

Award is for one term only and must be awarded for a term in which student is completing an eligible student teaching experience.

As required by statute, students selected for an award are notified by OHE by the following dates:

- Fall awards: August 15
- Spring awards: December 1
- Summer awards: May 1

Award Notification Deadlines do not apply in cases where grants are awarded to applicants who applied after the priority application deadlines and funds remained after the initial round of grants are awarded.

## **Disbursement Process**

Disbursements are made directly to the eligible postsecondary institution. Funds are transferred to the postsecondary institution via EFT.

# **Appendix B: Student Teacher Grants in Shortage Areas** Statute

## 2021 Minnesota Statutes

## 136A.1275 STUDENT TEACHER GRANTS IN SHORTAGE AREAS.

Subdivision 1.Establishment.

(a) The commissioner of the Office of Higher Education must establish a grant program for student teaching stipends for low-income students who intend to teach in a license shortage area or rural school district after graduating and receiving their teaching license.

(b) "License shortage area" means a licensure area that is identified as a shortage area by the Professional Educator Licensing and Standards Board in coordination with the commissioner using data collected for the teacher supply and demand report under section <u>122A.091</u>, <u>subdivision 5</u><sup>1</sup>, provided that only licensure areas within the following fields may be identified as a license shortage area for purposes of this section:

- (1) English as a second language;
- (2) early childhood;
- (3) special education;
- (4) career and technical education;
- (5) science, technology, engineering, arts, and math; and
- (6) world languages.

(c) "Rural school district" means a school district with fewer than 30 resident pupil units under section <u>126C.05</u>, subdivision  $6^2$ , per square mile.

Subd. 2. Eligibility.

To be eligible for a grant under this section, a student teacher must:

(1) be enrolled in a Professional Educator Licensing and Standards Board-approved teacher preparation program that requires at least 12 weeks of student teaching;

(2) demonstrate financial need based on criteria established by the commissioner under subdivision 3;

(3) be meeting satisfactory academic progress as defined under section <u>136A.101<sup>3</sup></u>, subdivision 10; and

(4) intend to teach in a rural school district or intend to teach in a license shortage area. Intent to teach in a license shortage area must be verified based on the teacher license field the student is pursuing. To verify intent to teach in a rural school district, the student must submit to the commissioner a completed affidavit, prescribed by the commissioner, affirming the student's intent to teach in a rural district following graduation. Upon obtaining employment after graduating, the teacher shall report to the office the name of the school district in which the teacher is teaching.

Subd. 3.Administration.

(a) The commissioner must establish an application process and other guidelines for implementing this program. The commissioner must notify grant recipients of their award amounts by the following dates:

(1) for fall student teaching placements, recipients must be notified by August 15;

(2) for spring student teaching placements, recipients must be notified by December 1; and

(3) for summer student teaching placements, recipients must be notified by May 1.

These notification deadlines do not apply in cases where grants are awarded to student teachers who applied after application deadlines and funds remained after the initial round of grants were awarded.

(b) The commissioner must determine each academic year the stipend amount up to \$7,500 based on the amount of available funding, the number of eligible applicants, and the financial need of the applicants.

(c) The commissioner must give equal consideration to all eligible applicants regardless of the order the application was received before the application deadline.

(d) If there are insufficient funds to provide an award to all eligible applicants, the commissioner shall prioritize the awards to eligible participants based on:

(1) the financial need of an applicant; and

(2) whether the applicant intends to teach in both a rural school district and a license shortage area.

Subd. 4. Reporting.

(a) By February 1 of each year, the commissioner must submit a report to the chairs and ranking minority members of the legislative committees with jurisdiction over E-12 and higher education finance and policy. The report must include the following information:

(1) the total number of awards, the total dollar amount of all awards, and the average award amount;

(2) the number of eligible applicants and the number of student teachers receiving an award, each broken down by postsecondary institution;

(3) the licensure areas and school districts in which the student teachers taught; and

(4) other summary data identified by the commissioner as outcome indicators, including how many student teachers awarded a rural teacher grant were employed in a rural school district after graduation.

(b) By July 1 of each odd numbered year, the commissioner must update and post on the office's website a list of licensure shortage areas eligible for a grant under this section.
