As requested, according to MS 125A.62. Subd. 8, listed below are the competitive grants that were awarded to Minnesota State Academies since our last report dated December 4, 2020.

**Formula 140 American Rescue Plan (ARP) Individuals with Disabilities Education Act (IDEA) Part B Section 611 ARP, CFDA 84.027X, H027X210087 (\$7,552.87)** Grant used for providing special instruction and related services for children with disabilities ages 3-21 focusing on challenges from the pandemic; school re-entry, disruption in education of children with disabilities and mental health services.

**Formula 141 American Resue Plan (ARP) SFY 2022 US Dept of Education IDEA Part B Section 619 Preschool Incentive, Ages 3-5, FFY 2021, CFDA 84.173X, H173X210086 (\$657.10)** Grant used for providing special instruction and related services for children with disabilities ages 3-5 focusing on challenges from the pandemic; school re-entry, disruption in education of children with disabilities and mental health services.

**Formula 150 SFY2022, Governor's Discretionary American Rescue Plan Funds-Summer Academic and Mental Health Support (\$10,777.76)** Grant used to expand mental health and well-being supports for students and increasing opportunities within our Summer School Program.

**Formula 156 SFY2021 Application, SFY2022 Budget Only (ESSER II) (\$29,463.20)** Grant used to purchase additional Technology, Personal Protective Equipment, and provide mental health services for students, staff, and families.

**Formula 164 SFY2022 Expanded Summer Programming \$4.5M (\$78,606.68)** Grant used to expand our Summer School Program by an additional week.


**Formula 169 SFY2022 ESSER III 5% American Rescue Plan Funds-Learning Recovery, Lost Instructional Time (\$104,384.82)** Grant used to fund activities focused on learning recovery and lost instructional time for students.

**Formula 170 SFY2022 Minnesota COVID-19 Testing (\$40,000.00)** Grant used to purchase equipment and supplies related to onsite COVID-19 Testing along with funding additional staff hours needed for contract tracing and COVID-19 testing.

**GenYOUth COVID 19 Emergency School Meal Delivery Fund (\$2,500)** Grant used to purchase disposable containers, supplies, and equipment related to food services for the Minnesota State Academy Dietary Department.
