Executive Summary

The Study Abroad Health and Safety Report informs students and parents about significant health and safety incidents during studying abroad. Incidents, as reported on the Study Abroad Health and Safety Survey, are defined as deaths and hospitalizations that occurred during participation in a study abroad program. Minnesota legislation ([Minn. Stat. § 5.41¹](https://www.revisor.mn.gov/statutes/cite/5.41)) aims to strengthen student safety by asking Minnesota colleges and universities with study abroad programs to annually report:

- Hospitalizations and deaths of students as a result of and during program participation,
- Country, primary program host, and program type of each incident, and
- Whether the program complied with health and safety standards set by the nationally recognized Forum on Education Abroad or a similar standard.

Key Takeaways

- Since 2015, 66,649 Minnesota students have participated in study abroad programs.
- During the 2020 – 2021 academic year, amid the COVID-19 pandemic, only 16 Minnesota institutions reported offering study abroad programs. Of the institutions offering programs, 11 institutions sent a total of 390 participants compared to about 11,800 students during a typical year.
- Since 2015, when this report began, there have been 178 incidents resulting in hospitalizations and zero deaths of students participating in study abroad programs.
- Europe continues to be the most common destination for study abroad students. The United Kingdom (7,362 participants), Italy (5,636 participants), Spain (4,215 participants), and France (3,203 participants) are the most popular study abroad destinations.
- Ecuador, India, Spain, and Italy have the most reported incidents involving hospitalization, with incident rates of 1.12% (14 incidents), .82% (11 incidents), .26% (11 incidents), and .20% (11 incidents) respectively.
- The University of Minnesota – Twin Cities sends the largest number of students on study abroad programs (17,749 participants). The University of St. Thomas (7,218 participants) sends the second-highest number of students on study abroad programs.

Data Privacy

The Minnesota Office of Higher Education (OHE) adheres to current federal and state data privacy laws and best practices to protect the privacy of individual students. [Minnesota Statutes § 135A.15, Subdivision 6](#)² requires that reports and data be prepared and published as summary data, as defined in [Minnesota Statutes § 13.02, Subdivision 19](#)³, and are consistent with federal and state laws governing access to educational data and student privacy.

OHE's policy for complying with federal and state laws governing access to student records is to suppress student data in cells containing fewer than ten students. This year's report introduces changes in student data suppression. Beginning with the 2021 report, suppression of participant counts no longer occurs if fewer than ten students appear in a table or chart as the report contains no student demographics or other potentially identifying information. However, the suppression of incident counts still occurs if participant counts are fewer than ten.

Introduction

The Study Abroad Health and Safety Report serves to inform students and parents about significant health and safety incidents occurring while studying abroad. Incidents, as reported on the Study Abroad Health and Safety Survey, are defined as deaths and hospitalizations that occurred during participation in a study abroad program. Minnesota legislation ([Minn. Stat. § 5.41⁴](#)) aims to strengthen student safety by asking Minnesota colleges and universities with study abroad programs to report annually on the hospitalizations and deaths of students during program participation, the country, primary program host, and program type of each incident and whether the program complied with health and safety standards set by the nationally recognized Forum on Education Abroad or a similar standard.

Study Abroad Institutions

During the 2020 – 2021 academic year, 16 Minnesota institutions offered study abroad programs, and 27 institutions temporarily suspended programs due to COVID-19, resulting in lower participation than prior years. Of the institutions offering programs, 11 institutions sent a total of 390 participants. For context, about 11,800 students participate in study abroad programs from institutions across Minnesota during a typical year.

Due to the uncertainty and risk associated with COVID-19, many of Minnesota’s top study abroad destination countries issued travel restrictions during the 2020 – 2021 academic year. These travel restrictions significantly impacted the ability of Minnesota institutions to continue study abroad programs during the 2020-2021 academic year. For example, the most popular destination country, the United Kingdom, maintained a “Do Not Travel” advisory through July of 2021⁵. The restrictions, coupled with uncertainty regarding the future spread of COVID-19, affected the ability of Minnesota institutions to adhere to study abroad health and safety standards.

Study Abroad Health and Safety Standards

The nationally recognized Forum on Education Abroad⁶ offers a series of standards regarding study abroad health and safety best practices. Table 1 displays institutions’ responses to a question on the annual survey asking whether or not their study abroad programs comply with these or similar standards. Institutions voluntarily reported their compliance with the following criteria:

1. 4.2.2. Collaborators shall discuss and clarify:
 - Compatibility of missions and alignment of goals, objectives, and outcomes
 - Determining the objectives of the partnership
 - Establishing respective financial responsibilities

- Assigning functional roles or tasks to responsible parties
 - Establishing policies and procedures
 - Managing health, safety, and security risks
2. 5.1.5 Each organization shall have policies and procedures in place that govern personnel matters, conduct, and training, including, but not limited to:
 - Participant conduct management
 - Communication protocols
 - Participant health, well-being, safety, and security
 - Emergency management and response
 - Partner relationships, roles, and responsibilities
 3. 5.1.6 Each organization shall have policies that govern student matters, including:
 - Academic affairs: course availability, assessment, credit transfer, grade conversions, grade appeals, research ethics, and academic integrity
 - Student affairs: student conduct matters, including, but not limited to, drug and alcohol use, mental health and well-being, culturally-sensitive behavior, sexual misconduct, travel, housing, disciplinary process, and appeal process
 - Student finances: financial aid, scholarships, program cost disclosure, payment, cancellation, and reimbursement
 4. 5.1.7 Each organization shall have policies and procedures in place regarding security and risk management that prioritize the health, well-being, and safety of students and personnel, including, but not limited to:
 - Risk assessment and monitoring for program locations and activities
 - Tracking, responding to, and reporting critical incidents
 - Written emergency plans and protocols
 - Insurance coverage
 5. 5.2.4. Each organization shall provide risk management, preparedness, and emergency response measures for all programs and ensure insurance coverage is in place.
 6. 5.2.7. Responsible parties shall provide a safe environment that supports learning for all students.
 7. 6.1.8. Responsible parties shall communicate expectations for conduct and consequences of behaviors to participants.
 8. 6.1.10. Responsible parties shall provide students with information related to accessing physical, mental, and emotional health and well-being services.
 9. 6.1.11. Responsible parties shall prepare students to manage their safety by providing resources related to concerns including, but not limited to:
 - physical risks
 - behavior

- property crime
- liability and legal issues
- sexual misconduct
- identity-based discrimination
- country-specific recommendations

10. 6.2.7. Responsible parties shall support students in accessing physical, mental, and emotional health and well-being services.

11. 6.2.8. Responsible parties shall support students in managing their safety by providing resources related to concerns, including:

- physical risks
- behavior
- property crime
- liability and legal issues
- sexual misconduct
- identity-based discrimination
- communication, social media use, and freedom of expression
- country-specific recommendations

12. 6.3.4. Responsible parties shall provide resources related to student mental and physical well-being related to program participation.

Study Abroad Hosts

Study abroad program hosts are institutions or organizations other than the student's home institution responsible for the study abroad program. Program hosts are responsible for the administrative details of the study abroad program and any other aspect of the program that assures its success, including, but not limited to, student housing, local transportation, and emergency response and support. There are seven classifications of study abroad host:

- 1) a study abroad program taught by home university faculty or staff,
- 2) a study abroad program from a university overseas,
- 3) a third-party program host,
- 4) a study abroad program from another U.S. university,
- 5) a study abroad program from a consortium, and
- 6) a study abroad program taken as an independent study. The majority of study abroad participants in Minnesota (60.6%) are participating in study abroad programs hosted by their home university faculty or staff, and
- 7) an unknown program host (new for 2021 only)

Study abroad hosts are held to the same health and safety standards mentioned in the prior section.

Study Abroad Data

Since 2015, 66,649 Minnesota students have participated in study abroad programs. Of those students, only 178 experienced incidents that resulted in hospitalizations since 2015. There have been no deaths of Minnesota students participating in study abroad programs since data collection began.

Europe continues to be the most common destination for study abroad students. The United Kingdom (7,362 participants), Italy (5,636 participants), Spain (4,215 participants), and France (3,203 participants) are the most popular study abroad destinations. Cameroon and Ethiopia have the most reported incidents involving hospitalization, with incident rates of 5.26% and 4.55%, respectively. The University of Minnesota – Twin Cities sends the largest number of students on study abroad programs (17,749 participants). The University of St. Thomas (7,218 participants) has the second-highest number of study abroad programs.

Between 2015 and 2021, 0.27% of participants (178 of 66,649 students) were involved in an incident while participating in a study abroad program. Over the same seven-year time period, the highest number of incidents reported by a single college is 33 resulting in an overall incident rate of 0.19%.

All of the incidents reported between 2015 and 2021 were hospitalizations. The most frequent known causes of hospitalization were gastrointestinal illnesses or bacterial/viral infections. Other hospitalizations with a known cause resulted from physical injury, rashes, animal bites, psychological illness, parasitic infections, urological conditions, respiratory illness, seizures, and dental conditions. There were no reported incidents for the 2020 – 2021 academic year, likely resulting from lower participation due to COVID-19.

Most study abroad students participate in programs hosted by their home university faculty or staff and have an incident rate of only 0.23%. All other program hosts have a combined incident rate of 0.32%.

Locations of Incidents

While incidents involving study abroad participants occur on every continent, the majority of incidents occurred in Europe (34%) and Asia (26%). Europe had the largest concentration of study abroad participants, with over 37,000 participants in the last seven years.

COVID-19

The COVID-19 pandemic created many challenges for study abroad programs both from the institution and student perspective. During the school year 2019-2020, many institutions with students studying abroad scrambled to have students return home safely. COVID-19 forced many institutions to cancel or delay study abroad programs well into the 2020-2021 school year. During the 2020 study abroad annual survey, institutions were asked optional questions about students who returned early due to the COVID-19 pandemic, along with questions on details of the cancellations. Twenty-eight institutions answered the optional questions about study abroad and COVID-19.

Out of the 5,687 students who participated in study abroad programs, many came home prior to completing their study abroad program. Institutions were encouraged, but not required, to report on how many students came back to the U.S. early. Institutions reported that 1,861 students returned home early in the 2019-2020 school year — roughly one in three students who studied abroad.
