## Re: Report to the Legislature on the Status of Indian Gaming in 2021

Dear Senator Dahms and Representative Stephenson:

This report is submitted in accordance with Minnesota Statutes, section 3.9221, subdivision 5, which provides:

The governor, the attorney general, and the governor's designated representatives shall report to the house of representatives and senate committees having jurisdiction over gambling regulation annually. This report shall contain information on compacts negotiated, and an outline of prospective negotiations.

Minnesota Statutes, section 3.9221, subdivision 2, also specifies:

If the governor appoints designees to negotiate under this subdivision, the designees must include at least two members of the senate and two members of the house of representatives, two of whom must be the chairs of the senate and house of representatives standing committees with the jurisdiction over gambling policy.

There have been no requests to negotiate new compacts or renegotiate existing compacts pursuant to the federal Indian Gaming Regulatory Act during 2021. Thus, there is nothing to report regarding the negotiation of compacts or an outline of prospective negotiations.

According to the Minnesota Department of Public Safety's Alcohol and Gambling Enforcement Division ("AGED"), AGED executed nine technical amendments this year:

AGED executed four technical amendments to the Tribal State Compact for the Control of Class III Games of Chance with the Lower Sioux Indian Community, the Bois Forte Band of Chippewa, the Red Lake Band of Chippewa Indians, and the Upper Sioux Community. These

amendments allow these tribes to operate video games of chance with single partitioned hard drives, rather than the two separate hard drives required under the current Compacts. This update reflects new technological developments and ensures the integrity of electronic gaming devices.

AGED executed a technical amendment with the Mille Lacs Band of Ojibwe regarding minimum probability standard for maximum payout. The amendment changes the minimum from 1 in 17,000,000 (one in seventeen million) to 1 in 100,000,000 (one in one hundred million).

AGED executed two technical amendments with the Mille Lacs Band of Ojibwe and the Lower Sioux Indian Community regarding non-bordered decks of cards. Blackjack must be played with at least one non-bordered deck of cards with backs of the same color and design and one colored cutting card. Before being put into play, the cards must arrive at the gaming location sealed and wrapped. This is not a novel topic and was originally addressed in 1990 with several tribes when a card vendor was unable to produce certain playing cards, and the property chose to use different decks.

AGED also executed technical amendments with the Shakopee Mdewakanton Sioux Community and the Mille Lacs Band of Ojibwe regarding the placing of side bets in blackjack. These amendments allow the tribes to set rules governing the placing of side bets.
