# Required Report on EMS Waivers Pursuant to HF 4065

This report is filed by the Emergency Medical Services Regulatory Board (EMSRB) to fulfill requirements outlined under Subdivision 6 of Section 23 of HF4065, which was signed into law on June 2, 2022. This report is being transmitted to the Chairs and Ranking minority member of the respective Health and Human Services Finance and Policy Committees as required by law. It is also being transmitted to the legislative ex-officio members of the EMSRB.

All information contained in this report is true and correct as of 09:00 A.M. on June 29, 2022. The next required report is due September 30, 2022

#### **Process to Date**

HF 4065 was signed into law on June 2, 2022, a portion of this bill provided EMS agencies across Minnesota with more flexible options from a regulatory perspective in the areas of minimum staffing, the use of expired medications and equipment, and the ability to on a temporary basis utilize expired personnel to meet minimum staffing requirements. Utilization of any such waiver required notification to the EMSRB, and subsequent reporting to specific members of the legislature.

On June 3, 2022, the effective date of the legislation the EMSRB emailed a memo to all ambulance agencies in the state information on the implementation of these waivers, including all forms that would need to be completed and sent to the EMSRB. This information was also placed on our publicly available website a copy of that memo is included as an attachment to this report.

The EMSRB has also conducted multiple virtual town hall meetings with EMS agencies and with the Minnesota Ambulance Association to answer questions from EMS agencies and to further push the information out.

## **Usage of Minimum Staffing Waiver**

One EMS service serving the Hoyt Lakes PSA with both a BLS and Part-Time ALS license, has filed for the staffing waiver as outlined in Subdivision 3 of Section 23. They intend to utilize the waiver through December 31, 2023, and to do so on up to three (3) ambulances

## **Usage of Medication/Equipment Waiver**

One EMS service has submitted the required form to utilize expired medication/supplies and has reported that they will be doing so for the medication Amiodarone, which is an antiarrhythmic.

An additional EMS service has submitted the required form to utilize expired medication/supplies but has not yet reported any specific utilization of this waiver.

## **Usage of Expired Personnel**

The EMRB received no requests for the usage of expired personnel.

## **Summary**

The legislative waivers have been in effect 26 days as of the date of this report. While there have been multiple inquires, there have been few submissions. As time elapses the EMSRB expects to see more submissions from EMS agencies across the state. # RE: Temporary requirements governing ambulance service operations and the provision of Emergency Medical Services.

The Minnesota Legislature has recently enacted provisions related to Minnesota Statute 144E; specifically related to the following:

- Staffing: use of a driver
- Use of expired medications and medical supplies
- Use of expired EMS personnel

#### **Staffing**

Minnesota Statute <u>144E.101 subdivisions 6 and 7</u> related to the staffing requirements of both Basic and Advanced Life Support ambulances.

Through January 1, 2024, the Minnesota Legislature has approved the following:

**Staffing**. (a) For emergency ambulance calls and interfacility transfers in an ambulance service's primary service area, an ambulance service must staff an ambulance that provides basic life support with at least:

- (1) one emergency medical technician, who must be in the patient compartment when a patient is being transported; and
- (2) one individual to drive the ambulance. The driver must hold a valid driver's license from any state, must have attended an emergency vehicle driving course approved by the ambulance service, and must have completed a course on cardiopulmonary resuscitation approved by the ambulance service.
- (b) For emergency ambulance calls and interfacility transfers in an ambulance service's primary service area, an ambulance service must staff an ambulance that provides advanced life support with at least:

- (1) one paramedic; one registered nurse who meets the requirements in Minnesota Statutes, section I 44E.001, subdivision 3a, clause (2); or one physician assistant who meets the requirements in Minnesota Statutes, section 144E.001, subdivision 3a, clause (3), and who must be in the patient compartment when a patient is being transported; and
- (2) one individual to drive the ambulance. The driver must hold a valid driver's license from any state, must have attended an emergency vehicle driving course approved by the ambulance service, and must have completed a course on cardiopulmonary resuscitation approved by the ambulance service.
- (c) The ambulance service director and medical director must approve the staffing of an ambulance according to this subdivision.
- (d) An ambulance service staffing an ambulance according to this subdivision must immediately notify the board in writing and in a manner prescribed by the board. The notice must specify how the ambulance service is staffing its basic life support or advanced life support ambulances and the time period the ambulance service plans to staff the ambulances according to this subdivision. If an ambulance service continues to staff an ambulance according to this subdivision after the date provided to the board in its initial notice, the ambulance service must provide a new notice to the board in a manner that complies with this paragraph.
- (e) If an individual serving as a driver under this subdivision commits an act listed in Minnesota Statutes, section 144E.27, subdivision 5, paragraph (a), the board may temporarily suspend or prohibit the individual from driving an ambulance or place conditions on the individual's ability to drive an ambulance using the procedures and authority in Minnesota Statutes, section 144E.27, subdivisions 5 and 6.

# Ambulance services wishing to utilize this model, as described in section (d) above, must complete the Temporary Staffing Notification Change form and submit it to EMSRB staff.

Note: Individuals who meet the definition of a volunteer (MS 144E.101 Subd. 15) and wish to obtain a Cooper Sam's Credit, may obtain an EMSRB number by creating an account in the <u>EMSRB eLicense site</u> and completing an application for Non-EMS Personnel.

#### Authorization to use expired emergency medications and supplies

Minnesota Statute <u>144E.103 subdivision 2(a)</u> related to the maintenance, sanitation, and testing of equipment, supplies, and drugs.

Through January 1, 2024, the Minnesota Legislature has approved the following:

Use of expired emergency medications and medical supplies.

(a) If an ambulance service experiences a shortage of an emergency medication or medical supply, ambulance service personnel may use an emergency medication or medical supply for up to six months after the emergency medication's or medical supply's specified expiration date, provided:

- (1) the ambulance service director and medical director approve the use of the expired emergency medication or medical supply;
- (2) ambulance service personnel use an expired emergency medication or medical supply only after depleting the ambulance service's supply of that emergency medication or medical supply that is unexpired;
- (3) the ambulance service has stored and maintained the expired emergency medication or medical supply according to the manufacturer's instructions;
- (4) if possible, ambulance service personnel obtain consent from the patient to use the expired emergency medication or medical supply prior to its use; and
- (5) when the ambulance service obtains a supply of that emergency medication or medical supply that is unexpired, ambulance service personnel cease use of the expired emergency medication or medical supply and instead use the unexpired emergency medication or medical supply.
- (b) Before approving the use of an expired emergency medication, an ambulance service director and medical director must consult with the Board of Pharmacy regarding the safety and efficacy of using the expired emergency medication.

(c) An ambulance service must keep a record of all expired emergency medications and all expired medical supplies used and must submit that record in writing to the board in a time and manner specified by the board. The record must list the specific expired emergency medications and medical supplies used and the time period during which ambulance service personnel used the expired emergency medication or medical supply.

Ambulance services wishing to use expired medications and medical supplies, must complete the Authorization to use expired supplies form and as described in section (c) above, record and report utilization to EMSRB staff at the close of each month.

#### Authorization to use expired EMT's, AEMT's, and Paramedics

Minnesota statute <u>144E.28</u> relates to the Certification of EMT's, AEMT's, and Paramedic, as well as the renewal requirements and forms of disciplinary action.

Through January 1, 2024 the Minnesota Legislature has approved the following:

Provision of emergency medical services after certification expires.

(a) At the request of an emergency medical technician, advanced emergency medical technician, or paramedic, and with the approval of the ambulance service director, an ambulance service

medical director may authorize the emergency medical technician, advanced emergency medical technician, or paramedic to provide emergency medical services for the ambulance service for <u>up</u> <u>to three months</u> after the certification of the emergency medical technician, advanced emergency medical technician, or paramedic expires.

(b) An ambulance service must immediately notify the board each time its medical director issues an authorization under paragraph (a). The notice must be provided in writing and in a manner prescribed by the board and must include information on the time period each emergency medical technician, advanced emergency medical technician, or paramedic will provide emergency medical services according to an authorization under this subdivision; information on why the emergency medical technician, advanced emergency medical technician, or paramedic needs the authorization; and an attestation from the medical director that the authorization is necessary to help the ambulance service adequately staff its ambulances.

EMT's, AEMT's, and Paramedics wishing to work with an expired certification, must complete the Request Form to work with an expired certification and obtain approval from both the Ambulance Service Director and Physician Medical Director. In addition, the ambulance service must comply with section (b) above by sending notifications to EMSRB staff.
