### RE: Semi-Annual Appointment Report, January 1 – June 30, 2022

Twice a year, MMB provides an Appointment Report that outlines the numbers of appointments that Minnesota state agencies made during the reporting period. This report fulfills the requirements outlined in Minnesota Statutes 43A.04, Subd. 7.

#### Takeaways from the report

- Minnesota state agencies made 6,205 appointments across all appointment categories between January 1 – June 20, 2022.
- This is a 46 percent increase (or 1,964) in total appointments from the same reporting period last year. The statewide hiring freeze was lifted July 2021, contributing to the significant increase in total appointments comparative to the previous year reporting period.

This number of appointments does not reflect the number of new employees. One employee may have several different appointments throughout the reporting period.
