In accordance with Minnesota Statutes 16E.21, Subd. 5, please find attached a report on projects currently funded through the Information and Telecommunications Technology Systems and Services Account, also known as the ITA account.

The attached report is current, as of September 15, 2021, and it includes the below information.

- The status of each project
- The name of each project currently funded through the ITA account
- A short description of the project
- The name of the State agency pursuing the project
- The balance of unexpended funds for the projects
- The budget status of the ITA portion of the project
- FY21 transfers to the ITA account totaled \$40,838,027

As of September 15, 2021, \$14,798 in ITA funds are scheduled to cancel back to the General Fund. This spans three projects, whose expenditures were less than anticipated.

Additionally, there were 14 instances of the transfer amount being less than the total amount originally requested by the agency for the project, as indicated below.
