Administrative Costs at Minnesota Health Plans, 2018 and 2019

The Minnesota Department of Health (MDH) is required to collect and publish information annually on administrative spending of health plans (also referred to as group purchasers) that are licensed to offer health insurance coverage in Minnesota. Due to delays caused by the COVID-19 pandemic response, data from 2018 and 2019 are reported together in this report.

This report presents administrative spending data for each health plan that collected more than \$3 million in total health premiums from Minnesota residents in a given year. The report includes a summary of high-level trends and findings for 2019, and in Appendix A and B, detailed tables for each eligible Minnesota group purchaser on 14 categories of administrative spending in 2018 and 2019, respectively.

As observed previously, Minnesota health plans consistently spend significant resources on administrative activities. In 2019, the latest year for which complete data were reported to MDH, health plans collectively spent \$2.17 billion to offer, design, sell, and enable use of health insurance benefits for Minnesota residents. As shown in Table 1, this amounted to an average of \$401 per insured Minnesotan in 2019.

After dipping slightly in 2017, administrative spending as a percent of total costs increased the next two years, reaching the highest proportion of total costs since 2009 (7.9 percent). Though high in terms of the preceding ten years, administrative health plan spending as a share of total costs was routinely higher prior to 2010.

Nevertheless, administrative health plan spending is one factor contributing to the high and rising cost of health insurance in Minnesota and the nation. For example, had health plans been able to maintain administrative spending as a share of costs just one-half of a percentage point below the 2019 value at 7.4 percent of total costs (the median of values observed in Table 1), premium costs for Minnesotans would have been about \$272 million less over the ten-year period shown.



With inflation largely remaining flat since 2009, aggregate health plan administrative spending has grown cumulatively over two and a half times faster than inflation for this period. By 2019, the cumulative increase in health care administrative costs matched the cumulative increase in health care claims costs, with both experiencing an increase of approximately 55 percent since 2009. However, this time period coincided with an increase in the number of people covered by health insurance, resulting in an increase of 39 percent on a per-insured Minnesotan basis between 2009 and 2019.

With the data available for this analysis, it is not possible to disaggregate factors driving administrative spending, analyze the economies of scale, or study the variation in spending over time. Still, in the future, it may be useful to analyze how administrative spending was affected by changes in the business climate, take-up of insurance coverage, the role of major investments (in systems or processes) and other market dynamics. Combining data used in this report with economic data from other sources may provide additional insight.

Health plan companies varied widely in their administrative load, as shown in Table 2. Administrative spending ranged from a low of less than two percent to approximately 61 percent of total spending. Several factors could influence this variation, including the size of the book of business, how established the health plan company is in the market, and if the plan continues to market their products to potential enrollees. Among the nonprofit health plan companies and affiliated insurance carriers, which control the majority of the Minnesota insurance market, the spread of administrative spending was narrower, ranging from six percent to 11 percent of total spending.


ADMINISTRATIVE COSTS AT MINNESOTA HEALTH PLANS 2018 AND 2019

Chart 2 shows the distribution of administrative expenses for all health plans in Minnesota, which spent over half of their administrative expenses on three primary activities, a distribution that has held fairly steady over time:

- General administration
- Claims processing
- Product management and marketing

The distribution of administrative spending by category for the subgroup of nonprofit health plan companies and affiliated insurance carriers, as shown in Chart 3, closely resembles the distribution for the overall market. This is not unexpected given that these nonprofit health plan companies and affiliated insurance carriers represent 88.2 percent of the Minnesota health insurance business (as share of premiums).

Chart 2. Distribution of Administrative Spending at all Health Plan Companies in Minnesota, 2019


