Executive Summary

The Minnesota State Grant program is a need-based financial aid program created to assist Minnesota resident undergraduates attending public and private postsecondary institutions in Minnesota. The program was established in 1969; and in fiscal year 2020, approximately 77,544 students were awarded grants, for a total of nearly \$208 million. The State Grant program is designed to provide choice and access to undergraduate students to attend the postsecondary institutions that best meet their needs. State Grants provide financial aid to students in conjunction with the Federal Pell Grant.

Family Adjusted Gross Income

Report Highlights:

- In fiscal year 2020, 58% of State Grant recipients had a family adjusted gross income of less than \$40,000.
- Most State Grant recipients attended a public university. In fiscal year 2020, 61% of recipients attended a
 Minnesota State College or University, 15% attended the University of Minnesota, and 23% attended a
 private college.
- In academic year 2018-2019, Minnesota ranked 17th in financial aid spending per full-time equivalent undergraduate among all states and U.S. territories¹.

¹ Full-time equivalent undergraduates are calculated by taking the sum of credits carried by all students at a particular level enrolled in classes, divided by the number of credits in a full-time load (15 credits). An FTE of 1.0 is equivalent to one full-time student.

Introduction

The Minnesota State Grant program is a need-based financial aid program created to assist Minnesota resident undergraduates attending public and private postsecondary institutions in Minnesota. The program was established in 1969; and in fiscal year 2020, approximately 77,544 students were awarded grants, totaling nearly \$208 million. The State Grant program is designed to provide choice and access to undergraduate students to attend the postsecondary institutions that best meet their needs. State Grants provide financial aid to students in conjunction with the Federal Pell Grant.

Since 1983, Minnesota State Grant policy has used the Design for Shared Responsibility model, a framework that was influenced by the work of the Carnegie Commission on Policy Studies in Higher Education. The goal of the program is established in Minnesota Statute 136A.095:

The legislature finds and declares that the identification of men and women of the state who are economically disadvantaged and the encouragement of their educational development in eligible institutions of their choosing are in the best interests of the state and of the students.

This policy statement provides a framework for Minnesota policymakers when considering changes to the State Grant program. The Design for Shared Responsibility model distributes the price of postsecondary education among students, families, and taxpayers, taking into account the student's family income, choice of institution, and enrollment level.

This report contains data on the number and dollar amounts of Minnesota State Grants received by Minnesota undergraduate students for fiscal year 2020 (July 1, 2019 to June 30, 2020). Because Minnesota State Grants are coordinated with Federal Pell Grants, this report includes tables and graphs with combined Federal Pell and State Grant awards received by State Grant recipients, in addition to reporting on State Grant awards. The report also includes information on categories of student characteristics that affect State Grant awards: family adjusted gross income², dependency status/family circumstances, institution choice, and registration credit load. State Grant award recipient demographics such as race/ethnicity and gender are also reported. All tables and charts in this report show the family adjusted gross income of Minnesota State Grant recipients as reported on the Free Application for Federal Student Aid (FAFSA) from the parents' federal income tax return. For dependent students, the parents' adjusted gross income is used; for independent students, the student's (and spouse's, if married) adjusted gross income is used.

Information reported here is based on State Grant data available as of October 15, 2020. The totals may differ slightly from other documents published by the Minnesota Office of Higher Education made before or after this date.

² Adjusted gross income is gross income minus certain deductions, such as health savings account deductions or retirement account contributions. Adjusted gross income is used to calculate federal taxable income.

1. Fiscal Year 2020 Applicants

Students applying for financial aid complete a Free Application for Federal Student Aid (FAFSA) or a State Aid application. The form asks students and their parents to supply information regarding wages, income, assets, and household composition. This information is used in the federal need analysis formula called Federal Methodology, which determines the family's expected contribution toward college costs using the student's and parents' financial resources. The formula calculates an expected Parent Contribution (PC), an expected Student Contribution (SC) and an Expected Family Contribution (EFC). These calculations determine the student's eligibility for federal student aid and, in Minnesota, the student's eligibility for the Minnesota State Grant program.

Family Adjusted Gross Income

For fiscal year 2020 (academic year 2019-2020), 130,070 students completed the FAFSA or State Aid application and met eligibility requirements for a Minnesota State Grant. These totals include students meeting eligibility requirements under the Minnesota Dream Act. Nearly 75 percent of applicants were dependent students. The remaining 25 percent of applicants were independent students. As shown in Figure 1, dependent student applicants are distributed evenly across all family adjusted gross incomes. Independent students display a smaller range of family adjusted gross incomes. Most independent students have family incomes of less than \$35,000.




Figure 2. Student Race and Ethnicity, Fiscal Year 2020, All State Grant Applicants

Just under one-third of State Grant applicants reported as students of color or American Indian students, while 63 percent of applicants reported as white. The remaining 4 percent of students did not report a race or ethnicity (Figure 2).

1.1 Income Profile of Applicants by Dependency Status

Across all types of institutions, independent students had lower median family incomes (\$25,700) than dependent students (\$79,000). Independent students enrolled at the University of Minnesota had the lowest median family income (\$19,400) (Figure 3, Table 1). Dependent students enrolled in private for-profit institutions had lower median family incomes (\$42,300) compared to those enrolled in other sectors (Figure 3, Table 1).





1.2 Enrollment Profile of Applicants by Income




Figure 4. Percent of Minnesota State Grant Applicants Enrolled, by Income and Institution Type, Fiscal Year 2020

As family income increases, the percentage of students enrolled in public two-year institutions or private for-profit institutions declined. In contrast, as income increases, more students enrolled in private non-profit institutions and the University of Minnesota (Figure 4). The University of Minnesota had the highest median family adjusted gross income (\$98,400 among all students) among Minnesota postsecondary sectors (Table 1). Among 2020 applicants from families with incomes below \$20,000, 60 percent enrolled in a Minnesota State College and 13 percent enrolled at a State University (Figure 4).

The State Grant program provides funds to lower- and middle-income students to attend the institution of their choosing. Nonetheless, this comparison highlights existing economic stratification in enrollment among Minnesota students.

1.3 Income Profile of Applicants by Sector

More State Grant applicants from families with incomes below \$20,000 enrolled in private for-profit institutions (33 percent) than any other institution type. Only Minnesota State Colleges had a comparable percentage of lower income students enrolled (29 percent) (Figure 5, Table 2).





Figure 6. Federal Pell and Minnesota State Grant Awards Received, by Family Adjusted Gross Income, Fiscal Year 2020




Family Adjusted Gross Income

During fiscal year 2020, \$208 million in State Grants were awarded to 77,544 students. These totals include students eligible to receive the Minnesota State Grant by meeting eligibility requirements of the Minnesota Dream Act. Minnesota State Grant awards are determined solely by the student's financial need, with the highest-need students and families receiving a greater share of State Grant funding. Of the \$208 million in Minnesota State Grants awarded in fiscal year 2020, roughly half of that total was awarded to students from families earning less than \$40,000 annually (Figure 6). These students represent nearly 60 percent of all State Grant recipients (Figure 7).


Calculations for the Minnesota State Grant take into account the student's Federal Pell Grant award. Figure 8 shows the average combined award for the Federal Pell Grant and the Minnesota State Grant by income.

Students from families earning less than \$10,000 annually received the highest combined average award (\$6,480) (Figure 8).

Figure 9 displays the average combined award for the Federal Pell Grant and the Minnesota State Grant by income and full-time/part-time enrollment status. Full-time enrollment is defined as being enrolled for 30 credits or more for the academic year. As shown in Figure 9, students that attend full time receive higher average State Grants and higher average Federal Pell Grants compared to students that attend part time. This is because full-time students are typically charged a higher tuition rate than students attending less than full time, and the State Grant takes this additional educational cost into account when determining the award. Full-time students from families earning less than \$10,000 received the highest average combined award in 2020 (\$10,050) (Figure 9).

For the 2018-2019 academic year, Minnesota's State Grant program was 17th in the nation for total grant aid awarded, according to the annual survey of National Association of State Student Grant & Aid Programs (Figure 10). The state ranks 12th when only need-based³ grant aid is considered.


The state grant spending per full-time equivalent (FTE) undergraduate⁵ places Minnesota 16th among all other states. Minnesota spends an average of \$1,003 per FTE undergraduate as compared to the top-spending state, Georgia (\$2,368), according to the 2018-2019 annual survey of the National Association of State Student Grant & Aid Programs (Figure 11). When considering need-based aid only, Minnesota spends \$997 per FTE undergraduate (7th in the nation).

³ Need-based grants are those awarded based solely on the student's financial need.

⁴ Non need-based grants are those awarded on measures other than the student's financial need, such as academic merit.

⁵ Full-time equivalent undergraduates are calculated by taking the sum of credits carried by all students at a particular level enrolled in classes, divided by the number of credits in a full-time load (15 credits). An FTE of 1.0 is equivalent to one full-time student.



4. State Grants 1997-2020

The average State Grant that a student receives continues to increase as the state's investment in the program increases.

5. Postsecondary Institution Choice

A student's State Grant award is determined by calculating the total cost of attendance at the institutions chosen by the student. Institutions are grouped into five categories for this report:

- Minnesota State Colleges two-year colleges
- Minnesota State Universities four-year universities
- University of Minnesota System
- Minnesota private non-profit institutions
- Minnesota private for-profit institutions

Tribal colleges operated by entities other than Minnesota State Colleges and Universities are included in the "private non-profit" category for reporting purposes.

The State Grant award calculation uses the average tuition and fees charged to undergraduate students at their institution or the tuition and fee maximums established in state law. Students with lower average tuition and fee charges receive smaller awards. As a result, lower-cost institutions receive a smaller percentage of total State Grant funds (e.g. Minnesota State Colleges). Students with higher-than-average tuition and fee charges receive larger State Grant awards, resulting in higher-cost intuitions receiving a greater percentage of total State Grant funds (e.g. University of Minnesota).

The maximum tuition and fees allowed for two-year programs is significantly lower (\$5,963) than the maximum tuition and fees allowed for four-year programs (\$15,142). Because full-time students will also receive a higher State Grant award, institutions that enroll a higher percentage of full-time students tend to receive a higher percentage of total State Grant funds as compared to institutions that enroll a higher percentage of part-time students.

6. Student Demographics of Recipients






Figure 15. Minnesota State Grant Recipients by Student Race and Ethnicity, All Recipients, Fiscal Year 2020

In 2020, 40 percent of State Grant recipients were students of color or American Indian students (Figure 14). This is roughly 7 percentage points higher than the percent of State Grant applicants that identified as students of color or American Indian students (Figure 2). A full breakdown of recipients of color/indigenous recipients by race and ethnicity is shown in Figure 15.

Figure 14. Minnesota State Grant Recipients by Student Race and Ethnicity, Fiscal Year 2020

Nearly 60% of State Grant recipients self-reported as female in 2020, while roughly 40% of recipients reported as male (Figure 16).

State Grant recipients were, on average, 24 years old in fiscal year 2020, but the average age of State Grant recipients varies by institution type (Table 6). At private for-profit institutions, students over the age of 24 make up two-thirds of all State Grant recipients. By comparison, at the University of Minnesota system, students in these same age brackets represent less than 10% of recipients at the system (Figure 17).

Figure 17. Percent of Minnesota State Grant Recipients by Age Group and Institution Type, Fiscal Year 2020



7. Dependency Status & Family Circumstances

The student and family's ability to pay for the total cost of attendance (tuition and fees, plus a living and miscellaneous expense allowance) is assessed differently for each family category in the State Grant award formula. Family categories are:


- Dependent students (usually students less than 24 years old who were not married and not supporting their own children and were not veterans/military service members)
- Married independent students with dependents (usually children)
- Unmarried independent students with dependents
- Married independent students with no dependents other than a spouse
- Unmarried independent students with no dependents

The profile of students enrolling by institution type varies. The majority of grant recipients enrolling at Minnesota State Universities, the University of Minnesota and private non-profit institutions are dependent students, as shown in Figure 18.

8. Registration Load

The registration load or number of course credits the student enrolls in affects the price of attendance used in calculating Minnesota State Grant awards. The Minnesota State Grant program defines full-time attendance as a registration load of at least 15 credits per term or the equivalent (30 credits per academic year). Average registration load varies by income and family status for State Grant recipients. Dependent students register for more credits annually on average (25.87) than independent students (18.82-21.40), as shown in Table 8.

State Grant recipients from families with an adjusted gross income of \$100,000 or more register for more credits annually on average (28.29) than recipients with lower family incomes (Table 9). This highlights the economic stratification that exists in how many credits students choose to enroll in.





Figure 19. Enrollment Patterns of State Grant Recipients, Fiscal Year 2020

Figures 19 and 20 display the percent of recipients by the number of credits enrolled per term as follows:

- Full-Time, Full-Year: Recipients who registered for 15 or more credits during both fall and spring terms if a semester-based calendar is used; OR registered for 15 or more credits during fall, winter, and spring terms if a quarter-based calendar is used.
- Full-Time, Part-Year: Recipients who registered for 15 or more credits during either fall or spring terms if a semester-based calendar is used; OR registered for 15 or more credits during either fall, winter, or spring terms if a quarter-based calendar is used AND the student registered for fewer than 15 credits for the other terms.
- Part-Time, Full-Year: Recipients who registered for fewer than 15 credits during both fall and spring terms if a semester-based calendar is used; OR registered for fewer than 15 credits during fall, winter, and spring terms if a quarter-based calendar is used.
- Part-Time, Part-Year: Recipients who registered for fewer than 15 credits during either fall or spring terms if a semester-based calendar is used; OR registered for fewer than 15 credits during either fall, winter, or spring terms if a quarter-based calendar is used AND the student did not register for at least one of the other terms.
- Summer only: Recipients who registered at any level for either summer term and did not register
 in fall, winter, or spring terms.

Approximately 30 percent of all State Grant recipients enrolled full-time for both fall and spring semesters (or the equivalent quarter terms, for institutions using a quarter-based academic calendar). An additional 24 percent of recipients registered for 15 or more credits in either fall or spring term. Forty-four percent of recipients enrolled for fewer than 15 credits. An additional 2 percent of recipients enrolled in summer term only (Figure 19).





State Grant awards calculated based on the enrollment level of the student. As a result, students that register for fewer than 15 credits per semester will receive lower State Grant awards than students who enroll full time. Students enrolled full time for both fall and spring semesters receive a greater percentage of total State Grant funds compared to students enrolled for fewer credits annually. The majority of State Grant aid is received by students taking 15 or more credits in both fall and spring semesters (Full-Time, Full-Year) (Figure 20).

8. Minnesota Dream Act

In May 2013, the State Legislature passed, and Governor Dayton signed into law, the Minnesota Dream Act (officially titled in Minnesota law as the Prosperity Act). Under this law, undocumented students meeting the criteria in the Minnesota Dream Act are eligible for in-state tuition rates, privately funded financial aid administered by Minnesota public colleges and universities, and can apply for state financial aid, including the Minnesota State Grant program. Minnesota students granted Deferred Action for Childhood Arrivals (DACA) may also be eligible.

The Minnesota Dream Act provides certain benefits to undocumented students with the following criteria:

- Attended a Minnesota high school for at least 3 years; and
- Graduated from a Minnesota high school or earned a GED in Minnesota; and
- Registered with the U.S. Selective Service (applies only to males 18 to 25 years old); and
- Provided documentation to show they have applied for lawful immigration status, but only if
 a federal process exists for a student to do so (does not include applying for Deferred Action
 for Childhood Arrivals). Currently, no federal process exists; therefore, this documentation is
 not currently required.

During fiscal year 2020, 414 students received State Grants pursuant to the Minnesota Dream Act, as shown in Table 10. Students applying for a Minnesota State Grant by completing a state aid application under the Minnesota Dream Act are included in all reporting on State Grant recipients throughout this report.
