Background

The American Rescue Plan (ARP) was passed by Congress and signed into law by President Biden on March 11, 2021. Minnesota cities, counties, and towns will receive an estimated \$2.132 billion in Local Fiscal Recovery Funds (LFRF) as part of the ARP. This report details distributions made by the State of Minnesota to local governments as of September 8, 2021.

Local Fiscal Recovery Funds include:

- \$1.11 billion in direct federal payments to Minnesota counties.
- \$644 million in direct federal payments to [21 large cities in Minnesota](#): Apple Valley, Blaine, Bloomington, Brooklyn Park, Burnsville, Coon Rapids, Duluth, Eagan, Eden Prairie, Edina, Lakeville, Mankato, Maple Grove, Minneapolis, Minnetonka, Moorhead, Plymouth, Rochester, St. Cloud, St. Paul, and Woodbury.
- \$377 million in payments to remaining [Non-Entitlement Units \(NEUs\)](#) of government, to be disbursed by the State of Minnesota in two payments spaced 12 months apart.

Per guidance from [U.S. Treasury](#), local governments may use ARP funds to:

- Respond to the public health emergency
- Serve the hardest hit communities and addressing inequities
- Address negative economic impacts
- Improve access to water and broadband infrastructure

Distribution Information

- All distribution is based on guidance from U.S. Department of Treasury.
- All NEUs must complete the [Local Government ARP Funding Request Form](#) prior to receiving funds. A complete list of all eligible NEUs and relevant guidance is available from [U.S. Treasury online](#).
- Each local government has been assigned a unique [NEU recipient number](#).
- The Minnesota Department of Revenue is distributing ARP funds to local governments.
- Local governments will receive a direct payment based on a per capita allocation.
- Local governments may not receive more than 75 percent of their total annual budget.
- The COVID-19 Response Accountability Office received and processed request forms from 629 cities and 707 towns as of August 31, 2021.
 - The Department of Revenue disbursed payments to 626 cities and 634 towns as of September 8, 2021. Review Appendix A.
 - Three cities and 73 towns submitted request forms containing data quality issues. Payments to these local governments are on hold pending clarification of submitted information. The COVID-19 Response Accountability Office is contacting these local governments regarding the action required to clear the hold on their payment. Review Appendix B.
