2020 and 2021 Local Road Improvement Program Summary

This document summarizes funding to the local road improvement program (LRIP) from the October, 2020 bonding bill¹ and the June, 2021 omnibus transportation finance and policy bill². In October 2020, \$75 million was provided for the competitive LRIP, with an additional \$110 million appropriated by the legislature to specific projects. In June, 2021, \$5.5 million was provided for the competitive LRIP. An additional \$30,930,000 was provided for trunk highway and local projects. Please contact State Aid for more information on these projects.

A solicitation was released for the competitive LRIP on December 2, 2020. Applications were due on March 3, 2021. 425 applications were submitted with requests for more than \$344 million in LRIP funding. On May 27, 2021, the LRIP Advisory Committee, as identified in Statute 174.52 Subd. 3, convened and approved 75 projects for funding through the competitive LRIP solicitation. The LRIP advisory committee re-convened on July 29, 2021 and selected an additional eight projects for LRIP awards from the \$5.5 million appropriation.

Following is a summary of projects that were either selected for funding through the competitive process or directly by the legislature. Those projects shaded below were selected on July 29, 2021.


