Who is eligible?	A county, city or town must apply for funds and certify to follow state
	requirements (which includes monthly reporting) and federal guidance ^{2, 3}
When to apply?	Accepting applications from June 26 to Sept 15, 2020.
How is aid calculated?	Aid amounts are based on 2018 population of county, city or town
	Timelines for distribution, methodology, and population thresholds for
	allocating these funds to local governments were proposed by the MN Legislature.
	Cities and towns of less than 200 people will not receive a direct distribution;
	instead they may apply to their home county which will receive supplemental funds to reimburse costs for those cities and towns.

¹ For cities and towns, funds unexpended by November 15, 2020 must be sent to its home county or if located in Hennepin or Ramsey, transferred to an eligible hospital by November 20, 2020. For counties and hospitals under this section, funds unexpended by December 1, 2020 must be returned to Minnesota Management and Budget by December 10, 2020.

² Counties with a population of at least 500,000 received CARES Act funds directly from the US Treasury (Hennepin \$220.88 million and Ramsey \$96.03 million) and thus are not included in this distribution to local governments.

³ Among state requirements, a local government must have a "MN SWIFT" identification number in the state accounting system. Similarly, a local government must have a federal Data Universal Number System number for tracking federal funds.
