

Positive Alternatives Grant Program

Responding to identified community needs, the Positive Alternatives (PA) Grant Program funds services and activities that support women to have healthy pregnancies and healthy babies. Grantees provide a range of services and supports, working in collaboration with other community resources. Healthy pregnancy and parenting outcomes are supported through the provision of grant funded activities such as prenatal services, nutritional education, and parenting classes. Grant awards fund support services that reduce the financial pressures a pregnancy may cause such as lack of medical care, food resources and housing. The PA Program also assists women by focusing on long-term solutions to self-sufficiency including assisting with achieving education and employment goals.
