This bulletin provides January reciprocity rates for Title XIX (Medical Assistance / MA) nursing facilities (NFs) by county and by specific age groups for 2016, 2017, 2018, 2019, 2020, 2021 and 2022

The recipient rates are standardized by dividing each region's (county's) count of NF residents who were recipients of Medical Assistance by the U.S. Census Bureau's age-group population estimate for the county for the previous July and then multiplying it by 1,000. NF resident recipients were counted using the payments data in the department's Data Warehouse.

NF residents were counted if MA paid at least one NF claim for January services within six months. Most claims for January are paid in February, but we also looked for late claims for January service processed in the following six months.

This new edition of the reciprocity rates provides tables of utilization for four age cohorts: 0-64 years old, 65-84 years old, 85 years old and up, and for All-Ages.

A summary of statewide recipient rates for 1995, 2000, 2005, 2010, 2015, and 2020 for the age cohorts identified in this report, follows below.
