Patients active in the Registry

It is unclear if patients getting a reprieve from re-enrolling during the pandemic have chosen to continue with the program or will drop out. In the data presented here, patients under these conditions were assigned as Returning Patients. N= 35,993.

Qualifying medical conditions

The top three qualifying medical conditions are intractable pain (54.1%); chronic pain (40.4%); and post-traumatic stress disorder (26.9%).

Active patients by age and gender

The average age of registered patients across all qualifying medical conditions is 47.7. There are 17,834 patients (49.5%) who self-identify as female, 17,850 patients (49.6%) who self-identify as male, and 309 (0.8%) who prefer to not list a gender.

Minnesota licensed physicians, advanced practice registered nurses, and physician assistants can certify a patient's qualifying medical condition. They must be enrolled in the Medical Cannabis Registry before certifying a patient's qualifying condition.
