ALTERNATIVE SOURCES OF ENERGY. Bi-monthly. Alternative Sources of Energy, Inc., Milaca, MN.

ASE is a forum for the discussion of alternative technologies in the areas of energy, agriculture, architecture, transportation and communications. In recent months, feature articles have included discussions of window insulation, solar hot water and underground buildings. Readers are encouraged to contribute and freely exchange information. Recurrent features: book reviews, notes on purchase of equipment, questions and answers. Also includes notices of classes, seminars and conferences.

SUB: POWER RESOURCES

AMERICAN BAR ASSOCIATION JUURNAL. Monthly. American Bar Association.

2 Regular features include editorials, a poll of members of the legal community on various topics, review of legislation affecting attorneys and book reviews. Articles cover a broad range of legal and law related topics - recent examples include "Lawyers, Law and Baseball," "Uniform Condominium Act" and "Can the ERA be Saved?"

AMERICAN EDUCATION. 10 times a year. U. S. Health, Education and Welfare Department. Office of Education.

3 Reflects the federal interest in all levels of education. Typical issues contained articles on student loans, educational television, special education and federal funding of community colleges. Each issue contains "Statistic of the Month," e.g. "Selected Characteristics of Student Aid Recipients, 1976-77."

7 Articles on a variety of architectural, building and design topics. Recent issues contain discussions of a gasohol plant in Minnesota, construction forecasts and approaches to renovation in Minneapolis. Recurrent features: book reviews and society news.

SUB: BUILDINGS ARTS & CRAFTS AS UTHERS SEE US. Monthly. University of Minnesota.

8 Reprinted editorials, reader comments and articles about the University from all Minnesota newspapers.

ASSESSORS JOURNAL. Quarterly. International Association of Assessing Ufficers.

9 Articles directed toward assessing practices and the promotion of justice and equity in the distribution of the tax burden. Most articles deal with property taxation and assessment administration and are technical in nature.

10 A popular general interest magazine.

BANKING. Monthly. Journal of the American Banking Association.

11 Major publication in the banking field containing feature articles on every aspect of finance and banking. Contains announcements and association news. Reports on state and federal legislation and related actions. Calendar.

SUB: FINANCIAL INSTITUTIONS

BENCH AND BAR. Monthly. Minnesota Bar Association.

12 Ufficial publication of the Minnesota Bar Association. Includes feature articles on some aspect of current Minnesota law of legislation. Contains association news and events, Continuing Legal Education course information and summaries of decisions. Topical articles such as state benefits for crime victims, patient costs, or alcohol, death and young drivers are covered in the General Practice Section.

SUB: LEGAL PROFESSION

- BUILDING OFFICIAL AND CODE ADMINISTRATUR: IHE VOICE OF CODE IN ENFORCEMENT. Monthly. Building Officials and Code Administrators International.
- 13 A forum for the expression of views and presentation of information on municipal codes and their administration, construction techniques and standards, etc. A recent report dealt with the relationship of building codes to housing costs and made specific recommendations to HUD regarding code requirements, housing standards, materials and labor costs. Other articles have dealt with energy conservation, wind loads, region wide enforcement. Handling of some material is rather technical. 17 A report on consumer price movements including statistical tables and technical notes. Tables include: Consumer Price Index by expenditure categories and for selected areas. Issues contain explanatory and technical notes on the recent Consumer Price Index revision.

CUED CUMMENTARY. Quarterly. National Council for Urban Economic Development.

18 CUED links public and private efforts in local assistance, communications, pragmatic research and professional interchange in this field. <u>Commentary</u> carries articles on issues which have impact on the economic development of cities, for instance, the environment vs. development controversy, historic preservation, neighborhood revitalization, taxation, etc. Also lists CUED publications.

SUB: ECONOMIC DEVELOPMENT

CURA REPORTER. Quarterly. University of Minnesota. Center for Urban and Regional Aftairs.

19 Provides information about what CURA is doing and what is being done on related projects outside Minnesota. Articles have dealt with "Sharing a City Administrator," "Child Care in High Risk Families," "Lakeshore Zoning Variances" and "Funding Social Services in Minnesota." Recurrent features: New CURA Publications.

SUB: EDUCATION - HIGHER

CHANGE: The Magazine of Learning. Monthly. Council on Learning.

20 Deals with the problems, personalities, programs and plans relating to all aspects of higher education. All articles pertain in some way to post-secondary education, but many have broader appeal. Topics covered recently include Proposition 13, academic tenure, student finance. Recurrent features: editorials, science policy, Washington and book reviews.

CHRONICLE OF HIGHER EDUCATION. Weekly. Chronicle of Higher Education, Inc.

21 Concerned with every aspect of higher education, this publication contains excellent statistical material and much on state problems and policies, legislation and rules affecting higher education. Recent features have included "Un Campus, the Biggest Drug is Alcohol," "Comparative Statistics," "The Wealth and Taxes in 50 States" and "Increased State Support for Higher Education."
