Major publication in the banking field containing feature articles on every aspect of finance and banking. Contains announcements and association news. Report on state and federal legislation and related actions. Calendar.

For Refuge," "Hispanics In Engineering - A Status Report," and "The Literature of Mexico." Regularly contains articles on the arts, business, and a calendar of events. Articles are presented in Spanish as well as in English.

In recent months, feature articles have included discussions of window insulation, solar hot water, and underground buildings. Readers are encouraged to contribute and freely exchange information. Recurrent features: book reviews, notes on purchase of equipment, questions and answers. Also includes notices of classes, seminars, and conferences.

The magazine often contains a section in which Congressmen present pros and cons of issues such as "Should The District Of Columbia Have Full Representation," or "Should The Federal Government Make Retribution To Crime Victims." Topical articles such as state benefits for crime victims, patient costs, or alcohol, death and young drivers are covered in the General Practice Section.

This publication is an interim supplement to Bench & Bar.

21. BROOKINGS PAPERS ON ECONOMIC ACTIVITY. Brookings Institution. Irregular.

Publications of papers, reports and discussions from Brookings conferences concentrating on live issues of economic performance that confront the maker of public policy." Some articles highly technical. Recent topics include The Gold Standard, policy analysis with econometric models, union contract concessions.

Presentation in non-technical. Articles in Volume 1, number 1 include "The Value Added Tax: Some Lessons and Issues," "Tough Time for Pension Plans." Authors: institute scholars and other authorities.

23. BUILDING OFFICIAL AND CODE ADMINISTRATOR: THE VOICE OF CODE IN ENFORCEMENT. Building Officials and Code Administrators International. Monthly.

A forum for the expression of views and presentation of information on building codes and their administration, construction techniques, and standards, etc. A recent report dealt with the relationship of building codes to housing costs and made specific recommendations to HUD regarding code requirements, housing standards, wind loads, region-wide enforcement. Handling of some material is rather technical. Information on federal and state legislation and regulations as well as association news.

27. CUED COMMENTARY. National Council for Urban Economic Development. Quarterly.

CUED links public and private efforts in local assistance, communications, pragmatic research and professional interchange in this field. Commentary carries articles on issues which have impact on the economic development of cities, for instance, the environment vs. development controversy; historic preservation, neighborhood revitalization, taxation, etc. Also lists CUED publications.

28. CALIFORNIA JOURNAL. California Center for Research and Education in Government. Monthly.

The major journal of California politics and public policy describes itself as "a non-partisan, non-ideological analysis of California government and politics established in 1970 and published monthly by the California Center for Research and Education in Government." Recent articles: "Transportation 1990," "Policing The Police," and "The Changing Face Of Farming." Regular features include "Perspective From Washington," "Newsmakers," "Signed" (a summary of recently enacted legislation), and editorials. Indexed quarterly with annual cumulations.

29. CHANGE: The Magazine of Learning. Council on Learning. Monthly.

Deals with the problems, personalities, programs, and plans relating to all aspects of higher education. All articles pertain in some way to post-secondary education, but many have broader appeal. Topics covered recently include Proposition 13, academic tenure, student finance. Recurrent features: editorials, science policy, Washington, and book reviews.

30. CHRONICLE OF HIGHER EDUCATION. Chronicle of Higher Education, Inc. Weekly.

Concerned with every aspect of higher education, this publication contains excellent statistical material and much on state problems and policies, legislation, and rules affecting higher education. Recent features have included "On Campus, The Biggest Drug Is Alcohol," "Comparative Statistics," "The Wealth And Taxes In 50 States," and "Increased State Support For Higher Education."

An independent, interfaith journal intended to provide "coverage and analysis of developments, legislation, litigation trends, and books affecting our most basic liberty." Editorial policy defending and advancing liberty and church-state separation. Contains material not available elsewhere.

Each issue contains only a few short articles. Recent titles have included: "Iowa Business Trends," "Inflation Still The Greatest Threat To The Free Enterprise System," and "It Ain't Actuarially So." Recurrent features: "Bank Notes," "ADA News," "Insurance News," "Bonds And Municipal Finance."

33. COMMON CAUSE. Common Cause. Bi-monthly.

A publication of the well-known "citizen lobby organization" contains articles and information on federal, state, and local political issues, and government policies and practices. Attention is also given to select legislation and regulatory practices. Regular features include: "Feedback," "Viewpoint," selected Senate and House votes, "In The States," and "Tracking Common Cause Issues." Continues Frontline and In Common.

34. COMMONSENSE: A Republican Journal of Thought and Opinion. Republican National Committee. Quarterly.

This journal was first published in summer 1978. Articles in the initial volume include Bob Packwood on tuition tax credits, James Buckley on federalism, Laurence Silberman on sunset laws and Michael Novak on the Republican party and "ordinary people." Book reviews.

Contributors are Congressmen and representatives of groups affected by the controversies.

36. CONGRESSIONAL QUARTERLY WEEKLY REPORT. Congressional Quarterly, Inc. Weekly.

Well-known comprehensive and dependable periodical. Examines issues before Congress as well as providing election analysis and political coverage. Recent topics have included discussion of the reorganization plan, health care costs, urban economic developments, arms control, voting studies, conservative coalition's strength and an entire issue presented profiles on new members. Excellent statistics and tables. Recurrent features: roll call votes. Often includes material on executive programs and personalities.

Recent issues included: "An Update On Waterfowl Management In NYS," "Deer: Farmer's Friend Or Foe?," and "Land Access For Hunting." Recurrent features: column answering readers' inquiries, book reviews and an earth almanac.

Regular features: "Letters," "News Briefs," "Upcoming Events," and "Resource Guide."
