The Legislative Reference Library (LRL) subscribes to over five hundred magazines, newsletters and newspapers. For your convenience, we have compiled a selected listing of the periodicals we receive. This listing is arranged in three sections: selected magazines received by the Library, selected newsletters received by the Library and newspapers (Minnesota and Non-Minnesota) which we receive. While it is useful to use this listing as a reference in locating journals, newsletters or newspapers, as a service to Legislators and legislative staff, LRL offers a contents service.

Enclosed with this publication, you will find a request form for the contents service. On the form, list the numbers of the magazines and/or newsletters in which you are interested, return the form to the Library, and we will send you a copy of the contents page of the periodical when it arrives at LRL. (For those publications without contents pages, we will copy the first page to alert you to the item's arrival.) This is an excellent way to keep up to date and to be alerted to articles of interest to you.

Please note: If you have participated in this service in the past, make sure you notify us if you want to continue or of any changes.

1. ABA BANKING JOURNAL. Journal of the American Banking Association. Monthly.

Major publication in the banking field containing feature articles on every aspect of finance and banking. Contains announcements and association news. Report on state and federal legislation and related actions. Calendar.

2. AEI ECONOMIST. The American Enterprise Institute. Monthly.

"The AEI Economist is a monthly report intended to clarify current issues of economic policy in an objective manner." Usually contains one article per issue; recent topics include the federal deficit, the Reagan record and a profile of the career of Friedrich Hayek.

3. ABSTRACTS AND REVIEWS IN ALCOHOL AND DRIVING. UCLA Alcohol Research Center. Quarterly.

One article and a dozen reviews covering law enforcement, education, prevention, psychological, sociological, medical and statistical studies.

4. ACROSS THE BOARD. The Conference Board. Monthly.

Contains multi-disciplinary articles with business orientation. Recent issues have been on high tech, taxation, trade, pollution, and pay equity. Recurrent features: book reviews, comments and letters.

5. ADMINISTRATIVE MANAGEMENT. Automated Office, LTD. Monthly

Subtitled "The Magazine of Office Administration and Automation," it contains articles on the introduction and management of new office technology (computer hardware, software, network systems, and peripherals).

6. **AGRICULTURAL OUTLOOK.** U.S. Department of Agriculture. Economic Research Service. Monthly.

Deals with national and international agricultural topics, including farm income, world agriculture and trade, marketing and transportation. Text, tables and graphs. Recurrent features "Statistical Indicators" and recent publications. Occasional special reports.

7. **ALTERNATIVE SOURCES OF ENERGY.** Alternative Sources of Energy, Inc. Milaca, MN. 10/year.

ASE is a forum for the discussion of alternative technologies in the areas of energy, agriculture, architecture, transportation and communications. In recent months, feature articles have included discussions of window insulation, solar hot water, underground buildings, hydropower and windpower.

8. **AMERICAN BAR ASSOCIATION JOURNAL.** American Bar Association. Monthly.

Regular features include editorials, a poll of members of the legal community on various topics, review of legislation affecting attorneys and book reviews. Articles cover a broad range of legal and law related topics.

9. **AMERICAN DEMOGRAPHICS.** American Demographics, Inc. Monthly.

Most articles describe the potential effects of demographic changes on problems, programs and policies; others deal with statistical measurement and methodology. Topics covered recently include the growing power of women, Hispanics and blacks, the changing composition of urban population, apportionment, voters' characteristics and characteristics of crime victims. Regular departments: essays, books and an index.

10. **AMERICAN FORESTS.** American Forestry Association. Monthly.

Contains approximately ten feature articles, an editorial, federal legislative update and bibliography for further reading. Articles cover all areas of forestry and forestry management. Association describes itself as working for "the advancement of intelligent management and use of our forests, soil, water, wildlife, and all other natural resources..."

11. AMERICAN JOURNAL OF PUBLIC HEALTH. American Public Health Association. Monthly.

Issues contain editorials and articles on topics such as extending life expectancy, child care, venereal disease, vital statistics and health care consumers. Recurrent feature: book reviews.

12. AMERICAN LAND FORUM MAGAZINE. American Land Resource Association. Quarterly.

Essays, commentaries, forum proceedings on rural issues, natural resources and land conservation and use. Book review, index.

13. AMERICAN LEGION MAGAZINE. American Legion. Monthly.

Many articles on military history, issues and personalities. Emphasis on problems particular to veterans as well as program and policy statements of the Legion and summaries of news items of concern to members.

14. AMICUS JOURNAL. Natural Resources Defense Counsel. Quarterly.

"A journal of thought and opinions on environmental affairs, particularly those relating to public policies of national and international significance." Good in the areas of nuclear safety, toxic substances, air and water pollution, urban transportation and conservation.

15. ARBITRATION JOURNAL. American Arbitration Association. Quarterly.

Material designed to promote "the resolution of disputes of all kinds through the use of arbitration, mediation, democratic elections and other voluntary methods." Regular features: Library Acquisitions, Review of Court Decisions, Book Review, and Editorial Comment.

16. ARBITRATION TIMES. American Arbitration Association. Quarterly.

This 8-10 page newspaper contains short news stories profiling national and international arbitration issues. Nearly all are directly about the American Arbitration Association.

17. ARCHITECTURE MINNESOTA. Minnesota Society of the American Institute of Architects. 6/year.

Articles on a variety of architectural, building and design topics. Recurrent features: book reviews, Society news and annual Architectural Directory for Minnesota.

18. THE ATLANTIC. Atlantic Monthly Company. Monthly.

A popular general interest magazine.

19. BARRON'S: NATIONAL BUSINESS & FINANCIAL WEEKLY. Dow Jones and Company, Inc. Weekly.

Most articles deal with financial and investment matters or personalities. Major articles have concerned EPA and lead, bankruptcy, American Association of Retired Persons and gold.

20. BENCH AND BAR. Minnesota State Bar Association. Monthly.

Official publication of the Minnesota Bar Association. Includes feature articles of current Minnesota law, legislation, legal personnel or personalities of interest to the legal community. Contains Association news and events, continuing legal education course information and summaries of decisions.

21. BEST'S REVIEW - PROPERTY/CASUALTY INSURANCE EDITION. A.M. Best Company. Monthly.

Aimed at the insurance industry, this periodical offers an insider's view of such topics as tort reform and the liability insurance crisis, the marketing of insurance to professionals, the effects of tax reform on the insurance industry, and insurance regulation.

22. BETTER ROADS: THE NEWS MAGAZINE FOR GOVERNMENT ROAD & STREET OFFICIALS, ENGINEERS & CONTRACTORS. William O. Dannhausen, editor. Monthly.

Articles on all aspects of road construction, maintenance, funding, legislation and regulation.

23. \*BROOKINGS PAPERS ON ECONOMIC ACTIVITY. Brookings Institution.  
2/year.

Publications of papers, reports and discussions from Brookings conferences concentrating on issues of economic performance that confront the makers of public policy. Some articles are highly technical. Recent topics include the gold standard, policy analysis with econometric models, union contract concessions, productivity and interest rates.

24. BROOKINGS REVIEW. Brookings Institution. Quarterly.

Purpose is to increase understanding between public and private sectors. Covers economics, governmental and foreign policy areas. Presentation is non-technical. Articles on banking, pensions, taxation, government finance, regulation, trade etc. Authors are institute scholars and other authorities.

25. BUILDING OFFICIAL AND CODE ADMINISTRATOR: THE VOICE OF CODE IN ENFORCEMENT. Building Officials and Code Administrators International. 6/year.

A forum for the expression of views and presentation of information on building codes and their administration, construction techniques and standards. Information on federal and state legislation and regulations as well as association news.

26. BULLETIN. National Association of Regulatory Utility Commissioners.  
Weekly.

Weekly publication of NARUC which includes news items of interest primarily to those involved with utility regulation.

27. BULLETIN OF THE ATOMIC SCIENTISTS: A Magazine of Science and Public Affairs. Education Foundation for Nuclear Science. Monthly.

Primary concern is the maintenance of international peace and attainment of nuclear non-proliferation. Articles also deal with energy, genetics, climate, disease, and nutrition

28. BUREAU OF JUSTICE STATISTICS BULLETIN. U.S. Department of Justice. Monthly.

The BJS BULLETIN is a monthly report summarizing the most current criminal justice data. One topic is presented in each issue. Recent topics have included bank robbery, probation and parole.

29. BUSINESS AND ECONOMIC REVIEW. Division of Research - College of Business Administration. University of South Carolina. Quarterly.

A research journal discussing current business and economic topics, such as economic development, foreign trade zones, the art of negotiation, and attracting high-tech firms. Only a few articles are aimed solely at the Southeast Region.

30. BUSINESS CONDITIONS DIGEST. U.S. Department of Commerce. Bureau of Economic Analysis. Monthly.

"BUSINESS CONDITIONS DIGEST provides a monthly look at many of the economic time series found most useful by business analysts and forecasters." Contents doesn't vary.

31. BUSINESS INSURANCE. Crain Communications. Weekly.

Weekly publication which focuses on all aspects of business insurance. Includes, but is not limited to, coverage of liability, health insurance, employee benefits, risk management.

BUSINESS VIEWS see MINNESOTA BUSINESS VIEWS.

32. BUSINESS WEEK. McGraw-Hill. Weekly.

A popular general interest magazine dealing with issues and matters of concern from a business perspective.

33. BYTE. McGraw-Hill. Monthly.

Articles and reviews cover computers, computer peripherals, software, and programming languages.

34. CBE ENVIRONMENTAL REVIEW. Citizens for a Better Environment. 6/year.  
Deals exclusively with environmental and public health topics in the member states of Illinois, Indiana, Minnesota, Wisconsin and California; also covers federal concerns, legislation and regulation.
35. CFS NOTEBOOK. (Conference for Federal Studies.) Center for the Study of Federalism. Temple University. Quarterly.  
A newsletter aimed at "taking a central role in fostering communication among those interested in the study of federalism and intergovernmental relations and in their manifestations as well, both academically and practically."
36. CUED COMMENTARY. National Council for Urban Economic Development. Quarterly.  
CUED links public and private efforts in local assistance, communications, pragmatic research and professional interchange in economic development.
37. CURA REPORTER. University of Minnesota. Center for Urban and Regional Affairs. Quarterly.  
The CURA REPORTER is published "to provide information about what CURA projects are doing, related programs and projects in the University of Minnesota... and other Minnesota colleges and universities, and actions outside the educational establishment which affect" CURA. Articles included on both urban and rural affairs.
38. CALIFORNIA JOURNAL. California Center for Research and Education in Government. Monthly.  
The major journal of California politics and public policy describes itself as "a non-partisan, non-ideological analysis of California government and politics." Frequent articles on legislative organization, staffing leadership and policy issues.

39. CAL-TAX RESEARCH BULLETIN. California Taxpayer's Association.  
Irregular.

CAL-TAX RESEARCH BULLETIN presents research findings on issues which fulfill Cal-Tax's goal "to advance economy and efficiency in government." Recent topics covered have included local taxes and negotiating public employee retirement.

40. CAMPAIGNS & ELECTIONS. Campaigns & Elections, Inc. 6/year.

The fast-changing, high-tech world of politics is reflected in article titles such as "Creating Candidate Imagery: An Audio-Visual Analysis," "Ballots and Bytes: Computerizing the Campaign," and "Train Tour Traumas: The Anatomy of a Successful Media Event." Articles and essays on the less technological, and more regulatory or ethical aspects of campaigning are included as well.

41. CATO JOURNAL: AN INTERDISCIPLINARY JOURNAL OF PUBLIC POLICY ANALYSIS.  
Cato Institute. 3/year.

Articles on issues of concern to those involved in public policy decision making. Issues often deal with one topic only such as social security or monetary policy.

42. CATO POLICY REPORT. Cato Institute. 6/year.

"Provides in depth evaluations of public policies and discusses appropriate solutions to current economic problems." Tariffs, debt, industrial policy and military spending have been discussed in recent issues.

43. CENTER MAGAZINE. Center for Democratic Institutions. 6/year.

The Center Magazine provides interdisciplinary examinations of local, state, national and international issues with the intention of improving the democratic process. Recent issues have contained articles on the "Failure of State Legislative Reform," and "Moral Experts in Courts."

44. CHALLENGE: THE MAGAZINE OF ECONOMIC AFFAIRS. M.E. Sharp, Inc.  
6/year.

Each issue contains lengthy articles by well-known economists on varied topics relating to economics including markets for pollution control, deficit financing, deregulation, federal aid cuts and the budget process. Each issue also includes a section of brief comments on topics such as incomes policy, job search and protectionism. Book reviews and further readings are regular features.

45. CHANGE: THE MAGAZINE OF LEARNING. Helen Dwight Reid Educational Foundation. Monthly.

Deals with the problems, personalities, programs and plans relating to all aspects of higher education. Topics covered recently include curriculum, academic tenure, student finance and educational quality. Recurrent features: editorials, science policy, Washington and book reviews.

46. CHANGING WORK. Program in Social Economy and Social Justice, Dept. of Sociology. Boston College. Quarterly.

The labor oriented magazine addresses concerns about "the psychological and social effects of worklife," and aims to be "useful as a tool for those actively involved in changing worklife." (Co-editor's note.) As examples, two articles in the Spring, 1986, issue covered worker owned firms and unions promoting community development.

47. CHILDREN TODAY. U.S. Dept. of Health and Human Services. Office of Human Development Services. 6/year.

Deals with issues pertaining to health, welfare education, and the future of America's young people. Asian family values, planning with scarce resources, abandonment, latchkey and child bearing among the very young are a few of the topics covered recently.

48. CHRONICLE OF HIGHER EDUCATION. Chronicle of Higher Education, Inc. Weekly.

Concerned with every aspect of higher education, this publication contains excellent statistical material and much on state problems and policies, legislation and rules affecting higher education. Recent features have included "On Campus, The Biggest Drug Is Alcohol," "The Wealth and Taxes in 50 States" and "Increased State Support for Higher Education."

49. CHURCH AND STATE. Americans United for Separation of Church and State. 11/year.

An independent, interfaith journal intended to provide "coverage and analysis of developments, legislation, litigation trends and books affecting our most basic liberty." Editorial policy defending and advancing liberty and church-state separation. Contains material not available elsewhere.

50. CITY AND STATE. Crain Communications. Monthly.

Includes short news articles and occasional longer special features covering business and finance news at the state and local level around the country.

51. CITY BUSINESS: SAINT PAUL. City Business/Twin Cities, Inc. 6/month.

This newspaper has been published since 1983 and covers a variety of issues. Among these are farming, health care and business climate. Also includes articles on Twin City's business people and firms.

52. CLEARINGHOUSE REVIEW. National Clearinghouse for Legal Services, Inc. Monthly.

The articles and case law summaries are primarily aimed at legal services practitioners, but the articles dealing with disadvantaged populations are relevant to a wider audience. Examples of titles: "Improvement in Foster Care and Adoption Assistance Programs," "Representing Low-Income Parents Who Are Seeking a Divorce: Considering the Public Benefits Implications."

53. COLUMBIA JOURNALISM REVIEW. Graduate School of Journalism, Columbia University. 6/year.

Provides critical analysis of print and broadcast news media. Its purpose is to "assess the performance of journalism" and "to help define or redefine - standards of honest, responsible service."

54. COMMERCIAL WEST: The Magazine of Banking and Business. Financial Communications, Inc. Weekly.

Each issue contains only a few short articles. Topics addressed include philosophical and practical aspects of banking and finance, taxation, economic development, regulation, etc. Recurrent features: "Bank Notes," "ADA News," "Insurance News," "Bonds and Municipal Finance."

55. COMMON CAUSE. Common Cause. 6/year.

A publication of the well-known citizen lobby organization contains articles and information on federal, state and local political issues and government policies and practices. Attention is also given to select legislation and regulatory practices.

56. COMPARATIVE STATE POLITICS NEWSLETTER. University of Kentucky. Department of Political Science. 6/year.

Reports on all aspects of political, government and legislative activities in the states. Summarizes research reports and articles.

57. CONGRESSIONAL DIGEST. Congressional Digest Corp. Monthly.

An independent monthly featuring pro and con viewpoints on matters before Congress. Recent issues covered welfare reform, the beverage container problem, and national health insurance. Contributors are Congressmen and representatives of groups affected by the controversies.

58. CONGRESSIONAL QUARTERLY WEEKLY REPORT. Congressional Quarterly, Inc. Weekly.

Well-known comprehensive and dependable periodical. Examines issues before Congress as well as providing election analysis and political coverage. Excellent statistics and tables. Recurrent feature: roll call votes. Often includes material on executive programs and personalities.

59. CONGRESSIONAL RESEARCH SERVICE REVIEW. Library of Congress. Congressional Research Service. 10/year.

"The CRS REVIEW is a professional journal for the United States Congress and its legislative staff." This journal covers a wide variety of topics including hunger in developing countries, defensive medicine, asbestos in schools, child support, defense spending and utility bankruptcy. Authors are subject specialists on the staff of the CRS.

60. CONSERVATIONIST. New York State Department of Environmental Conservation. 6/year.

This periodical is designed to inform the general public on various topics of environmental concern. Contains short articles, many photographs and drawings of wildlife. Fish, wetlands, waterfowl, wildlife, lakes and lake quality are topics likely to be discussed in this journal.

61. CONSERVATIVE DIGEST. Conservative Digest, Inc. 11/year.

Articles present Conservative opinions and profile prominent Conservative personalities in a readable, READER'S DIGEST format.

62. CONSUMER REPORTS. Consumers Union. Monthly.

The well-known periodical which tells you how good the tuna is or which battery booster cables to purchase, also addresses consumer issues, including mortgage rates, mail fraud, insurance costs, the medical profession, unnecessary surgery and drug use and abuse.

63. CONSUMERS UNION NEWS DIGEST. Consumers Union of United States, Inc.  
24/year.

Short synopses of articles on consumer topics culled from a range of publications. It is published in a newsletter format and the pieces are arranged under a number of general subject headings such as "health & medicine," "government," and "energy."

64. CORPORATE REPORT: MINNESOTA. Dorn Communications, Inc. Monthly.

Each issue contains articles featuring individuals, industries, issues and events of interest to members of the Midwest business community.

65. COUNCIL ON ECONOMIC PRIORITIES NEWSLETTER. Council on Economic Priorities. Monthly.

"The CEP is a non-profit organization established to disseminate unbiased and detailed information on the practices of U.S. corporations...CEP was established so that the American public could work to insure corporate social responsibility." Each issue covers a single topic (e.g. high frontier defense, political action committees, toxic wastes and cancer).

66. COUNTY NEWS. National Association of Counties Research Foundation.  
26/year.

This newspaper primarily covers the actions of the federal government and the resulting effects on counties. Revenue sharing is an important ongoing topic.

67. CRIMINAL JUSTICE NEWSLETTER. Pace Publications. 24/year.

"An independent report on significant developments in criminal justice policy and administration." (Title subheading.) Short, one-page, articles profile national legislative, judicial, and administrative news in the area of criminal justice. Releases of important studies in the field are also reported.

68. DOT SCENE. Minnesota Department of Transportation. 9-10/year.

Published as "an official medium of information to correlate the work of [the Department's] employees through the state and to stimulate dedicated and efficient public service in all transportation activities."

69. DATA RESOURCES REVIEW OF THE U.S. ECONOMY. Data Resources, Inc. Quarterly.

DATA RESOURCES REVIEW OF THE U.S. ECONOMY contains monthly economic forecasts on several major economic indicators. Data are included on sixteen key factors such as consumer spending, housing, fixed investment, inventories, government, imports/exports, energy and mortgage finance. In addition, DRI methods are described and a forecast summary is included.

70. DATA USER NEWS. U.S. Department of Commerce. Bureau of the Census. Monthly.

A newsletter for users of Census Bureau statistics. Includes and describes new services and data files, highlights, changes and explanations of census data. Lists selected new publications by the Census Bureau.

71. DATA-LOG: ECONOMIC REPORT. Metropolitan Council. Irregular.

Coverage of development and employment topics for the seven-county metropolitan area. Recent report titles include: "Employment in the Twin Cities Metropolitan Area 1980-1983," "1985 Industrial Construction Activity and Major Construction Projects in the Twin Cities Metropolitan Area, July-December 1985."

72. DATA-LOG: HEALTH STATUS REPORT. Metropolitan Council. Irregular.

Profiles health and hospital planning in the seven-county metropolitan area. The reports can be a useful source for descriptions and statistics covering metro area hospital programs.

73. DATA-LOG: SOCIAL AND DEMOGRAPHIC REPORT. Metropolitan Council.  
Irregular.

Statistical reports covering population trends, housing construction, and housing vacancy and turnover in the seven-county metropolitan area.

74. DATA-LOG: VITAL STATISTICS REPORT. Metropolitan Council. Irregular.

Reports of birth, acute health care, and death statistics and trends in the seven-county metropolitan area for use in health planning. Data are provided with little interpretation.

75. DISCOVER. The News Magazine of Science. Time, Inc. Monthly.

A periodical designed to acquaint the educated layman with developments and trends in the sciences. Topics treated recently include: genetics, hazardous wastes, mental illness, "creationism" and aging.

76. DOLLARS AND SENSE. Economic Affairs Bureau. 10/year.

"Edited and produced by a collective of economists and journalists...(to) offer interpretations of current economic events from a socialist perspective and to be of use to people working for progressive change."

77. DULUTHIAN. Duluth Area Chamber of Commerce. 6/year.

Feature articles deal with state and local issues, policies, programs and personalities.

78. EPA JOURNAL. U.S. Environmental Protection Agency. 10/year.

Focuses on "air and water quality, solid waste management and the control of toxic substances, pesticides, noise and radiation." Articles may deal with specific issues from a scientific, ecological, legal, or judicial perspective.

79. ECONOMIC INDICATORS. U.S. Congress Joint Economic Committee. Monthly.

Each issue consists of a series of statistical charts and tables covering GNP, employment, unemployment, wages, production and business activity, prices, international statistics, interest rates, government finance and more.

80. ECONOMIST. Economist Newspaper Ltd. (London). Weekly.

British newsweekly with excellent coverage of international news and economics. "American Survey" gives world view of U.S. events and has occasionally reported on Minnesota politics.

81. EDITORIAL RESEARCH REPORTS. Congressional Quarterly, Inc. Weekly.

A very worthwhile and useful publication directed particularly at policymakers and others in the public eye. Entire issue treats a single topic of current interest. Reports provide historical perspective, current situation, and likely future developments. When appropriate, arguments for and against are included. Presentation is brief but thorough. May be national or international in scope and treats a very wide range of issues including science, politics, elections, education, economics and trade, employment and job training, transportation, human services, resource management, civil rights etc. Further readings are recommended.

82. EDUCATIONAL EXCELLENCE NETWORK. Vanderbilt Institute for Public Policy Studies. 8/year.

Brings together reprints or articles from a variety of journals on a wide range of elementary and secondary level education issues.

83. EMPLOYMENT AND EARNINGS. U.S. Department of Labor. Bureau of Labor Statistics. Monthly.

A technical but major economic statistical source. Regularly includes employment and earnings data by household, employment status, sex and age, SIC group, state and selected SMSA. Each issue contains a special feature on topics like annual averages, state averages, employment of women and seasonal adjustments.

84. ENCOUNTERS. Science Museum of Minnesota. 6/year.

Contains six to ten short feature articles on scientific topics ranging from biology to aerodynamics. Columns on science for children, continuing education classes, astronomical events and many other topics. Includes a calendar of events. Written for a general non-scientific audience.

85. ENERGY USERS NEWS. Fairchild Publications. Weekly.

A trade publication which does not really contain a table of contents, but the weekly news summary provides a form of index. Areas covered include conservation, management, power resources, pricing, fuels, technology, innovations, laws, legislation and regulation. Regular features: state and federal legislative and regulatory source boards, pricing data by region, city and type of fuel.

86. ENGINEERING NEWS-RECORD. McGraw-Hill. Weekly.

Recurring features: news items, management and labor, letters, materials prices (includes Minneapolis), unit prices, editorials, construction score board (which includes statistical data on costs, volume, and capital), ENR index comparing current costs with 1913 & 1967, data on construction costs, building costs and wage rates. Feature articles often deal with legislative, legal or regulatory aspects of engineering and construction operations and projects. Much material on transportation systems, utilities and energy.

87. ENTREPRENEURIAL ECONOMY. The Corporation for Enterprise Development. Monthly.

Purpose is to provide exchange of information to assist private corporations, state and local government, and community based organizations to devise and implement enterprise development strategies to create jobs, generate income, provide goods and services and revitalize depressed economies.

88. ENVIRONMENT. Helen Dwight Reed Educational Foundation and Scientist's Institute for Public Information. Monthly.

An important publication containing timely non-technical articles. Recent issues have included articles on vanishing cropland, energy from alcohol, the hazards of high voltage lines.

89. ENVIRONMENTAL ACTION. Environmental Action, Inc. 6/year.

A national lobbying organization publication containing articles on environmental energy, pollution, conservation, waste management and related topics.

90. ENVIRONMENTAL SCIENCE & TECHNOLOGY. American Chemical Association. Monthly.

This highly technical scientific publication contains feature articles with an environmental focus. Recurrent features: investigators' reports and summaries of court actions.

91. FBI LAW ENFORCEMENT BULLETIN. U.S. Federal Bureau of Investigation. Monthly.

Most articles fall into the following broad subject areas: crime problems, forensic science, investigative techniques, law enforcement, management, technology, traffic and training. Recurrent feature: "Legal Digest."

92. FDA CONSUMER. U.S. Department of Health and Human Services. Food and Drug Administration. Monthly.

The official magazine of the Food and Drug Administration deals with the wide range of topic areas of concern to this office. Recent issues consider pesticide residue, ulcers, food labelling, irradiation, headaches, anesthesia and drug ads. Recurrent features: investigators' reports and summaries of court actions.

93. FAMILY ADVOCATE. American Bar Association. Section of Family Law. Quarterly.

Articles on the practical aspects of trying family law cases. Article titles include: "Direct Examination of a Wife on Her Child's Standard of Living," "Grooming Your Expert, Sculpting Your Case," and "How to Cross-Examine a Real Estate Appraiser."

94. FAMILY ECONOMICS REVIEW. U.S. Department of Agriculture. Science and Education Administration. Agricultural Research, Northeastern Region. Quarterly.

Reports on research, information and publications relating to the economic aspects of family living. Articles include many unique and valuable statistics, e.g. a series of family budgets for different income levels and ages, and a continuing series on the cost of raising a child in the different regions of the United States. Other areas of interest include housing and housing finance; food, diet and associated costs; consumer issues and various human services.

95. FAMILY PLANNING PERSPECTIVES. Alan Guttmacher Institute. 6/year.

Contains news items, articles, special reports, digested reports and book reviews on all topics related to pregnancy, family planning, abortion, sex education, etc.

Business news magazine geared to those involved in all aspects of agriculture. Contains short news items and articles covering national legislation and regulations, current events relevant to farms and new products, chemicals and machinery used in farming. Recurrent features: sections on new developments, Washington events and editorial comment.

97. THE FARMER. Serving Upper Midwest Farm Families. The Webb Company. 2/month.

Carries topics which may be of interest to farmers, their families, and those in agri-business. Recent issues have contained articles on planting and marketing strategies, farm taxes, gasohol. Regular features: agri-industry news, weather, Washington news, market briefs and more.

98. FARMLINE. U.S. Department of Agriculture. Economics, Statistics and Cooperatives Service. 11/year.

A good agricultural periodical with feature articles on marketing, new products, irrigation and other technology, exports, farm prices and farm safety. Very good statistical information in every issue.

100. FEDERAL RESERVE BANK OF BOSTON. NEW ENGLAND ECONOMIC REVIEW. 6/year.

- Includes material related to all aspects and types of insurance: legislative, legal, judicial, compensation, claims, damages, records, medical, life, fire, and products liability.
115. FIRST MONDAY. Republican National Committee. 6/year.
- Contains feature articles and news on topics in the national interest from the Republican perspective. Each issue contains "newsmaker interview" with a prominent Republican.
116. FISCAL LETTER. National Conference of State Legislatures. 6/year.
- Reports on government finance issues in the states including budget amounts, tax policies, tax collection appropriations and expenditures, and impact of federal budget policy on the states. Many state by state tables.
117. FOCUS ON GREAT LAKES WATER QUALITY. International Joint Commission. Quarterly.
- The IJC was created to settle disputes involving the boundary waters of the Great Lakes Region. FOCUS contains articles on environmental issues, legal affairs, Great Lakes shipping.

121. THE FUTURIST: A JOURNAL OF FORECASTS, TRENDS AND IDEAS ABOUT THE FUTURE. World Future Association. 6/year.

Concerns include economics, government, education, communication technology, and life styles. Recent articles have included "Does Money Have A Future?," "Licensing Parents," "Electronic Meetings" and "The Future Of The Drug Scene."

122. GALLUP REPORT. Gallup Poll. Monthly.

128. HAMLINE JOURNAL OF PUBLIC LAW. Public Law Research Center. Hamline University School of Law. Irregular.

"The Center is a research and drafting organization designed to promote greater involvement in the law making process by providing law research and writing services to local government, civic groups and individuals presenting significant public law issues for legislative consideration." The contents of this journal reflect its concern with legislation and law making with emphasis on Minnesota.

129. HAMLINE LAW REVIEW. Hamline University School of Law. 2/year.

Law review published by the Hamline University School of Law. This publication consists of articles, notes, comments and book reviews. The spring issue includes a symposium on a particular area of law.

130. HARPER'S. Harper's Magazine Company. Monthly.

A popular general interest magazine.

131. HARVARD BUSINESS REVIEW. Harvard University School of Business.  
6/year.

Styling itself as the "magazine for decision makers," this publication is a bimonthly product of the Harvard University School of Business. Deals with various topics, most centering on management and economic issues.

132. HARVARD JOURNAL ON LEGISLATION. Harvard Legislative Research Bureau.  
3/year.

A publication from the Harvard Legislative Research Bureau, this journal contains texts of model legislation as well as topical articles on legislation at the state and federal levels.

133. HASTINGS CENTER REPORT. Hastings Center Institute of Society, Ethics and Life Sciences. 6/year.

Material contained in this publication is intended to place the dilemmas, issues, and public policy questions growing out of the biomedical revolution before the public. Topics covered are diverse though the journal's prime concern is bioethics.

134. HEALTH CARE FINANCING REVIEW. U.S. Department of Health and Human Services. Quarterly.

The Health Care Financing Administration of the Department of Health and Human Services is charged with seeking alternative ways to finance, organize, and deliver health care services and to assess the impact of federal programs on costs, providers and beneficiaries. HCFA also monitors health care expenditures and prices and provides actuarial analyses of costs of current and proposed health care programs. This journal is their chief means of communicating their findings.

135. HENNEPIN LAWYER. Hennepin County Bar Association. 6/year.  
Issues contain both topical articles and Association business. Articles are contributed by members.
136. HIGH TECHNOLOGY. High Technology Publishing Corporation. Monthly.  
Subtitled "Covering the Business of High Technology," HIGH TECHNOLOGY emphasizes the practical utilization of high tech in a development environment. Articles are non-technical and provide useful background on current high tech advances.
137. HOME AND AWAY. Minnesota Automobile Association. 6/year.  
Articles deal with "Motoring and Maintenance" and travel as well as Minnesota life. Occasionally features articles on legislation in areas of roads and bridges, transportation policy etc.
138. HOUSING LAW BULLETIN. National Housing Law Project. 6/year.  
A newsletter of short articles about developments in housing law. It is aimed primarily at Legal Services people specializing in housing law and nonprofit community housing groups.
139. ICWP WASHINGTON REPORT. Interstate Conference on Water Policy. Monthly.  
This newsletter covers any new water related legislation or issues on a national, regional, and state by state basis.
140. ILLINOIS ISSUES. Sangamon State University with the Support of the Ford Foundation, University of Illinois and Sangamon University. Monthly.  
Articles on policy, problems and personalities which are, or are likely to become, of concern to Illinois lawmakers and government officials. Includes from one to three feature articles. Recent issues have dealt with Chicago city politics and elections. This journal often carries topical articles in series.

141. IN THESE TIMES. Institute for Public Affairs. 41/year.

IN THESE TIMES features news articles on all aspects of current events and culture. Its subheading, The Independent Socialist Newspaper, reflects its politics.

142. \*INC. Inc. Publishing Company. Monthly.

Devoted to the issues and problems of small business. Each issue contains six to ten feature articles on topics ranging from profit-making new enterprises or management to selling and marketing developments. Each October the magazine rates state business climates for small business.

143. INDIAN TRUTH. Indian Rights Association. 6/year.

"Published since 1924, INDIAN TRUTH covers major Indian news from Congress, the courts and 'Indian Country'." Articles pertain to any and all subjects affecting Indians and Indian life.

144. INDUSTRIAL AND LABOR RELATIONS REVIEW. New York State School of Industrial and Labor Relations. Cornell University. Quarterly.

Subjects covered are broader than the title indicates, including all topics relating to employment and employability. Recent issues have included "Predictability Of Strikes," "Regulations, Deregulations And Collective Bargaining In Airlines" and "Early Acceptance Of Social Security." Regular features include book reviews and research in progress.

145. INTERGOVERNMENTAL ISSUES. Illinois Commission on Intergovernmental Cooperation. 7-10/year.

A bipartisan publication designed to inform legislators of important state, federal and local issues. Recent articles have dealt with federal policy and the mid-west economy, housing programs, hazardous waste and a 50 state comparison of AFDC payment levels.

146. INTERGOVERNMENTAL PERSPECTIVE. Advisory Commission on Intergovernmental Relations. Quarterly.

Emphasis is on fiscal and tax matters. Regularly carries "Intergovernmental Focus," ACIR news and book reviews. Useful articles on revenue-sharing, tax limitations, grants-in-aid and state, federal-local and state-local relations and fiscal notes.

147. IRON AGE: MANUFACTURING MANAGEMENT. Chilton Company. Monthly.

Includes background articles focusing on the management aspects of iron and steel manufacturing. Data on price and production are included.

148. IRON AGE: METALS PRODUCER. Chilton Company. 24/year.

Includes data on order trends, price and production data and quarterly forecasts for the iron, steel and related industries. Focus is on metals production rather than management.

149. ISSUES IN SCIENCE AND TECHNOLOGY. National Academy of Science. Quarterly.

The purpose of this periodical is to examine and explain the policy implications of new developments in science, technology and health. Jointly published by the National Academy of Sciences, the National Academy of Engineering and the Institute of Medicine, ISSUES draws on leading professionals in the fields it covers and provides opportunities for all sides of a question to be explored.

150. JOURNAL OF AMERICAN INSURANCE. Alliance of American Insurers. Quarterly.

Provides broad topical coverage. A recent issue included articles on urban decay, arson, car repair and insurance costs, various safety programs and barrier-free environments.

151. JOURNAL OF COLLECTIVE NEGOTIATIONS IN THE PUBLIC SECTOR. Baywood Publishing Company. Quarterly.

"This journal was conceived as a forum for the interchange of ideas and information aiming at the international community of individuals concerned with the negotiations process." Articles relate to public employee bargaining.

152. JOURNAL OF CONTEMPORARY STUDIES. Rutgers University Institute for Contemporary Studies. Quarterly.

This journal devotes five to six feature articles on a broad spectrum of issues of interest to the social scientist as well as the public policymaker. Includes book reviews and letters. Articles contain statistical data and highly academic analyses.

153. JOURNAL OF EDUCATION FINANCE. Institute for Educational Finances and American Education Finance Association. Quarterly.

Articles treat all levels and types of education and all aspects of the law and economics of educational funding. Issues are, at times, devoted to single topics such as equity of school finance programs. Book reviews included.

154. JOURNAL OF FRESHWATER. Freshwater Biological Research Foundation. Annual.

This locally published journal devotes six to ten feature articles of interest to the general public on issues related to water use. Includes beautiful photography and easily read material.

155. JOURNAL OF HOUSING. National Association of Housing and Redevelopment Officials. 6/year.

Contains several lengthy articles on current developments in urban planning and housing fields. Emphasis is on inner city redevelopment and the activities of HRAs and HFAs on state and local levels. Also carries short news briefs of current interest - state activities, local developments.

156. JOURNAL OF LAW & POLITICS. University of Virginia. School of Law. 2/year.

"This journal is devoted to analyzing the interaction of law and politics. It intends to combine scholarly research and analysis unavailable in other sources." Topics include campaign finance, legislative veto, incumbency, apportionment, presidential primaries and nomination.

157. JOURNAL OF LEGISLATION. Notre Dame Law School. 2/year.

Journal treats broad range of issues dealing with legislation and legislators at state, national and international levels. Includes lengthy articles and shorter notes, ten to twelve topics covered in each. Authors are practitioners in fields discussed including congressmen, state, local and federal officials, attorneys, scholars and jurists.

JOURNAL OF MINNESOTA PUBLIC LAW see HAMLINE JOURNAL OF PUBLIC LAW.

158. JOURNAL OF POLICY ANALYSIS AND MANAGEMENT. Association for Public Policy Analysis and Management. Quarterly.

Contains articles on a wide variety of social and political issues from the perspective of a policy analyst.

159. JOURNAL OF POLITICS. Southern Political Science Association. Dept. of Political Science, University of Florida. Quarterly.

With its emphasis on scholarly articles in the area of political science, JOURNAL OF POLITICS analyzes methods, positions and techniques relating to this broad topic. Examples of recent articles are: "Labor in American Politics," "Selecting a Voting System," and "Do Parties Make a Difference?"

160. JOURNAL OF SOIL AND WATER CONSERVATION: TO ADVANCE THE SCIENCE AND ART OF GOOD LAND USE. Soil Conservation Society of America. 6/year.

Objective is promotion of good land use management and the conservation of air, soil, water, wildlife and other renewable resources. Issues contain features, notes, research reports, notices and announcements of interest to members. Presentation is technical.

161. JOURNAL OF STATE TAXATION. Panel Publishers. Quarterly.

Issues have included articles on income tax, taxation of machinery and equipment, unitary tax, taxation of newspapers, audits, sales and use tax litigation and discussion of specific taxes in particular states such as unitary tax in Massachusetts, Philadelphia sales tax exemption for business and New York real estate property gains tax.

162. JOURNAL OF THE AMERICAN PLANNING ASSOCIATION. American Planning Association. Quarterly.

Covers all aspects of topics related to planning including housing, transit, land use, recreation and the finance and management of these. Book reviews and periodical reviews in each issue.

163. JOURNAL OF THE INSTITUTE FOR SOCIOECONOMIC STUDIES. The Institute. Quarterly.

"The institute is a nonprofit foundation with broad research interests relating to quality of life, economic development, social motivation, poverty, urban regeneration and the problems of the elderly." Book reviews are a regular feature.

164. LAND USE LAW AND ZONING DIGEST. American Planning Association. Monthly.

A monthly publication which summarizes recent court cases by topic with complete legal citations when available. Topics covered include inverse condemnation, housing codes, environment and taxation among many others. Also includes a bibliography of recent articles in law reviews again arranged by topic. Covers recent items of note and new legislation in the states.

165. LEGISLATIVE INTERIM REPORTER. Phillips Legislative Service, Inc. Weekly between Legislative sessions.

Publishes legislative committee hearing schedules during session interim periods. Reports on those hearings including major remarks made during hearings.

166. LEGISLATIVE STUDIES QUARTERLY. University of Iowa. Comparative Legislative Research Center. Quarterly.

"The goal of the quarterly is to provide comparative studies of legislatures without regard to legislative boundaries. Ideally every issue ought to include articles on both Congressional and state legislative research in the United States." (editor's preface) Material presented is often technical. Many articles deal with European countries.

167. MPLS/ST. PAUL. MSP Publications. Monthly.

A slick, light publication which, like TWIN CITIES, provides guides to eating and events as well as feature articles.

168. MS. Ms. Foundation for Education and Communication, Inc. Monthly.

This periodical deals with issues and topics about or concerning women.

169. MSBA JOURNAL. Minnesota School Boards Association. Monthly.

Carries short news articles of interest to members. Contains minutes of meetings, legislative positions and general association information.

170. M.T.A. NEWSLETTER. Minnesota Taxpayers Association. Monthly.

This newsletter covers tax issues in the state of Minnesota. Data are presented on such items as property taxes, state spending, and mill rates. This is "must" reading for anyone concerned about taxation.

171. MACLEAN'S. Maclean Hunter Ltd. Weekly.

A Canadian general interest magazine.

172. **MANAGEMENT.** U.S. Office of Personnel Management. Quarterly.

A federal publication, **MANAGEMENT** presents brief articles on government management issues such as contracting out and the role of entrepreneurs in government.

173. **METRO.** Bobit Publishing Company. 6/year.

Of interest to public transportation officials and policy makers, this magazine features descriptions of transportation systems and technology.

174. **MICHIGAN ECONOMY.** Bureau of Business Research. School of Business Administration. Wayne State University. 6/year.

Contains feature articles and data on the economy of Michigan. Recent articles have included "Enterprise Zones," "Tourism in Michigan," and "Profile of Teen Pregnancy in Detroit." Generally, one feature article per issue.

175. **MINERALS AND MATERIALS MONTHLY.** U.S. Department of the Interior. Bureau of Mines. 6/year.

Mainly a statistical and tabular analysis of 12 minerals, including: U.S. net imports reliance, U.S. imports and exports of raw and processed minerals and crude petroleum; petroleum products; and natural gas liquids. A section entitled "State Liaison" includes news items related to minerals and materials such as the steel workers' strike, hazardous waste regulation and nuclear waste disposal. Includes listing of Bureau's recent publications.

176. **MINNESOTA AGRICULTURAL ECONOMIST.** University of Minnesota. Agricultural Extension Service. Irregular.

Each issue of this publication presents an in-depth article about agricultural issues in Minnesota. Data are included.

177. **MINNESOTA BUSINESS VIEWS.** Minnesota Association of Commerce and Industry. Monthly.

MACI's new magazine will explore taxes, labor-management issues, legal developments, politics, employee benefits, and management, all from a business perspective.

178. MINNESOTA CITIES. League of Minnesota Cities. Monthly.

Areas covered are matters of concern to city administrators, including such topics as revenue sharing, funding fire services, historic preservation, rules and regulations. Tables of contents are accompanied by annotations. Recurrent features: court decisions, rules, labor primer and association activities.

179. MINNESOTA FIRE CHIEF. Minnesota State Fire Chiefs Association for the Fire Service of the State. 6/year.

Articles relating to all aspects of fire prevention, fire fighting, service organizations and funding.

180. MINNESOTA HISTORY. Minnesota Historical Society. Quarterly.

Contains articles by historians on all aspects of Minnesota's past. Many reviews of historical publications.

181. MINNESOTA HORTICULTURIST. Minnesota State Horticultural Society. Monthly.

Gardening tips and information.

182. MINNESOTA JOURNAL. Citizens League. 2/month.

A publication of the Citizens League, a nonprofit, nonpartisan Twin Cities public affairs organization. Articles are drawn from a broad range of perspectives and do not necessarily reflect League positions. Discusses metro area issues, policies and personalities.

183. MINNESOTA LAW REVIEW. University of Minnesota. 6/year.

Two or three articles per issue with case comments.

184. MINNESOTA MEDICINE. Minnesota Medical Association. Monthly.

The professional journal of the Minnesota Medical Association which is published monthly. It contains articles not only on medical research and scientific discoveries of interest to doctors, but also articles on public policy and legislation relating to health care.

185. MINNESOTA MONTHLY. KSJN - Minnesota Public Radio, Inc. Monthly.

Contains articles and stories about Minnesota life and programming notes for Minnesota Public Radio.

186. MINNESOTA OUT-OF-DOORS. Minnesota Conservation Federation. Monthly.

A monthly journal devoted to all aspects of Minnesota environment, ecology and sportsmanship. Follows state and federal legislation and regulatory action as well as including articles of general interest.

REVIEW, a quarterly publication of the Multistate Tax Commission, presents articles on tax issues especially as they apply to multistate taxpayers.

202. NIJ REPORTS. National Institute of Justice. 6/year.

NIJ REPORTS contains abstracts of the current literature in all areas of criminal justice. In addition, feature articles are presented summarizing current judicial thought.

203. NATION. Nation Enterprises. Weekly.

The NATION has been an important journal to the political left for over one hundred years.

217. NEW ENGLAND JOURNAL OF HUMAN SERVICES. Osiris Press, Inc. Quarterly.

A popular general interest magazine.

221. NEWS REPORT. National Research Council. 10/year.

News Report is a "magazine featuring activities of the National Research Council" which "serves as an independent advisor to the federal government in scientific and technical questions of national importance."

222. NEWSWEEK. Newsweek, Inc. Weekly.

A popular general interest magazine.

223. NORTHEAST JOURNAL OF BUSINESS & ECONOMICS. Research Center in Business and Economics. College of Business Administration. University of Rhode Island. 2/year.

"Provides an outlet for business and economic research." Has frequent articles on small businesses and banking. Recent editions have essays on small business incubators, revenue generation for state hazardous waste cleanup funds, and the use of banks as alternative insurance delivery systems.

224. OBSERVER. Minnesota Newspaper Foundation. Quarterly.

Written for the Foundation's membership, most of whom are engaged in the newspaper business, this journal covers the state of journalism in Minnesota. Significant recent stories are how the press has covered the farm crisis, the shortcomings of Minnesota's "sunshine" laws, and who owns Minnesota newspapers.

Each issue is dedicated to a specific topic of current concern in the areas of planning and development.

Formerly THE ASSESSOR'S JOURNAL, this technical journal began publication in 1982 and is geared to the specialist in taxation and tax policy. Articles directed toward assessing practices and the promotion of justice and equity in the distribution of the tax burden.

245. PSYCHOLOGY TODAY. American Psychological Association. Monthly.

This magazine presents articles geared to the layman dealing with various aspects of psychology and human interaction. It includes feature length articles as well as abstracts of research and articles in other journals.

246. PUBLIC ADMINISTRATION REVIEW. American Society for Public Administration. 6/year.

This journal provides a forum for the discussion of topics of interest to government administrators. Articles, book reviews and frequent symposia included in each issue. Much material on finance, budget information flow and decision making, management and personnel.

247. PUBLIC AFFAIRS BULLETIN. Bureau of Governmental Research and Service - University of South Carolina. 3-4/year.

Each bulletin analyzes a current public policy issue in South Carolina and the nation that is of concern to city and county governments and community organizations.

251. PUBLIC FINANCE QUARTERLY. Sage Publications, Inc. Quarterly.

Examines the theory, policy, programs and institutions related to the collection, allocation and distribution of federal, state and local governments' economic resources.

254. PUBLIC INTEREST. National Affairs, Inc. Quarterly.

Includes analytical articles on diverse public policy topics. Recent titles include "Politics And Economics Of Regional Growth," "Regional Warfare For Federal Aid," "Taxes, Revenues And The Laffer Curve" and "Moral Education In The Schools." Book reviews in each issue.

255. PUBLIC MANAGEMENT. International City Management Association. Monthly.

Brief articles on topics of particular interest to municipal officials often describing programs, policies or services.

256. PUBLIC OPINION. American Enterprise Institute. 6/year.

263. READER'S DIGEST. Reader's Digest Association, Inc. Monthly.

Famed monthly publication which excerpts articles on a variety of topics which may be of interest to the general reading public.

264. REGULATION: AEI JOURNAL OF GOVERNMENT AND SOCIETY. American Enterprise Institute for Public Policy Research. 6/year.

This journal treats the achievements, failures, effects, developments, decisions and philosophy of regulation and rule making. Authors are frequently well-known government officials or public figures.

265. RESOURCES. Resources for the Future. 3/year.

Committed to advancing the development, conservation and wise use of natural resources and the improvement of the quality of the environment. Each issue contains short opinion pieces on a variety of subjects within these broad areas.

266. RESPONSE TO VIOLENCE IN THE FAMILY AND SEXUAL ASSAULT. Center for Women Policy Studies. 6/year.

Recent issues have contained tables comparing state laws, discussion of judicial decisions, fact sheets on child abuse and sexual assault and articles on patterns of institutional sexual assault, mediation of wife abuse, sexual harassment and rape.

267. REVENUE ENHANCEMENT REPORTER. Government Information Services. Monthly.

"Innovative ways to increase revenues for essential services." Alternatives means for raising local and state government revenues are presented either as ideas or existing programs. Examples include the various state lotteries, tax amnesties, using citizen volunteers, and various types of user fees.

268. REVIEW OF PUBLIC PERSONNEL ADMINISTRATION. University of South Carolina. Bureau of Governmental Research & Service. 3/year.

Research oriented, this slender journal has been focusing on the farm crisis and its effects on the rural economy for some time. Lately, articles have ranged from rural small business management, to the occupational and relocation preferences of families.

272. RURAL TELECOMMUNICATIONS. National Telephone Cooperative Association. Quarterly.

Much of this journal's contents deals with the effects of deregulation and competition in the telecommunications industry on service to rural communities. For example, one recent issue dealt comprehensively with the issues of access charges, universal service, and small rural telephone companies.

273. RURAL TRANSPORTATION REPORTER. Rural America, Inc. Monthly.

This publication not only covers rural transportation issues, but specialized transportation as well. Articles frequently cover transportation services for the elderly, the physically handicapped, and the economically disadvantaged. Ideas for community-based rural transportation systems appear in each issue. A recent example is a guide to seeking grants from foundations for rural transportation.

274. SOI (Statistics of Income) BULLETIN. Internal Revenue Service. Quarterly.

Articles on individual, partnership and corporate returns, the underground economy, alien income, tip estimates, windfall profits and investment credits have appeared in recent issues. Articles include text and many tables. In addition, select statistical series appear in each issue. These tables describe returns filed, excise taxes, refunds, gross IRS collections and number of returns filed.

275. SCIENCE. American Association for the Advancement of Science. Weekly. Articles are usually very technical and aimed at specialists in science and technology fields. Carries three or four feature articles per issue. Recurrent features: "News and Comment," "Research News," "Reports" and book reviews.

276. SCIENCE NEWS. Sciences Service, Inc. Weekly.

Contains brief, non-technical articles on subjects from the sciences and psychology to laser physics, current research reports, reviews of legislation, rules and regulation.

277. SCIENTIFIC AMERICAN. Scientific American, Inc. Monthly.

A respected science magazine with sophisticated, often technical, articles on a variety of subjects, including nuclear power, biology, neurology, astronomy, mathematics and engineering. Book reviews and bibliographies. Regular departments include "50 And 100 Years Ago," "Science And The Citizen" and "The Amateur Scientist."

278. SKILLINGS MINING REVIEW. Skillings Mining Review. Weekly.

Published in Duluth, this journal contains brief articles on technical aspects and development in mining, on companies involved in mining and issues affecting mining.

279. SMALL TOWN. Small Town Institute. 6/year.

Small Town Institute is a nonprofit organization dedicated to collecting and disseminating information on new and innovative ideas concerning the issues and problems facing small towns and nonurban areas. The journal contains perspectives from citizens, planners, government officials, business groups, educators and other interested parties.

280. SMITHSONIAN. Smithsonian Associates. Monthly.

Treats diverse subjects ranging from the routes of medieval pilgrims to profiles of presidents of the Continental Congress. Covers political, artistic, technological, international historical personalities, and events. Timely, unique - an unusual magazine, creative both in choice of content and form of presentation.

281. SOCIAL POLICY. Social Policy Corporation. 6/year.

Emphasizes current social thought in the area of human services. Recent articles have included: "A New Look at the Homeless," "Grassroots Mental Health," "Notes On U.S. Family Policy" and "The Limits Of Human Services." Recurrent features: book reviews and editorials.

282. SOCIAL PROBLEMS. Society for the Study of Social Problems. 5/year.

This wide-ranging scholarly journal covers the gamut of sociological discourse. Gender relations and work division within families, TV violence and crime, racial discrimination in sentencing, and domestic violence against the elderly are only some of the latest topics appearing here.

283. SOCIAL SECURITY BULLETIN. U.S. Social Security Administration. Monthly.

The "official monthly publication of the Social Security Administration" contains articles on the various topics associated with social security.

284. SOCIETY. Transaction, Inc. Rutgers State University. 6/year.

General interest social science journal with international coverage. Issues often include several articles on different aspects of a general topic.

289. STATE AND LOCAL GOVERNMENT REVIEW. University of Georgia. Institute of Government. 3/year.

"The REVIEW provides an interchange of ideas for practitioners and academics in applied research, service, training, and policymaking in state and local government." Articles contain citations and tables.

286. STATE BUDGET & TAX NEWS. State Policy Research, Inc. 2/month.

This newsletter offers continuing coverage of developments in the tax and fiscal conditions of the states. Innovative programs are discussed and evaluated, and the complexities of sales, income, and property taxes are contrasted and compared. Recent editions have continued an ongoing examination of the effects of tax reform on the states, reviewed the revenue effects of lotteries and the taxing of natural resources, and have searched for a formula which would give the authentic cost per family of each state's respective tax policy.

287. STATE COURT JOURNAL. National Center for State Courts. Quarterly.

Major concerns are policies and problems relating to the administration of state courts.

288. STATE EDUCATION LEADER. Education Commission of the States. Quarterly.

News and feature articles on issues and personalities involved at all levels of education. Contributions by elected officials, educators and public administrators.

289. STATE FACTOR. American Legislative Exchange Council. Monthly.

The STATE FACTOR concentrates on one topic in each issue. Current issues have dealt with comparable worth and privatization of transportation infrastructure.

290. STATE GOVERNMENT: THE JOURNAL OF STATE AFFAIRS. Council of State Governments. Quarterly.

Authors represent public affairs professionals and government officials. Recent issues have included articles on legislating the death sentence, planning for military base conversion, mental health and tax reform. Material deals with all three branches of state government. Book reviews.

291. STATE GOVERNMENT NEWS. Council of State Governments. Monthly.

This newsletter is published monthly by the Council of State Governments and describes itself as follows: "Considered the prime source of information on current developments in all state government activities." Usually features a one-page summary of a specific state legislature's actions and carries a section giving short summaries of legislative actions.

292. STATE HEALTH LEGISLATION REPORT. American Medical Association. Quarterly.

Issues provide in-depth review of legislation in two or three health-related subjects, plus capsule reports on several selected topics, court cases or regulatory actions. As defined here, "health" includes legislation pertaining to practitioners in all health fields, insurance, pharmaceutical technologies and devices, facilities and costs, education, patients, diseases and conditions.

293. STATE LEGISLATIVE REPORT. National Conference of State Legislatures. 12+/year.

Each issue provides a thorough overview of a single subject such as state beverage container deposit laws, economic impact statements, legislative caucus procedures, plant closings.

294. STATE LEGISLATURES. National Conference of State Legislatures. 10/year.

Informative articles covering current issues from a state perspective including topics on state legislation and federal-state relations.

295. STATE POLICY REPORTS. State Policy Research, Inc. 2/month.

This newsletter spotlights the major issues facing state governments and records how the various states are responding. The more innovative and responsive ideas are highlighted, then a review of how all the other states are falling in line follows. Major issues that continue to command attention recur over and over in succeeding editions. Examples this year: tort reform, tax reform, business climates, and utility regulation.

296. STATE REGISTER. Minnesota State Register and Office of Public Documents. Weekly.

Contains rule amendments and additions, proposed rules, notices of meetings, state contact offerings and awards, Supreme Court decisions and executive orders.

297. STATUS REPORT. Insurance Institute for Highway Safety. 2/month.

Contains short items relating to all aspects of road, vehicle and driver accident prevention at all levels of government. Contains statistics and materials from the states.

298. SURVEY OF CURRENT BUSINESS. U.S. Department of Commerce. Bureau of Economic Analysis. Monthly.

An excellent source of business statistics; also carries articles on business topics such as Proposition 13, patterns of change in non-farm income and a monthly report on the business situation. Yearly , the August issue carries personal income statistics by states and regions. Very important for anyone who uses business statistics.

299. TECHNOLOGY REVIEW. Massachusetts Institute of Technology. 8/year.

This publication covers the social and political ramifications of technology. Not a technical journal.

300. TEXAS BUSINESS REVIEW. University of Texas. Austin. Bureau of Business Research. 6/year.

Contains a variety of articles focusing on the business and economic climate in Texas and the Southwest. Also contains articles on governmental policies.

301. TEXAS OBSERVER. Texas Observer Publishing Company. 2/month.

Nonpartisan publication covering Texas state government. Articles of late have covered educational reform, the Texas business climate and the Texas state budget.

302. TIMBER BULLETIN: VOICE OF THE TIMBER INDUSTRY. Minnesota Timber Producers Association. 6/year.

Articles on topics of interest to loggers, timber growers and others associated with forests and forest products.

303. TIME. Time, Inc. Weekly.

A popular general interest magazine.

304. TRAFFIC SAFETY. National Safety Council. 6/year.

Material on problems, policies and procedures intended to reduce traffic accidents.

305. TRANSPORTATION QUARTERLY. The Eno Foundation for Transportation. Quarterly.

Intended to promote improved transportation through research and education, this journal publishes academic articles describing and evaluating planning, policy, design, operation, finance and regulation of all forms of transportation services and systems.

306. TRIAL: THE NATIONAL LEGAL MAGAZINE. Association of Trial Lawyers of America. Monthly.

Issues often contain several articles on a single topic, generally with a legal focus.

308. U.S. NEWS & WORLD REPORT. U.S. News and World Report, Inc. Weekly.

A popular general interest magazine.

309. U.S. WATER NEWS. U.S. Water News, Inc. and The Freshwater Foundation. Monthly.

A newspaper that covers all forms of water-related news from across the country: federal water projects and bills, water legislation and policy initiatives from other states, water related litigation, water supply, and cleanliness.

310. UNIVERSITY OF VIRGINIA NEWS LETTER. University of Virginia. Institute of Government. Monthly.

Published by the Institute of Government, NEWS LETTER selects one issue monthly to analyze.

311. URBAN AFFAIRS QUARTERLY. Sage Publications. Quarterly.  
Treats subjects relating to all aspects of municipal and city planning, government and life.
312. URBAN LAND: NEWS AND TRENDS IN LAND DEVELOPMENT. The Urban Land Institute. Monthly.  
Issues feature articles relating to a single metropolitan land development and land use topic. Focuses on governmental institutions and regulations on national, state and local levels.
313. UTNE READER. LENS Publishing Company. 6/year.  
Billed as a digest of articles from the 'alternative' press, actually many of these stories are reprints from the mainstream. Topics rotate around U.S. foreign misadventures, health and nutrition, and environmentalism.
314. VITAL SPEECHES OF THE DAY: THE BEST THOUGHT OF THE BEST MINDS ON CURRENT NATIONAL QUESTIONS. City News Publishing Company. 2/month.  
Contains entire speeches delivered by persons in business, education, politics and government. A useful starting point for the speech writer and a source for quotations.
315. VOTER. League of Women Voters of St. Paul. 10/year.  
Provides background on current League projects, the minutes of member meetings, and a calendar of upcoming events.
316. WASHINGTON MONTHLY. The Washington Monthly Corporation. Monthly.  
An irreverent look at politics, society, government activities and institutions.

317. WASTE AGE. National Solid Wastes Management Association. Monthly.

A monthly publication of the solid waste industry, this journal covers all aspects of interest to those involved in disposal and/or use of wastes in our society.

318. WAYS AND MEANS. Conference on Alternative State and Local Public Policies. Quarterly.

Subtitles "Reporting on Innovative Approaches to State and Local Governments, topics covered are diverse. Recent issues have covered family policy and the federal deficit.

319. WEEKLY COMPILATION OF PRESIDENTIAL DOCUMENTS. Office of the Federal Register. National Archives & Records Administration. Weekly.
