I. THE LEGISLATIVE SERVICES COMMISSION

Created by the 1969 Legislature. See 1969 Minnesota Statutes, section 3.301 and 3.302 for the Legislative provision. The Commission has six members--three from the House and three from the Senate. Their terms run from the last day of a regular session of the Legislature to the last day of the next succeeding regular session and until a successor is appointed. In the 1969 law the only responsibility assigned to this Commission was to provide a Legislative Reference Library.

III. PREFACE  
(including a note about the Reading Room and the Hours of Opening)

Legislators are faced with the problem that faces all decision-makers:

"A PERSON'S OPINION AND  
JUDGMENT IS NO BETTER THAN  
HIS INFORMATION"

Information can come to legislators from many sources--such as news media, citizen organizations, constituents, lobbyists, and even from the hard school of experience.

The printed page often supplies facts and represents research done by others. Whenever a legislator has to make a decision on legislation or other matters the better his background of information the better his judgment should be.

The Library's Purpose  
Is Securing, Storing  
and Retrieving Information  
in Printed Forms

This manual is intended to be kept by each member of the Legislature. It will show him what types of material and services are available in the Legislative Reference Library.

\* \* \*

To begin with, the manual presents an opportunity for both the members of the Legislative Services Commission and the Legislative Library staff to call attention to the fact that this library is one of the legislative services operated jointly by and for all members of both the House and the Senate.

The Library policy is that it will do anything it can for any of the members of the Legislature. This includes, of course, the staffs of the House Research Department and of the Senate Counsel, and any other persons assigned by caucuses or members to do research for them. The Library staff does not write research reports, for that is the function of the research workers. The Library is an information source, however, that all can use. Secretaries of committee chairmen or other employees of the Legislature may also seek information here, the idea being that the Library resources should be used to advance the work of the Legislature in any way possible.

#### READING ROOM

Tables and chairs are available for 8 or 10 persons to sit and do their research work in the Library itself. Many members like to stop to look at newspapers or magazines when they find time. Some books are available only for reference, in which case the user will have to be asked to come in person. Though small in size, the Reading Room is a light, cheerful and convenient place. It is in Room 111, just off the entrance lobby on the main floor of the Capitol when one enters from University Avenue (at the end of the North wing).

#### HOURS OF OPENING

8:30 am (usually someone there at least at 8:00 am) to 5:00 pm--Mondays through Fridays.

#### IV. HOW TO SECURE BILLS INTRODUCED IN FORMER MINNESOTA LEGISLATURES

For many years one of the copies of each bill that was introduced into the Legislature was deposited (after the session was over) in the State Law Library.

Now that there is a Legislative Library it was agreed by the members of the Legislative Services Commission that an offer to turn over the old bills to the Legislative Library should be accepted.

In 1969, for instance, some 5,776 bills were introduced, whereas only 1,159 were actually passed. Other bills on many of these subjects that were not passed will doubtless be introduced in the 1971 session. Committees or other members or researchers may want to see certain bills that were introduced even though they did not pass. The Journals from each session provide a subject approach to secure the numbers of bills.

Perhaps a member will want occasionally to go back a number of years. Actually the files from the Law Library go back as far as 1912. (In due time, in the future, it is hoped the early bills can be microfilmed and the paper copies disposed of.)

Policy of the Library will be not to permit old bills to be removed from the Library for fear they might be lost. Very long bills would ordinarily have to be used in the Reading Room. On others, Xerox copies would be made for the member who needs them. It is expected that in most cases it will be practical to issue the bills in Xerox form.

#### V. NEWSPAPERS AND NEWSPAPER CLIPPINGS

These are one of the most useful resources in the Library. They are an excellent way to refresh one's memory on what happened about certain bills or subjects, etc. They are an excellent way to get oriented in starting to study about a new subject. The news reports give a good idea

of what problems have arisen in a field during the past year or two, and the member or researchers can take it from that point.

IMPORTANT NOTE ABOUT NEWSPAPERS

Papers are kept for 10 days only. After that they are marked (and then clipped by library student pages) to save all articles believed to be of possible use to legislators and their researchers. Clippings are then filed by SUBJECT.

The Library has been clipping the above newspapers since January 1, 1969. Consequently, in the 1971 session if a person wants to check on viewpoints or meeting testimony, etc., on a subject when the same subject was before the

Legislature in 1969, these clippings are still available.

C. Out-state Minnesota Papers.

Up until the present time the policy was to depend on the four Twin City newspapers for Minnesota legislative news because their combined coverage is very full, including news about bills affecting other parts of the state.

It was felt that if even a few out-state newspapers were placed there, the Library would be buried in papers because it could be expected that a great many or most legislators would feel that their local paper should also be filed and clipped.

It was decided to experiment in the 1971 session with subscriptions to a geographically spaced group of papers. Letters were sent to 19 selected papers, asking if they would give the Legislative Library a complimentary subscription during the period of the 1971 session.

The following papers are now being received on a trial basis all during the 1971 session. As with other papers, they will be kept in the Library for 10 days and then clipped.

## VI. MAGAZINES AND NEWSLETTERS

Just as the Library subscribes to newspapers not just for their current news use but also to garner out of them printed information that might help the Legislature in its work, similarly does it receive a large number of subscriptions to magazines and newsletters. Many are on paid subscriptions, but a very large number are received free through efforts to get on mailing lists on behalf of the Legislature.

Most magazines are monthly or weekly or quarterly. Newsletter may also be, but also they may be issued irregularly or sporadically. The Library uses the term newsletter to describe the little publications of four or six or ten (or whatever it happens to be) pages that so many organizations issue. All are potential treasure-troves of information.

Standard indexes record articles in magazines by subject and provide the ordinary approach to finding reference to such material. Three that the Library has are:

Reader's Guide to Periodical Literature

Public Affairs Information Service

New York Times Index (Though this is an index to a leading newspaper, it is an excellent source for placing people and events when those categories are of such prominence that the "New York Times" probably would have had an item about them. These clues can lead one to similar dates in local papers.)

However, the Legislative Reference Library is doing much more than provide printed indexes to magazines. For the past six to eight months its staff has been going through each day's magazines and newsletters and selecting the itmes it is thought would be of interest and aid to legislative researchers.

### UNIQUE SAMPLE-ARTICLES-FILE

Instead of clipping the articles, such as is done with newspapers, the pertinent articles from magazines and newsletters are photocopied by Xerox.

These are then classified by exactly the same numbers that are used to arrange clippings by subject. The result is that when a person is looking for information on a subject, the file of periodical articles can immediately supply him with recent articles if any have been found. The Library's files of Xeroxed articles are not meant to be loaned. Instead, they act as a "sample" file of magazine articles. The reader can look at the articles, and the Library will lend him the actual magazine or make a Xerox copy for him.

The sample-articles-file is virtually unique, providing quick access to articles. One important feature is that it includes a great many items from newsletters and other publications that are not indexed in the standard printed indexes on which most libraries rely.

#### LIBRARY'S MAGAZINE LIST IS APPENDED

At the back of this manual is an alphabetical list (on colored paper) of all the magazines and newsletters the Library receives. That list can be consulted when a person wants to know if a specific title is available.

With this is also a separate list that groups the magazines under broad subject headings. That is to help a person know what magazines are available on Education, for instance, or Agriculture, or other subjects.

Because the alphabetical list of the magazines is so long, it was felt that the list of magazines by subject should be kept to as few pages as possible. Accordingly, the groupings are very broad. There may be times when a person will need to look at several categories to find the subject he is searching for. When in doubt, or when something not there is wanted, please telephone the Library to find whether it could be secured elsewhere.

## VII. STATE DOCUMENTS AND INTERIM COMMISSION AND OTHER MINUTES

The 1969 Statutory provision for the Legislative Services Commission provided that the Legislative Reference Library be a depository thereafter for all publications issued by any State of Minnesota departments or agencies.

A good collection of such documents was started in July 1969 when this part of the law became effective. Mrs. Zona DeWitt, the Library Administrative Assistant, accepted full responsibility for collecting and organizing Minnesota documents. To strengthen the collection, she made many dozens of telephone calls to get State publications. The result is a very good collection of State publications from recent years.

Minute books of Legislative Committees and of metropolitan agencies sponsored by the State, as well as Interim Commission reports, are also a collection she is developing. During the interim between the 1969 and the 1971 sessions, the Library received most, if not all, Minutes of meetings and hearings held by Interim Committees.

Minutes of Session Legislative Committees are not available at all in the Legislative Library. By a policy of the House Rules Committee made before there was such a library, all Minutes of such committees were sent to the Minnesota Historical Society six months after each session was over. In the Rules adopted by the House on January 7, 1971, however, it is provided that the committee books of all standing committees (except those of the State Claims Commission) shall be delivered to the Legislative Reference Library six months after each session, where they will be available for public inspection. The Senate, on the other hand, has stored its own session minute books. Some day it may be considered more convenient to have all Legislative committee and commission books in the one Library rather than to have to send persons also to the Historical Society or the Senate office as the case may be. A future microfilm project might ultimately be a goal for such records.

VIII. LEGISLATIVE MATERIALS AND LEGAL MATERIALS

Because the LAW LIBRARY on the third floor of the State Capitol is such a complete and outstanding one, there is no need for the Legislative Reference Library to develop any more legal materials than are necessary to carry on its information work.

It must have Minnesota Session Laws and Statutes, of course, as well as the Journals of the House and Senate. However, it need not carry files of these from many years ago as those could always be secured from the Law Library.

Similarly, the United States Statutes-at-Large are in the Law Library. The only Federal laws the Legislative Library has are those passed since 1958. This set was a recent gift from the Law Library.

In these days of Federal grants and revenue sharing and all sorts of Federal-State relationships, the Legislative Library must have current information on what is going on in Congress. The best publications for this are a weekly publication called Congressional Quarterly Weekly Reports and the daily Congressional Record. A full list of publications of this sort will be found under the heading "Congressional and Washington News and U.S. Publications" in the subject index at the back of this manual. There also, under "Law and Courts", it will be seen that the only law review magazines to which the Legislative Library subscribes are "California Law Review", "Law and Contemporary Problems", "Minnesota Law Review" and a new one from California called "Pacific Law Journal". The only reason for having these in the Legislative Library is because they frequently have items on legislation or interpretations of it. Other than those, the Law Library is depended upon for the "Index to Legal Periodicals" and its very complete files of what seems to be all law reviews.

Of books about the Minnesota Legislature, the collection of "Blue Books" or "Legislative Manuals" in the Legislative Library is remarkably complete, running from 1887 to date, with only the 1891 volume missing. It never would have been possible to build a set with the earlier volumes if it were not for the generosity of Mrs. DeWitt (who had a hobby of collecting them) plus some other persons who kindly gave volumes. If anyone has an 1891 volume, plus any before 1887, what a gift those would make for the Legislative Library!

The first two listed above have issued many excellent publications that are of great importance in the legislative field. The Library's collection of them is not complete, but is very good. Most of what would be asked for would be available.

The latter two organizations issue fewer publications, but the Library has, it believes, most of them.

IX. RESEARCH REPORTS AND PAMPHLETS

The Library is a member of a National Legislative Documents exchange whereby research reports prepared in other states by or for Legislative Councils, etc., are exchanged. Many helpful studies are received free through this source.

In this age when hiring consultants or appointing commissions to study current problems results in numerous reports in pamphlet form, the Library is ever seeking copies.

Documents published by the U.S. Government are sought in a wide range

of subjects, too. Many are received free, but some must be purchased. Some that are important, for instance, come from the Census Bureau; transcripts of hearings from Congressional Committees; studies from the Department of Health, Education and Welfare, for instance, are only a very few of the excellent pamphlets received in this way.

The Library is in the process of classifying these by subject with the same numbers used for clippings and periodical articles.

#### X. REFERENCE BOOKS

This term is used to group together books that are tools of the Library profession to refer to for information as contrasted with books that one might read from cover to cover.

Attention is called to a few, so a member of researcher may use them when needed.

#### ENCYCLOPEDIAS

Americana Encyclopedia. 1969 edition. All the world's knowledge (it almost seems) is here in brief form. 30 volumes.

Encyclopedia of the Social Sciences. Latest edition of a scholarly, specialized encyclopedia. 1968. 17 volumes.

#### DICTIONARIES

Webster's Unabridged, of course.

Black's Law Dictionary.

Dorland's Medical Dictionary.

A few foreign language dictionaries, as Latin, French, German.

A few specialized dictionaries, as on technical terms, science, foreign phrases and abbreviations.

#### STATISTICS AND FACT BOOKS

"Book of the States, 1970-71". Issued by Council of State Governments.

"Statistical Abstract of the United States, 1970". Published by U.S. Government to give all types of statistics.

"County and City Data Book". 1967.

Almanacs and Year Books, such as "World Almanac", "New York Times Almanac", "Information Please Almanac", "Reader's Digest Almanac". All are useful for quick reference.

#### ADDRESSES, NAMES, AND INFORMATION ABOUT ORGANIZATIONS

Best for national organizations of all kinds is Encyclopedia of Associations.

"Who's Who in Minnesota" (centennial edition, 1958) (no current directory of Minnesota personages is published)

Besides the Taylor book, the pamphlet supplements that the Council of State Governments issues giving names of members of the Legislature in each state, and on the names of the administrative department heads in the state governments, are of much importance in finding current names in these latter fields.

#### WORDS AND USAGE

"Funk and Wagnall's Modern Guide to Synonyms"

"Government Printing Office Style Manual"

"University of Chicago Manual of Style"

"Zip Code Directory of the United States"; Covers every community in the country, state by state, and gives the zip code for government buildings, office buildings, colleges, etc., in the larger cities.

QUOTATIONS and aids for public speakers, and so on and on. The Library tries to be ready to supply all types of information which may be requested.

XI. BOOKS IN GENERAL

The requirements of a library devoted to supplying information for legislators demands current (or old) information found principally in the types of printed material described above.

For that reason it is never expected that the Legislative Reference Library will have a large collection of books, such as the Law Library, or a college or university, or a public library must have.

Book-buying for this library would include books about legislatures and legislation, about state and local government, and politics and political science, about taxation, and about Minnesota. For each session an effort will be made to have a few books on current subjects--education, for instance, and public finance, juvenile delinquency, apportionment, crime and prisons, social welfare problems (a few now on abortion, drugs, alcoholism, for instance, because these are current topics on which proposed legislation will need research). Paper-bound copies are often adequate for the purpose when they are available.

The Legislative Reference Library, then, should not be thought of as one that will develop a large collection of books. Primarily it is an information center supplying information from printed sources, most of which are of other kinds than books.

Books are important in such service, of course, but the ever-changing subjects that come before successive sessions of the Legislature will make a large, continually growing, section of subject-field books unnecessary. However, many members of the Legislature have expressed interest in the books that are currently available. There are already many books for those who like to read and find time for it.

### Inter-Library Loans

What does the Library do when a specific book or material is requested that it does not have? The answer is that it makes every effort to borrow it at some other library. There are four principal libraries that have been drawn on heavily by this library to secure books or magazines that are not in its collection. They are: the Law Library (here in the Capitol); the Public Library Division of the State Department of Education; the St. Paul Public Library; and the Hill Reference Library. All deserve 100% appreciation for interested and most generous service. Many other libraries have given excellent help when called upon, but the four named are used most because of their large size and their convenience.

### XII. TIME LIMITS ON LIBRARY MATERIALS

Everyone understands that libraries LEND publications rather than give them away. If that were not the case there would soon be no library left.

The Legislative Services Commission has given direction that a time limit be placed on material loaned. It has given the Library staff discretion to work out with each borrower what the time limit will be. Current newspapers are loaned only long enough for a person to take them to a Xerox machine when a copy of an article is wanted. In general, research reports and magazines may be kept for one week; books for two weeks. The due date decided upon with each borrower will be stamped inside the back cover of the publication. It will be appreciated if the material is returned by that date. Reminder slips will be sent to the borrower if the material is not returned by the time limit set.

The Legislative Services Commission and the Library staff want everyone to use the information freely, realizing that information must frequently be secured to help legislators form important decisions. Although

there will inevitably be times in any library where nothing can be found that will provide the information wanted, still a dedicated staff will make every effort to comb resources to try to find what is wanted.

For the best use of all materials from the Library it is suggested that:

THE SOONER YOU RETURN THE MATERIALS YOU BORROW,

THE SOONER THEY WILL BE AVAILABLE FOR OTHERS WHO MAY NEED THEM.

Do telephone or write or come to the Library when information you need may be something that can be found in printed form.

To group titles of magazines and newsletters into groups is confusing as many fit into more than one category.

On the different color paper following the Subject List is a complete Alphabetical List of all magazines and newsletters received. If the question is only whether a particular title is available, that is the list to use.

It is suggested that when a person wonders about a periodical listed in the Subject Index, he check it in the Alphabetical List, for sometimes fuller descriptive entries are recorded on titles in the Alphabetical List.
