The Central Corridor light-rail transit line has been in the news lately for a couple of reasons - the *Central Corridor Alternatives Analysis and Draft Environmental Impact Statement* was released in early April, hearings to discuss several corridor transportation options are scheduled for late May, and some state funding is being considered in the bonding bill. Linking downtown Minneapolis to downtown St. Paul via light-rail has long been a goal of light-rail proponents. The success of the Hiawatha light-rail line may increase the likelihood of the second line but the process is far from over.
