#### FEATURED PROJECTS

#### Art Speaks at the Minnesota History Center

The art collection at the Minnesota Historical Society is the most comprehensive collection of Minnesota art in the world with more than 7,000 works and counting. Art Speaks, an exhibit at the Minnesota History Center from February through July, shared more than 160 paintings, sculptures, photos, and more collected over the past 15 years. The exhibit featured four interrelated themes playing to the collection's historic strengths rooted in portraiture and landscapes and works that highlight the strengths of visual arts in Minnesota - all while stirring viewers' imaginations and encouraging Minnesotans to have a closer look at history as reflected in art.



## Women of the Big Lake / Misi-zagaa'iganii-ikwewag

A new exhibit at the Mille Lacs Indian Museum and Trading Post celebrates the women of the big lake and their lasting contributions to American Indian Arts. Women of the Big Lake / Misi-zagaa'iganii-ikwewag is a story of adaptation and resilience, commemorating the lives, achievements, and legacies of Mille Lacs Band members Margaret Hill, Maude Kegg, Cheryl Minnema, and Batiste Sam. These four remarkable women retained cultural practices and values in the face of adversity, while staying connected to their homeland. Through their arts, writings, and teachings, their cultural knowledge will be passed onto future generations of Anishinaabeg. The exhibit is currently open to the public.



#### **Taking Top Honors at National History Day**

The week-long, 2022 National History Day competition ended in June with a dramatic awards ceremony featuring students from Elk River, Duluth, and more. Minnesota's 65 competitors took home an array of awards including one silver medal, one bronze medal, a special prize, and several other top finishers based on this year's theme, "Debate and Diplomacy: Successes, Failures, Consequences." Minnesota's delegation included students in grades six through 12 from around the state, who competed against students from across the nation. The students presented exhibits, papers, documentaries, performances, and websites representing months of research and work. Due to COVID-19, the 2022 National History Day contest moved online for the third year with the award ceremony shared via a livestream from the National History Day website at www.nhd.ora.



## Righting a Wrong: Japanese Americans and World War II, at the Minnesota History Center, April 23-July 3

Embracing themes that are as relevant today as they were 75 years ago, the Smithsonian traveling exhibition *Righting a Wrong: Japanese Americans and World War II* at the Minnesota History Center examined the complex history of immigration, prejudice, civil rights, heroism, and what it means to be an American. Through historical images, personal stories and objects, the exhibition shared the complicated history and impact of Executive Order 9066 that led to the incarceration of Japanese Americans following the attack on Pearl Harbor.



#### Legacy Grant Revs Up Fire Station No. 24

Fire Station No. 24, located on a corner in the Minnehaha-Hiawatha Corridor, was staffed exclusively by African Americans from 1907-1912, the only such fire station in Minneapolis history. The building was created as part of a broader expansion of the fire department throughout the city, segregating African American employees. The City of Minneapolis Community Planning & Economic Development department received a \$10,000 Legacy Grant to hire a qualified historian to complete a local historic designation study. This designation will help ensure the preservation of this historically significant property and its association with events that exemplify broad patterns of cultural, political, and social history in Minnesota.



### A Jewel in Belview: Historic Odeon Hall Roof Restoration

The year 2021 marked the 120th anniversary of the Odeon Theatre located on Main Street in downtown Belview. The historic theater was built to host community events and to this day, continues to be a gathering place each month. It is where the community meets and is a tangible touchstone for local history, bringing economic benefits to downtown and a wider community to enjoy the theater. The roof repairs restoration, made possible by a \$198,800 Legacy Grant, included critical work to stabilize the historic structure and retain the features of its Queen Anne architectural style, which brings additional aesthetic benefit to the community. Today, Odeon Theatre is once again a jewel in downtown Belview.

#### INTRODUCTION

On November 4, 2008, Minnesota voters approved the Clean Water, Land, and Legacy Amendment to preserve and enhance some of the most important elements of our state. This amendment to the Minnesota Constitution, often referred to as the "Legacy Amendment," created four funds, one of which is the Arts and Cultural Heritage Fund (ACHF).

The Legacy Amendment mandates that a portion of the ACHF be used "to preserve Minnesota's history and cultural heritage" (Minnesota Constitution, Article XI, Sec. 15). Each January, the Minnesota Historical Society (MNHS) is required to submit an annual report to the governor and legislature detailing expenditures it has made from the ACHF.

This report details all ACHF grants awarded, and projects and programs funded, through MNHS, **for Fiscal Year 2022 (FY22)**, the year ending June 30, 2022.

#### ACHF history projects are benefiting Minnesotans statewide by:

- Preserving our state's most valuable historical and cultural resources for future generations
- Sharing our state's stories and treasured resources with ever-growing audiences including students, teachers, scholars, researchers, genealogists, and the general public
- Connecting Minnesotans of all ages to each other and to history—history that is becoming more accessible than ever before

#### **APPROPRIATIONS**

The Arts and Cultural Heritage Fund receives 19.75% of overall Legacy funding. In 2021, the legislature appropriated \$33.085 million from the ACHF to MNHS for the two-year period July 2021-June 2023. That appropriation breaks down to \$15.588 million for fiscal year 2022 and \$17.497 million for fiscal year 2023. The legislature divided the fiscal years 2022 and 2023 appropriations to MNHS into the following six categories:

#### HISTORIC RESOURCES ADVISORY COMMITTEE (HRAC)

Legislation specifies that the HRAC, a volunteer citizen panel that guides decisions for the Minnesota Historical and Cultural Heritage Grants Program, has balanced statewide membership and includes representatives of local, county, and statewide historic and cultural organizations and programs.

It further requires that the HRAC shall include, but is not limited to, members representing the interests of historic preservation, local history, archaeology, archival programs, and other cultural programs related to the history of Minnesota.

#### **ACCOUNTABILITY**

The Minnesota Legislature has reiterated the mandate that every project and program supported by the Arts and Cultural Heritage Fund report "actual measurable outcomes, and a plan for measuring and evaluating the results."

MNHS staff and partners are strongly positioned to ensure that ACHF projects and programs use best practices, current scholarship, and when appropriate, incorporate state-of-the-art technology for demonstrating measurable outcomes. During FY22, MNHS continued to evaluate the impact of ACHF projects and programs to ensure that they demonstrate measurable outcomes as well as economic value for citizens. These results will be shared on a website explained below.

#### **TRANSPARENCY**

The Minnesota Historical Society has an obligation to the citizens of Minnesota to ensure that ACHF dollars entrusted to our care are invested in ways that are transparent and will produce the greatest measurable impact on lives, enabling our state to thrive.

To meet this goal, MNHS has assisted in the building of a website that informs the public about all ACHF initiatives funded through MNHS. Minnesota's Legacy, www.legacy.mn.gov, was created by the Legislative Coordinating Commission and contains information on all Legacy-funded projects. Through the end of the biennium, MNHS will continue to post the most current information about historyrelated ACHF initiatives ensuring transparency and responsible stewardship of the funds.

### ARTS AND CULTURAL HERITAGE FUND HISTORY **APPROPRIATIONS LANGUAGE**

Session Law Reference: Laws of Minnesota, 2021 First Special Session, Chapter 1, Article 4, Section 2, Subdivision 4.

#### Subd. 4. Minnesota Historical Society, FY2022: \$15,588,000. FY2023: \$17,497,000

(a) The amounts in this subdivision are appropriated to the governing board of the Minnesota Historical Society to preserve and enhance access to Minnesota's history and its cultural and historical resources. Grant agreements entered into by the Minnesota Historical Society and other recipients of appropriations in this subdivision must ensure that these funds are used to supplement and not substitute for traditional sources of funding. Funds directly appropriated to the Minnesota Historical Society must be used to supplement and not substitute for traditional sources of funding. Notwithstanding Minnesota Statutes, section 16A.28, for historic preservation projects that improve historic structures, the amounts are available until June 30, 2025. The Minnesota Historical Society or grant recipients of the Minnesota Historical Society using arts and cultural heritage funds under this subdivision must give consideration to Conservation Corps Minnesota and Northern Bedrock Historic Preservation Corps, or an organization carrying out similar work, for projects with the potential to need historic preservation services.

#### (b) Historical Grants and Programs

#### (1) Statewide Historic and Cultural Grants

\$5,982,000 the first year and \$7,000,000 the second year are for statewide historic and cultural grants to local, county, regional, or other historical or cultural organizations or for activities to preserve significant historic and cultural resources. Money must be distributed through a competitive grant process. The Minnesota Historical Society must administer the money using established grant mechanisms, with assistance from the advisory committee created under Laws 2009, chapter 172, article 4, section 2, subdivision 4, paragraph (b), item (ii).

#### (2) Statewide History Programs

\$6,213,000 the first year and \$6,990,000 the second year are for historic and cultural programs and purposes related to the heritage of the state. Of this amount, \$213,000 the first year must be used by the Board of Directors of the Minnesota Historical Society to either produce or purchase and distribute a book to engage and educate elementary school students on Minnesota's natural resources, legacy, culture, and history. The book should be made available costfree to educators and libraries and through state historical society sites to provide to a targeted grade of elementary school students.

#### (3) History Partnerships

\$2,450,000 the first year and \$2,550,000 the second year are for history partnerships involving multiple organizations, which may include the Minnesota Historical Society, to preserve and enhance access to Minnesota's history and cultural heritage in all regions of the state.

#### (4) Statewide Survey of Historical and **Archaeological Sites**

\$475,000 the first year and \$525,000 the second year are for one or more contracts to be competitively awarded to conduct statewide surveys or investigations of Minnesota's sites of historical, archaeological, and cultural significance. Results of the surveys or investigations must be published in a searchable form and available to the public cost-free. The Minnesota Historical Society, the Office of the State Archaeologist, the Indian Affairs Council, and the State Historic Preservation Office must each appoint a representative to an oversight board to select contractors and direct the conduct of the surveys or investigations. The oversight board must consult with the Department of Transportation and Department of Natural Resources.

#### (5) Digital Library

\$368,000 the first year and \$382,000 the second year are for a digital library project to preserve, digitize, and share Minnesota images, documents, and historical materials. The Minnesota Historical Society must cooperate with the Minitex interlibrary loan system and must jointly share this appropriation for these purposes.

#### (6) Grants

(i) \$100,000 the first year is for a grant to the Litchfield Opera House to restore and renovate the historic Litchfield Opera House.

(ii) \$50,000 the second year is for a grant to the city of South St. Paul to relocate the gatehouses in the BridgePoint Business Park that remain from the Armour & Company meatpacking campus.

#### (c) Balance Remaining

Any unencumbered balance remaining under this subdivision the first year does not cancel but is available the second year.

### REPORT OF MINNESOTA HISTORICAL AND CULTURAL HERITAGE GRANTS



The ACHF-supported Minnesota Historical and Cultural Heritage Grants Program provides a valuable opportunity for nonprofit and educational organizations, government units, and federally recognized tribes across Minnesota to preserve and share the state's history and cultural heritage. The Minnesota Historical Society administers the Minnesota Historical and Cultural Heritage Grants Program and awards grants based on the recommendations of the Historic Resources Advisory Committee.

Through a competitive process, 3095 grants totaling more than \$69 million have been awarded to 924 organizations in every county in Minnesota since the Legacy Amendment was passed in 2008. This year's report reflects 12-months of grants awarded from July 1, 2021 to June 30, 2022. In this time frame, 195 grants totaling more than \$7.3 million have been awarded in 60 counties to 159 organizations across Minnesota.

Minnesota Historical and Cultural Heritage Grants are available in two tiers:

- Small or Structured Grants of \$10,000 or less
- Large Grants of more than \$10,000

Ten percent of grants funding is used to administer and ensure the success of the Minnesota Historical and Cultural Heritage Grants Program. The funds allow MNHS to lead statewide grant-writing workshops and webinars, assist applicants with technical information critical to submitting a successful grant application, and support recipients throughout the life of their project.


To assure transparency and measurable outcomes of projects, grants staff members conduct monitoring visits required by the Minnesota Office of Grants Management and, throughout the grant life cycle, monitor the progress of all awarded grants.



### REPORT OF STATEWIDE HISTORY PROGRAMS



The Minnesota Historical Society has been preserving, sharing, and connecting people with history since 1849. With support from the Legacy Amendment's Arts and Cultural Heritage Fund, the people of Minnesota are investing \$13.203 million this biennium in history programs that will bring the power of history to Minnesotans of all ages in all corners of the state.

This Legacy report presents a look back on how funds were used for Statewide Programs in FY22.

Appropriations Language-Statewide History Programs: \$6,213,000 the first year and \$6,990,000 the second year are for historic and cultural programs and purposes related to the heritage of the state. Of this amount, \$213,000 the first year must be used by the Board of Directors of the Minnesota Historical Society to either produce or purchase and distribute a book to engage and educate elementary school students on Minnesota's natural resources, legacy, culture, and history. The book should be made available cost-free to educators and libraries and through state historical society sites to provide to a targeted grade of elementary school students.

#### **ARCHAEOLOGY**

#### Archaeology Collections Management, \$77,137

This project creates detailed digital catalog records for archaeological collections that were acquired before digital documentation was possible. This work increases the accessibility and research value of the MNHS archaeological collections. It also brings curation of these collections up to current standards and increases the number of archaeological objects available to view on the MNHS website. The focus of this project is currently archaeological sites along the Minnesota River Valley. Completing digitization for these collections now allows for more convenient access to the collections and eliminates the need for additional storage space required to maintain physical access. Digitization of the archaeological collections includes artifact photography, updated artifact descriptions, and narrative writing. During FY22, the Archaeology Department completed a collections inventory of Fort Ridgely, starting with data from archaeological excavations from 1936, and updated over 70,000 artifacts and associated data.

#### Historic Sites GEO Database, \$39,718

The Historic Sites Geodatabase Project collects and organizes information from previous archaeological investigations and site data at MNHS Historic Sites into a geodatabase system for each MNHS Historic Site. The project creates a site-specific, comprehensive spatial database tool for MNHS and partners to manage past and future archaeological research, sites and content, assists in the preservation of resources at Historic Sites, and serves as a platform to create interactive education tools for Historic Site interpretation as well as a path for building future digital content. During FY22, geodatabases were completed for the Snake River Fur Post, Mille Lacs Museum & Trading Post, Split Rock Lighthouse, Lindbergh House & Museum, Marine Mill, and Lower Sioux Agency. A geodatabase was started and in progress for Jeffers Petroglyphs and updated geodatabases from Historic Fort Snelling and Historic Forestville.

#### Curator of Archaeology, \$21,297

These funds were used for the partial salary of a curator to support archaeological collection work.

#### **EDUCATION AND PROGRAMMING**

#### Digital Access Initiative, \$346,568

In FY22, Legacy funding was used to align new Digital Access activities with MNHS's newly adopted strategic plan, transforming and creating broader access to MNHS resources for the people of Minnesota. MNHS welcomed new staff to more deeply integrate digital activities within historic sites, education and the Gale Family Library. Through these efforts, MNHS extended live virtual and hybrid programming, developed original videos celebrating notable women in Minneapolis history for Women's History Month, and worked with historic sites to produce pre-recorded programs available on demand, including a virtual tour of Jeffers Petroglyphs. Teacher education and curriculum teams used Legacy funding to support teachers with resources they needed most during an exceptionally challenging school year that bridged remote and inperson modes of learning amid staffing shortages.

## Forest History Center Adventures & Logging Camp Programs, \$145,778

Legacy funding was used to purchase kayaks and water safety equipment now actively used in Forest History Center's water tour program. Through these tools, the public can now gain a greater understanding of logging, forest ecology, and the Mississippi River's role in shaping the region. This project added programs and public engagement on the water, in the woods, at logging camp, and inside the visitor center. The result has created many activities and opportunities for the public to actively participate in the area's industry, ecology, and natural amenities, all while learning about historical connections between these areas.

#### History Center Public Programs, \$26,453

This funding supported a program specialist position to develop programs for the Minnesota History center's core audiences, including adult learners and intergenerational/family groups. Content was tied to exhibit themes and broad history topics.

#### History Center Museum Programs, \$73,464

This funding created a program associate position to work under the direction of the Minnesota History Center site manager to develop and implement programs to serve the museum's core audiences, including adult learners and intergenerational/family groups, and field trips. Content was tied to exhibit themes and broad history topics.

#### Our Home: Native Minnesota Museum Theater, \$6,880

Museum theater was not possible under Covid restrictions. This funding supported virtual and inperson programming highlighting artists and stories featured in the Our Home: Native Minnesota exhibit. An interactive station with two custom puzzles featuring art from past Native American Artistsin-Residence was added to the Our Home: Native Minnesota exhibit, creating an activity designed for family and field trip audiences.

#### Jeffers Petroglyphs Development, \$20,983

This project supports a program assistant position at Jeffers Petroglyphs and uses their expert knowledge of the site and site history in the delivery and evaluation of existing content and programming. Additionally, the program assistant will collaborate with the site manager and outside parties to develop, deliver, and train new content to site staff to engage a wide-ranging audience. The goal is to increase visitors' understanding and appreciation of the Native Americans who interacted with the Jeffers Petroglyphs site through the development and delivery of programs, special programs, and tours.

#### Legacy Field Trip Support Fund, \$38,616

The high cost of transportation prohibits many Minnesota teachers from taking their students on field trips. Historically, the Legacy Field Trip Support Fund offsets transportation costs to all MNHS historic sites and museums. Eligible schools (those with 25% or more students enrolled in the Federal Free and Reduced Lunch Program) are reimbursed \$4 per student, allowing more students access to field trips.

During the pandemic, in-person field trip programming was paused with site closures following the response to COVID-19 safety. The focus of this work was to create a robust and modern solution to school and youth group reservations across MNHS. This funding was pivoted to providing support to staffing during the development of the new Artifax version 4 upgrade of our K-12 Scheduling Department.

#### **Curriculum and Teacher Professional** Development, \$93,054

In FY22, these funds were utilized by the Teacher Education and Curriculum Development Team to focus on teacher training and curricular product development. Teacher professional development offerings included sessions geared towards numerous education constituencies.

Funding supported staffing costs for outreach and training sessions provided to college level preservice teachers in social studies teacher preparation programs and college-level social studies methods instructors and professors. Staff time was also covered for the development and facilitation of

professional development geared towards sixth grade teachers using the Northern Lights curriculum and more broadly to K-12 social studies teachers across Minnesota in sessions on various topics. including topics connected to MNHS Press books and authors. In addition to staffing costs for workshop development and facilitation, direct program expenses for the annual History Fest teacher workshop were also funded. Some project expenses for the Ojibwe Shoulder Bag Activity Kit, a popular supplemental curricular product, were also covered by this fund to help keep the product updated and relevant as classroom technology changes.

#### **EXHIBITS**

#### Exhibit Development, \$48,028

This funding supported the Development and Design of a new collections-based exhibit at the Minnesota History Center.

#### Extraordinary Women, Voting Rights Exhibit, \$62,999

This funding supported the development and promotion of the Extraordinary Women exhibit, which opened on March 6, 2021, and featured stories of 22 women who fought for equal rights, including women's right to vote, through political activism, education, and social justice work. Illustrations, multimedia pieces and MNHS collection objects brought these women's stories to life. This exhibit closed January 2, 2022.

#### Historic Fort Snelling, \$167,609

This funding supported exhibit research, development, design, and production for Historic Fort Snelling.

#### Mill City Museum, What makes Minneapolis, Minneapolis?, \$94,128

What Makes Minneapolis, Minneapolis was a series of public programs and exhibits designed to engage visitors in the historical and contemporary identity of the city. The programs were held during the summer and fall of 2021 (July-November) while the museum gallery was temporarily closed. Public programs included: Open Courtyard Family Days; Minneapolis is... Participatory Exhibit; The Theater of Public Policy Performances; Codswallop: Fact vs. Fiction Tour; Soul of the Cities Musical Performance; digital shorts of videos featuring interviews of community members answering the question "What Makes Minneapolis, Minneapolis?" and related questions; Hear Her Stories in recognition of Women's History Month Exhibits and a free exhibit in Mill Commons created in a partnership with the MNHS and Epsilon Rho, Our Past Guides Our Future: Minnesota Omega Men at 100. Additional work included exhibit revisions in the main gallery for the November 2021

reopening including new panels addressing the lives of mill workers, labor history, and the history of the unhoused in Minneapolis. The main gallery's overview of Minneapolis history was updated and renamed What Makes Minneapolis, Minneapolis?

#### Righting a Wrong: Japanese Americans and World War II, \$26,335

This funding supported the Smithsonian touring exhibit Righting a Wrong: Japanese Americans and World War II at the History Center Museum. The exhibition examined the complicated history and impact of Executive Order 9066 that led to the incarceration of Japanese Americans following the attack on Pearl Harbor.

#### Sherlock Holmes: The Exhibition, \$37,172

This funding supported bringing the traveling exhibit Sherlock Holmes: The Exhibition to the Minnesota History Center. The highly creative and interactive exhibit encourages visitors to use critical thinking skills to participate in a process that is similar to the study of history. The exhibit features many items on loan from the Sherlock Holmes Collections at the University of Minnesota Library and was developed by St. Paulbased Exhibits Development Group with support from the Minnesota Bureau of Criminal Apprehension.

#### Sinclair Lewis: 100 Years of Main Street, \$32,883

This funding supported the exhibit Sinclair Lewis: 100 years of Main Street, commemorating the 100th anniversary of the publication of the novel and its promotion. This exhibit, which opened on April 10, 2021 at the Minnesota History Center, re-examined Lewis' legacy and drew parallels between social concerns of his time and today. Multimedia, MNHS collections, and items on loan were featured in the exhibit. The exhibit closed January 2, 2022.

#### Split Rock Lighthouse Historic Site Exhibit, \$18,609

This funding supported exhibit research, development, and design of a new exhibit to be installed in the Split Rock Lighthouse Visitor Center.

#### Then, Now, Wow, \$13,655

This funding supported the reconfiguration of the gallery and relocation of the several elements in the exhibit. New cases were built for the Buffalo artifact and Native American artifacts. The Rondo section of the exhibit was relocated and expanded with new graphics and content.

#### Women of the Big Lake, Misi-zagaa'iganii Ikwewag (Ojibwe), \$61,690

This new exhibit highlights the lives of four women from the Mille Lacs Band that have made significant contributions to their communities as well as American Indian arts and culture in Minnesota. These women have also shared their knowledge and culture with people from all over the world through their roles they played for the Minnesota Historical Society and the Mille Lacs Indian Museum and Trading Post.

#### **FINANCE**

#### Administrative Costs, \$490,564

Administrative costs reflect a portion of the "shared services" costs, such as human resources, payroll, financial accounting, reporting and payment processing, and technology infrastructure and spacerelated costs for those services. These funds also included the cost for benefits and unemployment cost for legacy-funded staff furloughed during MNHS closure due to COVID. These services are necessary to support the day-to-day operation of Legacyfunded programs and partnerships. MNHS works to provide these services at a reasonable cost and these services are directly related to and necessary for MNHS's legacy programs

#### MARKETING AND COMMUNICATIONS

#### History Exhibits and Programming, \$48,201

Legacy funding was used to promote and generate public awareness for MNHS exhibits and related programming for Our Home: Native Minnesota, Sinclair Lewis: 100 Years of Main Street, Extraordinary Women, Art Speaks, Women of the Big Lake, Documenting a Reckoning, and Righting a Wrong.

#### Multimedia, Public Awareness, and Communication \$88,326

Legacy funds supported work to produce video, audio, and other multimedia content for educational, interpretive, and promotional programs across MNHS. In addition, MNHS staff created communication strategies and promotional materials for Legacy projects, programs, and exhibits via media relations, social media, and various marketing tools. This work is aimed at providing access to history to the state's students, teachers, and the general public.

#### HERITAGE PRESERVATION

#### Minnesota Historical Markers, \$56,850

MNHS installed more than 200 historical markers across the state of Minnesota, beginning in the 1930s. The marker program was most active from the 1970s to the 1990s. It has been largely dormant since the early 2000s. The work from this project enabled a project staff person to survey the markers and identify their physical condition and begin to assess the interpretation presented. The project located markers that had been damaged and moved over the years. The final result is a report that will help determine how to handle these resources moving forward.

#### **INCLUSION AND COMMUNITY ENGAGEMENT**

#### Community Programs, \$93,088

Minnesota Historical Society's Community Programs team seeks to build deep, collaborative partnerships with communities of color. The long-term goal is to increase visibility of underrepresented histories that have shaped Minnesota through partnership initiatives. During FY22, Community Programs staff continued to build upon programming with BIPOC community organizations, many of whom were new MNHS partners. The goal is to co-create meaningful programs in order to build trust and deepen collaborative community partnerships so MNHS can better serve the communities.

Over the past year, Community Programs staff has partnered with the Capri Theater and Film Society of Minneapolis St. Paul on the First Thursdays @The Capri film series in North Minneapolis, which includes movie screenings and follow-up conversations with community leaders. Community Programs staff also partnered with local organizations to screen films related to untold BIPOC history, including the film 39 Seconds about John Donaldson, a Black baseball player from Minnesota who played in the early part of the 20th Century. Staff also partnered with Hallie Q. Brown Community Center to support the preservation and sharing of the history of the Rondo Community.

#### Native American Initiatives, \$272,741

The Native American Initiatives (NAI) team is an advocate for Native communities and Native nations at MNHS, serving as a bridge between community needs and MNHS resources, engaging with Native communities and nations throughout the state, and ensuring Native voices, stories, and concerns are addressed in MNHS work. NAI is responsible for the vision and strategy of incorporating Native content throughout the institution.

The NAI team conducted research, provided content, and created programming and engagement opportunities across the state. Examples include American Indian Family Day featuring Indigenous artists, authors, educators, and organizations from the Twin Cities area and region to highlight the resources of MNHS. Guests viewed the Our Home: Native Minnesota exhibit and learned about Native cultures through activities, readings, food, and music throughout the day. NAI also works with the Dakota Community Council and the Indian Advisory Committee, two partnership groups that provide input and guidance on MNHS activities and initiatives related to Minnesota and Native American history.

#### Veterans Relations, \$118,232

This funding supported a staff position tasked with assessing and developing sustained engagement between MNHS and the veteran and military community. This position also provided support for veteran- and military-related programs and exhibits and served as a resource for other MNHS staff. Highlights included:

- Created military-focused outreach in-person and virtual programs for veterans and lifelong learner audiences.
- Supported the World War II Round Table program series at the Minnesota History Center.
- Facilitated tours for active military and veterans groups.
- Hosted military Change of Command ceremonies, including promotion and deployment ceremonies.
- Attended Military Action Group and United Veterans Legislative Council monthly meetings, providing updates on MNHS/Historic Fort Snelling (HFS) military/veteran-specific programs and events to determine where HFS might support other veteran organizations.
- Coordinated donations of military-related program material to MNHS.
- Gathered veteran and military perspectives for the new Historic Fort Snelling visitor center exhibit being developed as part of the site's revitalization.
- Built relationships with current active, reserve, and national guard military components on the still active Fort Snelling military base.
- Planned and implemented a MNHS Veterans Advisory Group, with its first meeting in October
- Planned construction and installation of an early 1900s Army Cavalry saddle exhibit.
- Provided staff training on military-related content at the site and assisted with preparing content documents for staff in preparation for the reopening of the revitalized Historic Fort Snelling.

#### **LIBRARY & ARCHIVES**

#### Collections Projects, \$126,913

Curatorial staff led the work of Native American Collections, providing leadership for the Native American Artist in Residence program, building community relationships with key stakeholders, acquiring materials, and setting collecting priorities for future acquisitions. Curatorial staff also provided key leadership for developing a model of collection review to increase access, improve intellectual and physical control, and maximize use of collections storage spaces in the History Center and off site. Curatorial staff also directed the daily work of four interns who assisted with accessioning backlogged collections in three dimensional objects, Manuscripts, Fine Art, and Publications; collection review, digitization, and other activities related to space, access, and sustainable collecting practices.

#### Digitization of Archival Collections, \$217,605

In FY22, the Collections Digitization teams, encompassing both Archival and the Media team, digitized 81 collections, representing 29.8 cubic feet of materials, and created 1,557 digital objects. A grant from the Council of Library & Information Resources' Recordings at Risk program was awarded in April 2022. One hundred and twenty-seven videotape reels and 86 U-Matic tapes from The Intermedia Arts collection will now be digitized. The Intermedia Arts collection highlights early documentary/guerilla television from the 1970s and 1980s. The videos and tapes cover a variety of topics including community involvement, race and racism, urban and rural issues, agriculture, music and dance, and many more.

The Archival collections digitization team continued scan-on-demand efforts, and in FY22, the team fulfilled 54 scan-on-demand requests, which encompassed 451 folders and 47 volumes. Additionally, Community Digitization efforts began in June 2021 with the digitization of the Gilbert L. and Frederick N. Wilson manuscript collection, and the Gilbert L. Wilson photography collection. A total of 6.0 cubic feet and 1,106 photo prints comprise both collections for a total creation of 832.1 GB of full color, high resolution digital copies. Our continued partnership with the Minnesota Digital Library (MDL) resulted in digitization projects from such contributors as the Saint Paul Public Library to the Hibbing Historical Society that were completed in FY22. All of these endeavors will be continued and expanded upon to reach a greater level of access, connect with communities and develop partnerships, and grow researchers' interests.

#### Digitization of Minnesota's Newspapers, \$421,379

MNHS digitizesMinnesota's current newspapers for preservation and access. Newspapers are deposited with MNHS by publishers throughout Minnesota. In FY22, 518,487 pages of current newspapers were digitized for the years 2008-2022 and 655,399 pages were added for both current and historic newspapers. With this boost in content, the Newspaper Hub reached 4,803,441 pages in June 2022. MNHS is also beginning to fill gaps in its newspapers on microfilm by digitizing from original print issues contributed by publishers, organizations, and individuals with the digitized issues going into the Hub. The Legacy Amendment also ensures Minnesota's newspapers are preserved through a recently launched inhouse program at MNHS: following digitization, the digital files are printed to microfilm for long-term preservation of the newspapers.

#### Library Innovation, \$169,173

The Gale Family Library in the Minnesota History Center is the physical and virtual access point for all MNHS collections and related expertise and resources, and this year the main challenges for Library staff were centered around increasing and improving access to all users—whether onsite or at a distance—while maintaining quality and also ensuring staff/visitor safety.

In FY22 the Library Innovation project work resulted in new and improved systems, processes, and partnerships related to services, instruction, outreach, tools, capacity-building, and researcher empowerment. Specific accomplishments include: partnering with Digitization staff to introduce a working pilot for scan-on-demand services; refining anew request/retrieval infrastructure to encourage self-service advanced requests, as well as enabling better collections security, materials tracking, and data gathering/analysis for materials usage; launching the "MNHS Image and Duplication Support for Community Projects" pilot program; providing new types of distance instruction, including pre-visit orientations for students and community groups; and increasing both onsite researcher capacity and distance services.

In FY22, more than 13,000 non-microfilm items were requested and pulled using the virtual request system; onsite researcher capacity more than quadrupled during the year (to 49 simultaneous researchers); distance services more than doubled over FY21 (to over 4,600); more than 4,400 onsite research visits; and, staff completed more than 7,700 distance reference/research interactions.

# **PARTNER & GREATER MINNESOTA SITES**

# **Outdoor Interpretive Signage, \$30,437**

These funds were used to improve site interpretation by producing eleven, 36" by 22" interpretive signs for Jeffers Petroglyphs (five signs) and Mille Lacs Indian Museum and Trading Post (six signs), plus partial funding for 15 plant identification signs at Mille Lacs Indian Museum and Trading Post.

# **PUBLICATIONS**

# **Book Publications on Women's History in** Minnesota, \$6,970

This fund supported the publication of Daughters of Arraweelo: Stories of Somali Women by Ayaan Adan, which chronicles the experiences of immigrant and first-generation Somali American women in helping to shape the history and culture of Minnesota and of women's roles as community leaders. The fund was used to cover the costs for designing, printing, and promoting the book.

#### Elementary School Book, \$17,285

Funding was used to pay for the development of the Making Minnesota activity book for kids aged seven and up. The funds went toward compensating the author-illustrator team of Patricia Bauer and David Geister and to the freelance editorial and design vendors.

## MNopedia-Digital Encyclopedia of Minnesota History, \$69,295

MNopedia is MNHS's free online encyclopedia of Minnesota history. MNHS published nearly 30 new MNopedia articles during FY22, covering a wide variety of topics, ranging from biographies of influential Minnesotans like George Hormel and suffragist Bertha Moller, to monuments like the State Capitol Building and Grand Portage National Monument, and to cultural institutions like Zenon Dance Company and Penumbra Theatre. All MNopedia content was curated and fact-checked by the program's editor.

#### **Urban Biography Series, \$5,158**

These funds were used to support the publication of Rochester: An Urban Biography, the fourth book in the series of histories of Minnesota cities. The funds supported the editorial, design, and layout of the book.

# INTERPRETATIVE PROGRAMS

#### Interpreter Training, \$128,617

This project involved researching, planning, and piloting a framework for training interpreters across the MNHS historic sites and museums. Frontline staff. especially interpreters, are key to engaging MNHS visitors. In FY22, 100 staff members received 520 hours of training. The Native Nations and Tensions of Historical Interpretation training were successfully launched.

#### Statewide Program Support, \$127,066

This initiative supported the development, testing, implementation, and evaluation of interpretive programs and experiences across the statewide network of MNHS historic sites and museums. Several sites completed a framework outlining its interpretation and themes, which will serve as road maps to assist staff in long-term planning. Work is underway to build programmatic consistency across the MNHS sites network. In FY22, two interpretive frameworks were completed and another three were launched.

#### **RESEARCH & EVALUATION**

#### Evaluation, \$103,166

Evaluation staff provided technical assistance and support to evaluate projects and programs. Wilder Research consulted on strategy and direction for data informed decision-making and building a culture of evaluation. MNHS conducted evaluative work by:

- Participating in the Measures of Museum Social Impact, a national survey of museum social impact.
- Participating in the American Alliance of Museum's Annual Study of Museum Goers, to better understand visitor motivations and provide cutting-edge research to the entire museum field.
- Conducting evaluation work for Jeffers Petroglyphs, Historic Forestville, and James J. Hill House interpretive framework processes.
- Supporting Learning Initiatives Division and K12 logic model development.
- Supporting K-12 Digital team and Lifelong Learning Digital Access team with logic models, surveys for Zoom and Facebook Live public programs.
- Conducting a General Visitor Survey and K12 Field Trip surveys with revised and updated outcomes.
- Conducting an Art Speaks exhibit evaluation at Minnesota History Center Museum.
- Conducting a public program surveys as sites reopened and public programs re-launched after the pandemic.

#### Research, \$227,191

The Research Department generated five annotated research context report drafts for sites and exhibits program developers and developed a digital LGBTQ+ walking tour in partnership with TC Pride. Staff participated in approximately 12 media interviews. Under the lead of the Director of Research, the cross departmental Historic Fort Snelling Exhibit Design team developed a revised concept and schematic plan for the Historic Fort Snelling exhibit opening in the spring of 2023. Research staff contributed to four MNopedia articles, completed a comprehensive content review of the MNHS Roadside Interpretive Markers, and began work on a comprehensive revision of all MNHS Sites Interpretive Signs. Research Department staff also contributed content as members of the Split Rock Lighthouse and exhibit development teams.

#### Oral History Projects, \$110,912

The Oral History Office completed several projects: Women in Sports, Computer History, Veterans, and Split Rock Lighthouse.

# **VOLUNTEER SERVICES** AND INTERNS

#### College Internship Program, \$205,369

The college internship program provides an opportunity for students to work with experts in the museum field and gain professional experience. MNHS served 53 college interns with a total of 8,993 hours. MNHS made a commitment to pay all interns, providing equity to all. MNHS continues to receive a large number of applications, between 100 to 300 per semester. In addition to operating the college internship program, the staff paid through Legacy funds provided administration, onboarding, seminar planning and implementation, recordkeeping, and payroll functions. The staff also administered two additional programs, the Native American Undergraduate Museum Fellows program (NAUMF) and the Heritage Studies Public History program, which had 20 interns total this fiscal year.

# REPORT OF HISTORY PARTNERSHIPS



Support from the Legacy Amendment's Arts and Cultural Heritage Fund has resulted in partnerships between the Minnesota Historical Society and more than 20 organizations.

It also supports the Heritage Partnership Program that works to build the capacity of two or more independent organizations to preserve and enhance access to Minnesota's history and cultural resources, by supporting the creation and development of sustainable, history-based partnerships throughout the state.

This Legacy report presents a look back on how funds were used for History Partnerships in FY22

Appropriations Language-History Partnerships: \$2,450,000 the first year and \$2,550,000 the second year are for history partnerships involving multiple organizations, which may include the Minnesota Historical Society, to preserve and enhance access to Minnesota's history and cultural heritage in all regions of the state.

# **EDUCATION AND PROGRAMMING**

#### History Day Partnerships, \$158,654

These funds enabled MNHS staff to coordinate the National History Day in Minnesota program which reaches approximately 27,000 students in grades 6-12 annually. The program emphasizes engaging students from diverse backgrounds, expanding statewide reach, building college readiness skills, and strengthening the mentoring skills of college students. MNHS staff worked with program partners at public and academic libraries, schools districts, and higher education institutions to pivot programming to be done virtually and in person for approximately 17,000 student participants. Throughout the fall, teacher workshops were hosted online and attended by educators. Classroom presentations were both virtually and in person, depending upon visitor policies at the requested school. The statewide mentor program provided in-person and virtual project feedback, continuing to reach more schools geographically than ever before. Library events were conducted online and allowed for individualized project help and chat support from librarians. The MNHS chat service continued to provide direct-to-student support throughout the school year. Competitions were held virtually at the regional and state levels, culminating with 65 Minnesota students representing our state at the Virtual National History Day Contest, with one project winning a silver medal, one bronze medal, other top finishers, and one special award winner.

#### North Star Story Maps, \$48,000

North Star Story Map is a Legacy Partnership between the American Institute of Architects (AIA) Minnesota, Mill City Museum, and the Minnesota Historical Society to create a digital storytelling platform. The goal is to connect the people of Minnesota to their built environment, recognizing that every built space holds memories and meaning of different kinds for different people. North Star Story Map will bring forward the stories of the places of Minnesota that matter to its people. The project is complete and will launch in 2023.

#### State Fair Programming, \$29,207

These funds supported programming at the Minnesota State Fair. MNHS worked with the Minnesota State Fair to update and produce the self-guided walking tour and the "History-on-a-Schtick" performance. The performance ran twice a day, each day, for the duration of the 2022 State Fair.

# **FINANCE**

#### Administrative Costs, \$70,938

MNHS works to minimize administrative costs while adhering to the legislative mandate that costs be "directly related to and necessary for a specific appropriation." In order to implement its Arts and Cultural Heritage Fund programs, these funds support delivery of Legacy partnership programs.

#### HERITAGE PRESERVATION

#### Minnesota Main Street Partnership, \$103,139

This partnership provides ongoing technical assistance, packaged in-house preservation training and services, counsel for potential Main Street programs, promotion for Minnesota Main Street, peerlearning and networking opportunities for designated Main Street, training for new local directors and volunteers, quarterly data collection, and toolkits. As of the end of FY22, Minnesota had 12 Designated Main Street Communities: Albert Lea, Faribault, Lincoln Park (Duluth), Mankato, Northfield, Olivia, Owatonna, Red Wing, Shakopee, Wabasha, Willmar, and Winona. Rethos' successful Main Street conference in Faribault was enhanced with MNHS programming and supplemental funding sources such as the Paul Bruhn Revitalization grant will help ensure that there are additional options for the Minnesota Main Street community in the upcoming year.

#### Preservation Education, \$85,296

Rethos Education seeks to demystify many aspects of historic homes for the people of Minnesota. They offer hands-on classes on common small repairs, such as plaster, toilets, and windows which offer homeowners to affordably improve their houses. Other courses, focused on real estate agents and home buyers, spread knowledge about historic houses, neighborhoods, and real estate practices. By increasing understanding and appreciation of our historic housing stock, Rethos is reinforcing the goals of Historic Preservation and MNHS.

#### **Building Capacity of History Professionals, \$54,000**

This partnership develops the capacity of history professionals across the state to better serve local communities and the 500+ organizations in Minnesota's history community. Through this partnership, the Minnesota Alliance of Local History Museums (MALHM) provides best practices, training opportunities, resources, and networking opportunities for local history practitioners. MALHM also works to create a reliable collections management system for local organizations with the capacity for online searching across contributing organizations. The cornerstone of this partnership is the administration of an annual conference that trains professionals, volunteers, and board members alike in best practices of history and museum work. In 2022, MALHM was able to return to an in-person conference. Held over two days in Alexandria, the conference offered 21 sessions and attracted 169 attendees and 13 vendors.

#### Historic Preservation Corps, \$300,000

This program provides training for young adults in historic preservation techniques while addressing the preservation needs of the state's historic structures and landscapes. The partnership between Northern Bedrock Historic Preservation Corps and MNHS increases the viability of a historic preservation activity by building on a conservation corps model. During the 2021 field season, Northern Bedrock Historic Preservation Corps completed 11,377 hours on service projects helping to maintain and repair historic structures and cemeteries with 11 project hosts in Detroit Lakes, the Superior National Forest, Stillwater, Isabella, and more.

# **INCLUSION AND COMMUNITY ENGAGEMENT**

## Diversity Outreach, \$264,555

This funding supported initiatives designed to build engagement between MNHS and Minnesota's diverse communities. This work includes meeting with members of different cultural communities for the purpose of building relationships. It also includes learning about and developing relationships with community based organizations, and exploring partnership opportunities. Additionally, this funding supports different projects and programs within MNHS including community voices.

# HERITAGE PRESERVATION PARTNERSHIP PROGRAM GRANTS

#### **Meeting Educational Standards in Historic Buildings**, \$24,909

Partners: Minnesota's Historic Northwest, Clearwater County Historical Society, Kittson County History Center/Museum. Norman County Historical and Genealogy Society, Polk County Historical Society, and East Polk Heritage Center

This partnership aims to develop programs to better utilize the historic buildings within Minnesota's Historic Northwest museum campuses. The Education Partnership was formed out of Minnesota's Historic Northwest consortium, a more extensive partnership of county museums and local organizations in the twelve-county area in NW Minnesota. It was created after discussing how to better use and promote historic buildings for student visits. Several members within the Historic Northwest have expressed interest in participating, and after discussion, five partners agreed to move forward.

The purpose is to research the Minnesota K-12 Academic Standard and create lesson plans accordingly, using the physical buildings as the base of the lesson plan. The partners will establish critical points that can be taught by museum staff or volunteers at each location featuring historic buildings as the focus in the lesson plans. The deliverables are 1) a brochure that can be used for marketing the program to teachers and homeschool groups, and 2) A booklet/binder with lesson plans that can be used at each site/building corresponding to the Standard. This program will create a better student experience at each partners museum. Once completed, these programs could be adapted to other regional and statewide museums if requested.

# Traditional Cultural Property (TCP) Evaluation for National Register Eligibility, \$188,900

Partners: Sherburne County, Mille Lacs Band of Ojibwe Indians, Upper Sioux Community, and Lower Sioux Indian Community

Sherburne County Parks & Recreation Department (SCPRD) initiated a partnership to evaluate a property with sensitive cultural resources in a way that respects tribal values. The property boundary was the Ojibwe and Dakota ceded territories between 1830 and 1889. This grant will assist the partners in including the voice of both cultures in the process and is essential to meeting our objectives and avoiding regrettable consequences.

The partners' tasks are to conduct informational interviews, a Geophysical Survey, and a Tribal Culture Survey. The work will also include performing traditional ceremonies, conducting site visits to collect tribal relatives' recommendations, and training the next generation to be Tribal Cultural Specialists. The Phase I archaeological survey will be reviewed to determine any information gaps. The informational interviews will be transcribed, and summaries will be included in the report to address the National Register criteria for evaluating the property and its connection to the broader cultural landscape. Completing these tasks before any further park development work will ensure that partners continue to build and maintain relationships and enhance trust and cross-cultural understanding.

# Cook County Historical Societies Alliance Study, \$38,000

Partners: Cook County Historical Society (CCHS), Gunflint Trail Historical Society (GTHS), Schroeder Area Historical Society (SAHS), and Tofte Historical Society (THS)

The four historical societies in Cook County are collaborating to hire a facilitator to conduct a study to report on the viability of forming an alliance or another form of shared governance. The partners are Cook County Historical Society (CCHS), founded in 1924, which operates the Cook County History Museum, Johnson Heritage Post Art Gallery, St. Francis Xavier Chippewa City Church, Bally Blacksmith Shop, and a 1930s fish house replica with the 35 foot fishing tug Nee-Gee; Gunflint Trail Historical Society (GTHS), founded in 2005, which operates the Chik-Wauk Museum & Nature Center; Schroeder Area Historical Society (SAHS), founded in 1996, which operates the Cross River Heritage Center & Museum; and Tofte Historical Society (THS), founded in 1992, which operates the North Shore Commercial Fishing Museum. All four Cook County historical societies have distinct and similar missions, strategic plans, operations, and historical collections.

The specific purpose of the partnership program is to study and learn how to work more effectively together, take collective action to solve current shortcomings, and sustainably fulfill the organizations' missions. The program's scope includes gathering information, analyzing input, and developing a preferred model of program integration, such as an alliance, consolidation, merger, or another form of governance. Areas include each organization's board, staff, volunteers, membership, finances, policies, facilities, mission, and long-term plans. An outcome is to identify a possible ideal structure of governance to serve the four partner organizations and society best. In addition, the partners may learn ways to share resources. services, or the workforce.

# The 1980s Farm Crisis in West Central Minnesota: Interpretive Plan, \$39,250

Partners: West Central Minnesota Historical Association (WCMHA), Chippewa County Historical Society, Kandiyohi County Historical Society, Lac Qui Parle County Historical Society, Lyon County Historical Society, Renville County Historical Society, Swift County Historical Society, and Yellow Medicine County Historical Society

The West Central Minnesota Historical Association (WCMHA) is a collaboration of the county and area historical societies and museums of 10 counties in West Central Minnesota. The counties included are Big Stone, Chippewa, Kandiyohi, Lac Qui Parle, Lincoln, Lyon, Redwood, Renville, Swift, and Yellow Medicine. This collaboration aims to promote and tell the history of West Central Minnesota. Each county has its unique story, but many of the themes and subjects of each country's history overlap.

At a WCMHA meeting, attendees felt that an Interpretive Plan revolving around the 1980s Farm Crisis would be the logical first step to exploring how WCMHA can share their local stories collaboratively and on a regional level. The process for the Interpretive Plan will follow the Standards and Practices put forward by the National Association of Interpretation. The benchmark practices include Audience Analysis, Evaluation, Management Objectives, Marketing Factors, Message Elements, Partnerships, Stakeholder Involvement, and Visitor Experience. The ultimate goal of the Interpretive Plan is to put audiences first. Therefore, the final Interpretive Plan will be audience focused by drawing on what appeals to our audience regarding cultural heritage experiences.

#### **Archaeomagnetic Dating of Minnesota Ceramic** Artifacts, \$72,915

Partners: Regents of the University of Minnesota (Department of Earth and Environmental Sciences). and the Science Museum of Minnesota

The University of Minnesota (UMN) and the Science Museum of Minnesota (SMM) have a common interest in developing archaeomagnetism in Minnesota. Archaeomagnetism is an alternative dating technique that has been used successfully for decades at archaeological sites in Europe and the Middle East but has not yet been widely employed in the United States and has not been used in Minnesota. This technique is relevant to materials that have previously experienced heating, including ceramics, fire-cracked rocks, and burnt soils. The scientific approach for this dating technique is already fully developed in peer-reviewed literature, with origins in the 1950s. In some countries, such as the United Kingdom, it is a standard method used by national heritage agencies. It offers a ripe opportunity to expand the range of dating tools available for archaeological materials in Minnesota.

The specific goals are (1) to conduct an interdisciplinary pilot study on a population of already deaccessioned ceramic sherds from SMM to determine which ceramic materials are most likely to provide robust data for what we will call the "Minnesota Archaeomagnetic Reference Curve" (MARC), and, applying those results, (2) to coordinate between UMN and SMM to select additional stylistically diagnostic ceramic sherds in the SMM archaeological collection that host carbonrich residues suitable for radiocarbon analyses AND are composed of the material identified in objective #1 as being well-suited for obtaining reliable magnetic data for the MARC. The sherds identified in objective #2 are intended to be analyzed during a future phase of research, during which the MARC will be developed and refined. This Partnership Program is the first of what will hopefully be a multi-year effort to establish a world-class archaeomagnetic reference curve tailored to Minnesota that can be used to date heat-treated archaeological materials.

# **VOLUNTEER AND INTERNSHIPS**

## **Heritage Studies and Public History Graduate** Program, \$45,717

Launched in fall 2017, the Heritage Studies and Public History graduate program is a partnership between MNHS and the University of Minnesota. This program takes advantage of Minnesota Historical Society's extensive resources and expertise to offer unparalleled training in the theory and methods of heritage and public history studies at the graduate

This two-year program offers a master's degree in one of three cultural heritage tracks: historical archaeology, historic preservation, and public history. Students in the program gain technical knowledge about the field while also learning how to address issues of inclusion and equity within the practice. Through a number of field experiences, students also learn to work collaboratively with community agencies and organizations to enhance historical narratives or develop cultural resources that ensure more equitable practices. Students complete either an externship with another organization or internship with MNHS for a semester. There were 10 Heritage Studies internships totaling 2,634 hours.


# REPORT OF OTHER STATEWIDE INITIATIVES



In addition to grants, programs, and partnerships, the Minnesota Legislature has appropriated funding from the Legacy Amendment's Arts and Cultural Heritage Fund to support initiatives for history, including the Statewide Survey of Historical and Archaeological Sites, Minnesota Digital Library, and Additional Projects. These initiatives support statewide efforts to preserve and share history for future generations.

# STATEWIDE SURVEY OF HISTORICAL AND ARCHAEOLOGICAL SITES



The Statewide Survey of Historical and Archaeological Sites provides opportunities to expand our understanding of these sites statewide. Projects are defined by an oversight board and are conducted through competitive-bid contracts. So far three major topics have been addressed by the survey: identification and protection of sensitive historic and archaeological resources; geographic surveys of poorly known areas of Minnesota; and thematic studies of poorly understood historic contexts.

To date more than 30 projects have been conducted, which have expanded the number of documented historic and archaeological sites in Minnesota, increased our understanding of where such sites are likely to be located, and illuminated cultural traditions, lifeways, and technologies dating to the earliest human occupations of the state.

Appropriations Language-Statewide Survey of Historical and Archaeological Sites: \$475,000 the first year and \$525,000 the second year are for one or more contracts to be competitively awarded to conduct statewide surveys or investigations of Minnesota's sites of historical, archaeological, and cultural significance. Results of the surveys or investigations must be published in a searchable form and available to the public cost-free. The Minnesota Historical Society, the Office of the State Archaeologist, the Indian Affairs Council, and the State Historic Preservation Office must each appoint a representative to an oversight board to select contractors and direct the conduct of the surveys or investigations. The oversight board must consult with the Department of Transportation and Department of Natural Resources.

## Assessing the Archaeological Potential of Two Southeastern Minnesota Coulee (Ravine) Sites

Now complete, the objective of this project was to better understand the archaeological potential of the Dutchman Coulee (21WB0055) and King Coulee (21WB0056) archaeological sites in Wabasha County. The multicomponent habitation sites date to Archaic through Mississippian/Oneota occupations, with most cultural material recovered from below the buried surface of a paleosol capped by post-Contact sediment and fill. The King Coulee site produced evidence of the earliest known domesticated plants in the upper Midwest, specifically domesticated squash (Cucurbita Pepo), and is listed in the National Register of Historic Places. This was designed to provide significant new information about the sites, most importantly determining the vertical and horizontal extent of the King Coulee site and the absolute ages of the cultural horizons at both sites. The project conducted a literature review and radiocarbon analysis for both sites and conducted geomorphological coring at the King Coulee site.

#### An Archaeological Survey of Freeborn County, Minnesota

The primary objective of this study was to expand the collective knowledge concerning the location and character of precontact and contactperiod archaeological sites in Freeborn County. The investigations surveyed 2,603.09 acres and documented 37 previously unrecorded archeological properties in the county. One previously recorded site was also revisited during the course of the study and four reported localities were assigned alpha designations. The study also included a geomorphological investigation, focusing on the examination of localities in the Shell Rock River valley, assessment of the properties of mapped soils in these settings, and the modeling of surface and buried archeological site potential there. The geomorphological evaluation afforded a clearer view of regional landform development and resulted in the identification of a paleosol in the T-1 terrace fill of the Shell Rock River valley that has elevated potential for harboring precontact archeology associated with the Late Archaic through Woodland periods. These data were then incorporated into a larger, countywide narrative probability model for precontact archeological sites in Freeborn County. Results from the current study were also evaluated via Minnesota's existing site probability model, MnModel.

#### Minnesota State Capitol Area, Part 1: Planning and **Context Development**

A cultural resources literature review, archaeological assessment, and historic context report development was completed for the Minnesota State Capitol Area Planning & Context Development project located within the Minnesota State Capitol Area in St. Paul. The study area includes the entire Minnesota State Capitol Area, which covers 344.4 acres. As the final stage of this project, the literature review and archaeological assessment also informed a research design. Together, these studies will inform potential future studies, including architectural history and archaeological investigations, in order to identify buildings, structures, objects, sites, landscapes, and districts that may be eligible for listing in the National Register of Historic Places.

## Archaeological Survey of Two Counties in the Red **River Valley of Minnesota**

The primary focus of the archaeological survey for Kittson and Wilkin Counties was to locate new unrecorded archaeological sites to expand on what little is known about precontact occupation within those counties, focusing on areas of higher potential for archaeological sites and to sample diverse environmental zones. The archaeological investigation included a background literature review within and surrounding the area along with an approximate 4,686-acre intensive survey (2,757 acres in Kittson County and 1,929 acres in Wilkin County). Five previously recorded cultural resources and 69 newly recorded cultural resources were observed and recorded during the archaeological survey. All sites identified in the survey were given formal sites numbers, and all sites revisited were given updated site forms.

#### **Inventorying Unrecorded Historic Period Indian Cemeteries in Minnesota**

This ongoing project conducts an intensive records search to complete a preliminary database of unrecorded historic period Indian cemeteries and burials in Minnesota. The purposes are to summarize what is known about unrecorded historic period Indian cemeteries, to add new information about unrecorded historic period Indian cemeteries to an existing cemeteries database, and to develop a research design for a field survey to find currently uninventoried unrecorded Indian historic period cemeteries. This will add to an existing database started in 2011 and support a comprehensive database of Minnesota cemeteries, maintained by the appropriate agencies.

# **MINNESOTA DIGITAL LIBRARY**



The Minnesota Digital Library (MDL) supports the discovery, use, and preservation of the rich historical resources of the state's libraries, archives, museums, historical societies, and other cultural heritage organizations through digitization and online access. In FY22 MDL increased partnerships to 203 organizations, each contributing primary source materials to the MDL's searchable portal at www.mndigital.org. This portal offers access to more than 317,000 photos, maps, documents, and more. More than 187,300 people visited the MDL website with many thousands more engaging through other online channels. Additional MDL work focused on outreach and professional development opportunities to local history organizations through both virtual and in-person education and training, hosting workshops, conferences and small group sessions.

**Appropriations Language-Minnesota Digital Library:** \$368,000 the first year and \$382,000 the second year are for a digital library project to preserve, digitize, and share Minnesota images, documents, and historical materials. The Minnesota Historical Society must cooperate with the Minitex interlibrary loan system and must jointly share this appropriation for these purposes.
