Minnesota Statutes 1986, Chapter 473, amended by Minnesota Statutes 1988, Chapter 664 state that "The Commission need not prepare an assessment for an airport when the Capital Improvement Program and Plan for the airport has not changed from the one adopted the previous year or when the changes in the program and plan will have only trivial environmental effects".

At the St. Paul Downtown, Crystal, Anoka County-Blaine and Airlake Airports, there has been either no change from plans adopted in the previous year(s) or projects that are characteristic of one or more of the following:

- A rehabilitation project that does not physically alter the original size
- An electrical or mechanical modification that monitors or indicates existing conditions
- A structural, mechanical or electrical modification or airport support function that does not increase size or passenger capacity
- A project that has been previously addressed in an Environmental Assessment Worksheet (EAW) or other official environmental documentation and no change in scope is expected

Therefore, an Assessment of Environmental Effects will not be prepared for these airports this year.
