## **DNR CWD Spending Legislative Report**

This report fulfills the quarterly reporting requirement of Minnesota Session Law 2021, 1st Special Session, Chapter 6, Article 1, Section 3, Subdivision 6(b) "\$1,529,000 the first year and \$2,532,000 the second year are from the general fund and \$2,425,000 the first year and \$2,425,000 the second year are from the game and fish fund for planning for and emergency response to disease outbreaks in wildlife. Of the game and fish fund appropriation, \$750,000 the first year and \$750,000 the second year are from the heritage enhancement account and are onetime (Table 1). The commissioner and the Board of Animal Health must each submit quarterly reports on chronic wasting disease activities funded in this biennium to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over environment and natural resources and agriculture."

## CWD Activities, January 1 – March 31, 2023

The Minnesota Department of Natural Resources (DNR) spent approximately \$770,000 during the third quarter of FY23 on Chronic Wasting Disease (CWD)-related activities (Figure 1, Table 2,3). This spending includes staff salary for CWD surveillance and management work, contract payments for student labor at fall check stations, invoices for fall dumpsters, and fleet costs, diagnostic testing, and agency culling activities. New activities that occurred this past quarter focused on agency culling activities in southeast and north central Minnesota. A detailed list of activities include:

- From Jan 1 to March 31, a total of 952 samples were collected and submitted for CWD testing:
  - Opportunistic sampling (i.e., 45 vehicle-killed deer, 7 sick deer, 11 found dead, 14 depredation permits, and 6 other): 83 samples, collected statewide; two of these deer were CWD-positive.
  - o Targeted sampling: 689 samples; 20 of these deer were CWD-positive.
- The 22 new cases of CWD were detected in wild deer during this quarter. This included 1 found dead deer in DPA 604 and 1 reported sick deer in DPA 343. The remainder were all deer harvested through agency culling efforts to reduce local prevalence of CWD where it was recently found.




Figure 3. Locations of deer culled during targeted efforts by USDA-WS in south metro areas of Minnesota, winter 2023.




Figure 4. Locations of deer culled during targeted efforts by USDA-WS in Grand Rapids area of Minnesota, winter 2023.

- DNR contracted with USDA-Wildlife Services for \$425,000 to conduct targeted culling in management zones in southeast MN and within the city limits of Grand Rapids, MN. Culling efforts took place from January-March 2023; 627 deer were removed, 20 tested CWD-positive (Table 1, Figure 2,3,4). At the end of the project, a total of 73 private landowners provided access to 6,196 private acres from within focus areas in the southeast and south metro areas combined. All culled deer went to the Share the Harvest public donation program after receiving a not-detected test result.
- DNR staff met with tribal biologists to discuss results of fall CWD sampling efforts in areas near tribal lands. Federal funding was available to support collection and testing efforts for tribal hunters and these efforts were coordinated through University of Minnesota staff. Approximately 300 samples were collected by tribes in the northwest; all were not detected for CWD.

Planning efforts for fall 2023 CWD surveillance began, as staff summarized and analyzed results from fall 2022 efforts. The footprint of CWD has expanded in Minnesota, with the discovery of 2 infected deer in DPA 184, which will create a new CWD management zone for fall 2023. However, the disease was also not found after 3 years of surveillance in the east central and west central surveillance zones; thus, testing will be discontinued. Discussions are underway to expand testing opportunities statewide by fall 2023 by increasing participation in the Partner Sampling Program and hunter mail-in kit program.

Figure 1. Quarterly spending activity of the Chronic Wasting Disease Appropriation Allocation FY22-23.


