SOUTHWEST MINNESOTA ARTS AND HUMANITIES COUNCIL FINAL REPORT TO THE MINNESOTA STATE ARTS BOARD ON FISCAL YEAR 1997

OVERVIEW: All stated goals using State of Minnesota Arts Funds were completed or exceeded, with no exceptions. Of SMAHC's goals using other funds, nearly all were completed, with one notable exception. Work on the SMAHC Artists Directory was again postponed, due to failure of grant applications to foundations for support and failure to secure intern position through outside support mechanisms.
