#### INTRODUCTION

1

The Metropolitan Livable Communities Act (LCA), requires the Metropolitan Council to report which municipalities elected to participate and which did not elect to participate in the local housing incentive account program by February 1, of each year. (Minnesota Statutes 473.254, section 5, subsection 9)

#### **PARTICIPATION IN 1997**

The LCA supports regional *Blueprint* policies which call for the expansion of the opportunities for affordable and life-cycle housing throughout the region, creative planning that links jobs, transportation and housing, and revitalization of the region's older cities. Communities within the seven county area that participate in the local housing incentives account program may receive grants or loans from the three funds in the LCA. These funds are the tax base revitalization account, livable communities demonstration account and the local housing incentives account. Only participants may apply for and receive grants from the polluted sites clean-up program administered by the Minnesota Department of Trade and Economic Development. In addition, the Council "shall give consideration to a municipality's participation," when making discretionary funding decisions such as federal ISTEA funding.

During 1996, 97 communities passed resolutions to participate in the LCA's local housing incentives account in 1997. Of these 97 communities, six were cities electing to participate in the LCA for the first time. These six cities are Champlin, Circle Pines, Excelsior, Mound, Rogers and St. Bonifacius. Also in 1996, however, five communities chose not to renew their participation in the housing incentives account by not preparing a resolution of participation. These five communities are Deephaven, Forest Lake, Ham Lake, Victoria and Young America Township. In addition, as of the first of the year, two LCA participating cities -- Norwood and Young America merged to become one city. This leaves participation in the housing incentives account at the same number of communities in 1997 as participated in 1996, 97.


