### RE: Semi-Annual Appointment Report, July 1 – December 31, 2022

Twice a year, MMB provides an Appointment Report that outlines the numbers of appointments that Minnesota state agencies made during the reporting period. This report fulfills the requirements outlined in Minnesota Statutes 43A.04, Subd. 7.

#### Takeaways from the report

- Minnesota state agencies made 5,842 appointments across all appointment categories between July 1 – December 31, 2022.
- This represents a 18 percent increase (or 899) in total appointments from the same reporting period last year.
- We also realized a 30 percent increase (or 758) in Open Competitive appointments from the same reporting period last year.

This number of appointments does not reflect the number of new employees. One employee may have several different appointments throughout the reporting period.
