## Background

The Medical Education and Research Costs (MERC) Program was established in 1996 as a way of recognizing the need for, and value of, investing in medical education to ensure a well-training health care workforce and high-quality health care system for all Minnesotans. The MERC program was one significant effort to help balance the costs of clinical training so those facilities that provided this necessary training were not forced to compete at a disadvantage with those health systems that did not. The MERC program provides support and funding for these teaching activities under the guidance of a committee of stakeholders and medical education professionals.

The Commissioner of Health has been responsible for administering the MERC program since 1998. Since its first year of funding in 1997, the MERC program has distributed nearly \$1.2 billion to hospitals, clinics, and other clinical training facilities throughout Minnesota to help cover the cost of training health professionals.

Grants are determined through a distribution formula established in Minnesota Statutes, section 62J.692, and approved by the Centers for Medicare and Medicaid (CMS) through an 1115 Waiver. The current formula calculates the total Medicaid revenue pool across all eligible sites and then determines the percentage of total Medicaid revenue associated with each clinical training facility. This percentage is then applied to the amount of available funding to calculate each facility's grant. The grants to clinical training facilities cannot exceed the facility's reported clinical training expenditures, nor can they exceed the 95th percentile grant per FTE cap. Facilities must provide at least 0.1 FTE (208 clinical hours) of training. Facilities that would receive grants of less than \$5,000 do not qualify for MERC funding, and their funding is redistributed among those that qualify.

Debate over the formula has focused on whether the program should be designed to support clinical training wherever it occurs or focus on supporting clinical training in facilities that have a larger share of the Medicaid business. Medicaid funds have been the major source of the program's appropriation, which, for the past ten years, has led to primarily supporting those facilities that serve a larger share of patients using Medicaid.

In 2021, CMS did not renew the 1115 waiver that authorized the distribution formula for the MERC program, and gave a temporary extension through 2022. In 2023, the Legislature approved a new method of distribution for the MERC program, and the Department of Human Services is in the process of seeking approval from CMS for the distributions that will occur in future years.

## Reporting

Throughout this report, the current funding year reflects state fiscal year 2023; the 'data year' reflects fiscal year 2021 clinical training, which is the reference year for data in the MERC application. Numbers are rounded for reporting purposes.

## Funding

The MERC grant was funded in state fiscal year 2023 through a carve-out from the Prepaid Medical Assistance Program (PMAP) rates, an appropriation from Minnesota's cigarette tax and federal matching funds, and appropriations from the state General Fund and the Health Care Access Fund. The distribution to clinical training facilities totaled \$59,127,000.

\* A maximum of \$150,000 of the funds dedicated to the commissioner under section <u>297F.10</u>, <u>subdivision 1</u> (<u>https://www.revisor.mn.gov/statutes/cite/297F.10</u>) may be used by the commissioner for administrative expenses associated with implementing the MERC program.

## **Application Process**

Grant applications for clinical training in Minnesota are submitted to the Minnesota Department of Health by sponsoring institutions. These sponsoring institutions coordinate the grant process on behalf of their accredited teaching programs and the facilities providing clinical training for the program's trainees.

## **Applicants and Grant Recipients**

## **Sponsoring Institutions**

In total, 27 sponsoring institutions submitted grant applications. These sponsoring institutions were applying on behalf of 335 teaching programs whose students/residents received clinical training in Minnesota during the teaching programs' 2021 fiscal year.

The grant payments listed in Table 2 were distributed in April 2023. Since the grant was designed to offset costs at clinical training facilities, not the sponsoring institution, the sponsoring institutions are required to pass available funds on to eligible facilities where the students or residents clinical training was provided within 60 days of receipt. Many entities in Minnesota are both sponsoring institutions and training sites.

## **Provider Types**

Fifteen provider types are included in MERC legislation. During the period covered by this report, three did not apply: community health workers, dental therapists, and doctors of chiropractic programs.

## **Training Facility Types**

Training takes place in a wide variety of settings. The formula's initial weight on Medicaid plays a significant role in the outcome. Medical Assistance and Prepaid Medical Assistance revenue is used to calculate initial funding at the facility level, the cost associated with clinical training and number of trainees are used to determine the funding share attributed to a trainee type and teaching program. Most notably this is seen in the grant to dental facilities. While dental clinics host a significant number of trainees, the grant per FTE is significantly lower than other facility types who have a higher Medicaid volume.









## County

The bulk of clinical training has historically occurred in Hennepin County and Olmsted County while the largest grants are paid to facilities in Hennepin County and Ramsey County. The outcome typically coincides with the county's share of Medicaid. The figures below compare the relative percent of trainees, expenditures, MA/PMAP reimbursement, and MERC funding.

## **Clinical Training Facilities**

MDH received applications from 27 sponsoring institutions that applied on behalf of their 335 teaching programs and the facilities where their students or residents received clinical training. Those applications included funding requests for 547 distinct clinical training facilities that hosted trainees from multiple teaching disciplines.

To qualify for MERC funding, a training facility must have a minimum of 0.1 FTE trainees, submit clinical training expenditures that meet or exceed \$5,000 (the minimum grant amount), and have Medical Assistance revenue during the training year. A total of 143 distinct facilities did not meet these initial qualifications, most (89) because they did not meet the FTE minimum.

Of the 404 training facilities that met the initial qualifications, 358 received grants. The other 46 facilities did not qualify under the formula, which determined their grant amount was less than the \$5,000 minimum facility grant. Because the formula is based on Medical Assistance revenue, facilities that do not meet the minimum grant amount typically have a smaller share of Medical Assistance revenue revenue compared to other grant applicants.

In 2021, MERC training sites provided clinical training to just over 3,166 FTE trainees. Facilities hosting the trainees can change from year to year; some facilities that hosted trainees in 2021 did not host trainees in the prior training period. Table 6 outlines the total number of facilities that qualified and FTEs within the specific grant range.

A total of 189 sites did not qualify for a grant due to either the \$5,000 minimum or not meeting the initial qualifications.

Table 7 includes the top 25 grant recipients, who together received nearly 80 percent of the total grant and hosted over 84 percent of the trainees.

A relatively small number of clinical training sites are responsible for most of the training that is supported by MERC funding. Twenty facilities hosted at least 10 FTEs. These facilities represented just under 90 percent of the qualifying FTEs trained in Minnesota and received just under 74 percent of the available MERC funds. Six facilities hosted more than 150 FTEs, accounting for just over 77 percent of the qualifying trainees in Minnesota and receiving just under 36 percent of the available funding. Because grants are based on relative Medicaid volume, rather than on number of FTE trainees, the grant per FTE trainee varies widely across facilities.

## **Training Expenditures**

The MERC formula caps the amount of funding an organization can receive to ensure that grants do not exceed the organization's costs of providing clinical training to eligible trainees. This provision of the program ensures that funding is targeted to support the costs of training. While a site is capped at their total expenditures across a variety of training types, their grant is initially based on the facilities relative MA/PMAP reimbursement. The expenditure limits can provide an incentive for training facilities to take on additional trainees when their Medicaid volume is high, and their prior trainee count is low. However, larger facilities that already have expenditures beyond their grant amounts will not see an increase in funding by taking on new provider types or additional trainees.

More than \$433 million in training-related expenses were submitted by the Minnesota clinical training facilities applying for MERC funding. In a typical grant cycle, MERC supports between 13-17% of the overall reported health professions expenditures.




Figure 3A Overall 2021 Clinical Training Expenditures vs Available 2023 Funding

The impact MERC funding has on clinical training expenditures can vary by facility type. Facilities that hosted twenty or more trainees are shown in the figure below. Hospitals incurred just over 70% of the total training expenditures in Minnesota and receive just over 85% of the funds available through the MERC program; however, their actual expenditure reimbursement was only slightly more than 16%. Meanwhile, pharmacies incurred just over 0.7% of the overall training expenditures, receive just

over 4% of MERC funds, but their expenditure reimbursement was nearly 75%. With so many moving pieces, changes to any applicant or one part of the formula can impact the outcome.




Figure 3B Facilities Hosting Over 20 FTE Trainees

For the current grant distribution, there were 175 facilities whose share of the grant pool, based on their Medicaid revenue, exceeded their training expenditures. Consequently, their grant was capped at their reported expenditure amount as required by statute. If the expenditure cap on grant amounts had not been in place, the initial formula would have led to them receiving higher grants ranging from an additional \$71 to \$2.5 million.

## **Conclusion and Next Steps**

The program continues to benefit from the development of the electronic application portal that rolled out in August 2019. The portal collects all data electronically, streamlining the process tremendously.

The debate that occurred over the last year as Minnesota sought to revise the program to meet CMS approval helped focus discussion on the variety of needs within the state to ensure an adequate supply of clinical training sites and providers willing to precept health care students and trainees. Once approval has been received from CMS, the distribution method for MERC funding will change. The way the formula works, however, will remain largely the same. Currently, the grant a facility receives won't necessarily increase when more trainees are training at a site or a new provider type begins training at a facility; the facility's costs may increase, but unless their Medicaid revenue increases at the same time, there will not likely be an increase in their grant amount unless the facility had been capped at their expenditures in the previous period. Larger facilities that already have expenditures beyond their grant amounts also will not see an increase by taking on new provider types or additional trainees.

In 2023, the Legislature approved changes in the former PMAP carveout in an effort to gain approval from CMS. The Department of Human Services is working with CMS to determine if that approval is forthcoming. If CMS does not approve the recent legislation, it would significantly impact funding for medical education. Under Minnesota's formula, approximately 30% of the training sites currently applying would continue to qualify for funding and they would see significant decreases, which would increase the financial burden on the facilities providing clinical training.

In the coming year, MDH will monitor the CMS review and begin implementation of the revised distribution process. MDH will continue to work with stakeholders to identify opportunities to improve the process and continue to work toward a more robust, forward-thinking, and responsive system of providing clinical training to health professionals to help meet Minnesota's future health workforce needs.
