## **RE: 2023 Temporary Classification Report**

Dear Speaker Hortman and Majority Leader Dziedzic,

Enclosed please find the required legislative report pursuant to Minnesota Statutes, section 13.06, subdivision 7. The report is in bill form, as required by the statute, and contains all temporary classifications of data that were in effect as of January 1, 2023.

The Commissioner of Administration partially approved one temporary classification that is currently in effect related to certain data maintained by the Department of Labor and Industry. The Attorney General's Office approved the temporary classification as to form and legality on September 22, 2023. The enclosed bill draft addresses the classification of this data by amending Minnesota Statutes, section 13.7905 and adding Minnesota Statutes, section 175.47.
