It was another exciting and successful year for the Minnesota Lottery. With \$787.2 million in sales, fiscal year 2023 represents one of the highest sales years in the history of the state lottery, continuing a run of record sales that now stretches nearly a decade.

Each dollar spent on a lottery ticket in Minnesota not only fuels the dreams of potential winners, but also drives millions of dollars toward crucial state services and vital projects that protect our environment and natural resources. From the depths of Lake Superior to the prairies of southwestern Minnesota, you'll find wherever you go in the state, lottery dollars are all around you.

Additional figures for FY23 showcase various ways the Minnesota Lottery continues to give back:

- \$488.0 million in prizes won by players across the state
- \$196.1 million contributed toward important state initiatives, including:
  - o \$105.7 million for the General Fund
  - o \$88.9 million for Minnesota's environment and natural resources
  - o \$1.5 million for responsible gambling programs
- \$51.9 million in commissions and incentives for nearly 3,000 retailers around Minnesota

Numbers like these showcase the lottery's dedication to its mission, as well as the positive reaction players have to the vision of a state lottery that provides entertainment while generating income to benefit all Minnesotans.

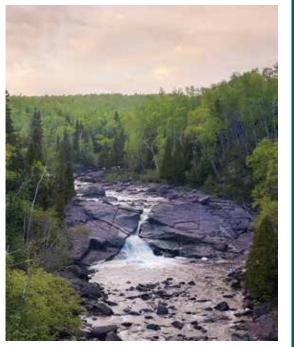

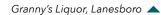

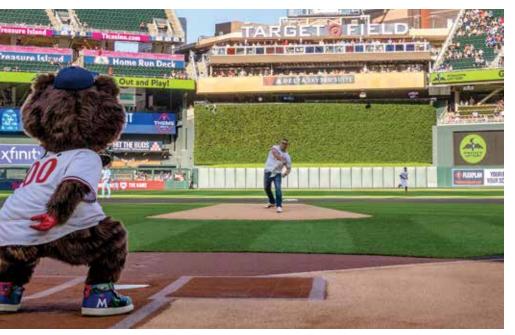

# RESPONSIBLE GAMBLING

The Minnesota Lottery strives to increase awareness of responsible gambling practices, problem gambling warning signs, and how to get help if you or a loved one needs it. Working with partners in the Minnesota Department of Human Services and the Minnesota Alliance on Problem Gambling (MNAPG), our state's affiliate to the National Council on Problem Gambling (NCPG), the Minnesota Lottery has invested more than \$55 million in a statewide effort to prevent problem gambling and encourage responsible gambling habits.

The Minnesota Alliance on Problem Gambling (MNAPG) continues to enjoy a meaningful relationship with the Minnesota Lottery. Over the 22 years MNAPG has been advocating on behalf of those harmed by gambling, the MN Lottery has provided leadership from within by serving on our board of directors. Having the gambling industry represented provides opportunities to hear first-hand of MNAPG's efforts to meet its mission of reducing the numbers of Minnesotans negatively impacted by gambling. The Minnesota Lottery understands its role and the importance of promoting responsible gambling amongst its customers. One such effort is the annual advocacy program - Gift Responsibly - to ensure adults understand that purchasing a lottery ticket or scratch off ticket for a youth's gift is a bad idea. Introducing gambling at an early age has shown a greater likelihood of developing an addiction to gambling as an adult. MNAPG values the Minnesota Lottery's involvement in such programs. Our efforts are strengthened through our partnership.

## FINANCIAL OVERVIEW

#### **OVERVIEW OF FINANCIAL STATEMENTS**

This discussion and analysis include an overview of financial activities regarding the financial performance of the Minnesota State Lottery (the Lottery) for the fiscal year ended June 30, 2023 and comparison for the one previous fiscal year ended June 30, 2022. The management discussion and analysis should be read in conjunction with the transmittal letter and supplementary information included in this report. This report consists of three parts: management's discussion and analysis, the basic financial statements and the notes to the financial statements. Included below and on the following pages are the financial highlights, summary of contributions to the State, summary results of operations and a condensed statement of net position for the years ended June 30, 2023 and 2022.

#### **FINANCIAL HIGHLIGHTS**

The Minnesota State Lottery had operating revenues of \$787.3 million in fiscal year 2023 and contributed \$196.1 million to the State. Both revenues and contributions to the State were up compared to last year. Operating revenues for fiscal year 2023 resulted in the largest contribution to the State of Minnesota in the Lottery's history.

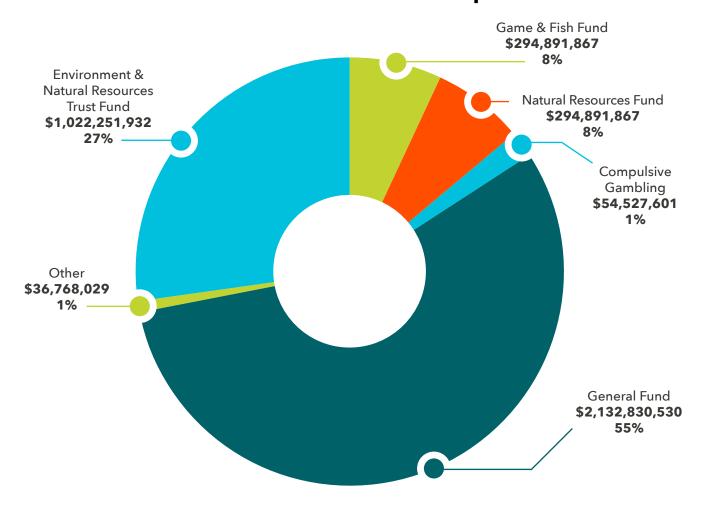
## SUMMARY OF CONTRIBUTIONS TO THE STATE

The Lottery contributed \$196.1 million to the State in fiscal year 2023. This was a \$23.5 million or a 13.6% increase from 2022. The following table provides detail on the total amounts transferred to the State as well as the source of the transfers provided to the State.

#### **OPERATING INCOME**

Operating Income has increased by \$14.6 million in 2023 from 2022. Gross receipts increased by \$44.1 million or 6.4% due to increased lotto sales by \$63.0 million. As a result of higher gross receipts operating income increased by \$14.6 million. Direct costs which include prizes, commissions and ticket costs as a percent of gross were 76.4% in 2023 compared to 77.8% in 2022.

#### **OPERATING EXPENSES**

Operating Expenses increased by \$5.3 million in 2023 from 2022. This was primarily due to recognizing the change in the pension valuation.

#### **SCRATCH GAMES**

Scratch game sales accounted for 69.3% of operating revenue in fiscal year 2023, down from 75.9% in 2022. Total scratch sales were down \$16.0 million compared to 2022. The decrease in scratch sales was all in the first six months of the fiscal year. The last six months exceeded fiscal year 2022 by \$8.8 million.

#### **LOTTO GAMES**

Lotto sales saw a large increase of \$63.0 million in 2023 from 2022. This was attributed to four large jackpot runs during the fiscal year between Powerball and Mega Millions.

#### **NET POSITION**

Minnesota State Lottery's net position at the end of fiscal year 2023 was \$(3.1) million compared to \$(6.0) million in fiscal year 2022. The negative net position is attributable to the offset of the net pension liability and recognition of postemployment benefits liability.

## CASH AND CASH EQUIVALENTS AND RECEIVABLES

The total of cash and cash equivalents and receivables decreased by \$876 thousand from 2022 to 2023. This was primarily due to spending more on capital activities.

#### **CAPITAL ASSETS AND OTHER ASSETS**

Net Capital assets increased by \$185 thousand in 2023 versus 2022. Purchase of capital assets totaled \$594 thousand comprised of \$97 thousand in computer equipment, \$396 thousand in software costs and \$101 thousand in vehicles. For a more detailed explanation see Footnote 5.

During the fiscal year the Lottery adopted GASB No. 96 Accounting for Subscription Based Information Technology Arrangements which accounts for \$2.2 million of the \$3.1 million right-to-use assets. The other \$884 thousand of the right-to-use asset is for GASB No. 87 Accounting for Leases which was adopted during the previous fiscal year. For a more detailed explanation see Footnotes 2, 5, 9 and 16.

#### **DUE TO STATE AND STATE AGENCIES**

Payment due to state at the end of fiscal year 2023 was \$1.7 million higher than fiscal year 2022. This was due to a \$1.5 million increase in unclaimed prizes and a \$225 thousand increase in net proceeds due.

#### **PRIZE LIABILITY**

Prize Liability decreased by \$1.6 million from 2022 to 2023 due to mid and high tier scratch game prizes.

## ACCOUNTS PAYABLE AND CURRENT ACCRUED EXPENSES

Accounts payable and current accrued expenses decreased slightly by \$25 thousand during the fiscal year twenty-three.
