





State Services for the Blind and Visually Handicapped

Our mission: facilitating achievement of vocational and personal independence

When loss of vision creates a handicap to the vocational, educational and personal independence of children or adults, direct services are available from State Services for the Blind and Visually Handicapped (SSB). People who have physical or mental disabilities in addition to vision loss also are served.

Our mission is achieved by providing the following services:

Rehabilitation Services

- Adjustment to blindness
- Rehabilitation counseling
- Braille instruction
- Travel training
- Job placement & retention
- Career exploration
- Rehabilitation engineering
- Low-vision services
- Independent living skills training
- Vocational training
- Blind vendor program
- Parent support
- Child development

Communication Center Services

- Radio talking book (newspapers, magazines, and best sellers – 24 hours a day)

- Engineering and equipment repair services

Communication Center

The SSB Communication Center is a statewide special library, transcription and reading service, supported by federal, state and private funds. Any Minnesotan who is unable to read normal newsprint because of a visual or physical handicap is eligible for Communication Center services.

People may borrow textbooks and books for leisure reading on tape or in Braille from the Center's library of 11,000 book titles. They also may borrow special phonographs, cassette players and closed-circuit radios.

The closed-circuit radio network, Radio Talking Book, is a Minnesota-based radio reading service for newspapers, books and magazines, broadcasting 24 hours every day throughout the year. The signal is transmitted by satellite across most of the state—but, by law, it is not available to the general public.

An audio newspaper-reading service, Dial-In News, allows readers to access the daily newspapers 24 hours every day throughout the year using a touch-tone telephone.

Upon request, the Communication Center transcribes books or other printed materials onto tape or into braille. Students and workers who are blind, as well as educators and employers, may call the Center to request instructions for obtaining transcribed materials.






