COVID-19

While COVID-19 was still a factor during 2022 our operations were fairly normal. The library was fully accessible and masks were optional for visitors and law library staff. Vaccinations or testing/masking was required by Minnesota Judicial Branch policy for court staff and judges.

2022 Highlights

New Probate Self-Help Clinic

Seeing a need for brief legal advice for simple probate process questions, the State Law Library partnered with the Probate, Trusts and Estates Section of the Minnesota State Bar Association to create a free clinic. The clinic started in October 2022 and is coordinated by the State Law Library and staffed by attorney volunteers from the Probate, Trusts and Estates Section. It is a phone clinic, so it is available to people statewide. Issues not covered are tax, medical assistance, guardianship/conservatorship, questions about the law in other states.

Court of Appeals Oral Histories

In 2022, the library added seven oral history interviews and their transcripts to the Minnesota Digital Library. They were interviews with retired Court of Appeals Judges Doris Ohlsen Huspeni, Edward Toussaint Jr., Gary Crippen, Harriet Lansing, Marianne Short, Randolph Peterson, and Thomas J. Kalitowski. These interviews were part of a 2017 project by the Minnesota Supreme Court Historical Society to document the founding and early days of the Court of Appeals. The State Law Library has now submitted 31 oral history interview videos to the Minnesota Digital Library.

Excellence in Community Engagement Award

In 2022, the State Law Library received the American Association of Law Libraries (AALL) Excellence in Community Engagement Award. The award honors outstanding achievement in public relations activities by an AALL member library. The State Law Library was selected as the 2022 winner for our first four Appeals Self-Help Videos. These videos were published during 2021 and were produced to make it easier for self-represented appellants to complete initial paperwork to file their appeals. The State Law Library has since added a fifth appeals video on eviction appeals and two videos demonstrating legal research strategies.

Justice James H. Gilbert Career Book Presentment

In 2021, the State Law Library completed the volume entitled "The Legal and Judicial Career of James H. Gilbert". On March 1, 2022 the book was presented to Justice Gilbert

and the Supreme Court at a court ceremony in the Capitol courtroom. Retired Associate Justice Paul Anderson and former Attorney General Lori Swanson spoke at the event. Because COVID-19 was still a concern, attendance was limited, but the event was live streamed and recorded. The recording can be found here -

Security Screening


On January 3, 2022, the Minnesota Judicial Center adopted new security screening protocols. Visitors entering through the Rev. Dr. Martin Luther King Jr. Boulevard entrance must pass through screening before they can enter the upper levels of the building. Since the law library is located next to the tunnel, and people in the tunnel can pass through the Minnesota Judicial Center without having to go through security, additional measures were put in place for the library. The library doors are kept locked, and visitors are buzzed into the library from the receptionist/guard station, after they have passed through security screening. Interestingly, the new screening has not lessened our foot traffic. The library's percentage of in person patrons increased from 11% in 2021 to 19% in 2022.


Answering Questions




The State Law Library strives to provide statewide service. The library can track the county for many questions that are received via email. (We can track counties in emails that are initiated by clicking on "Ask a Librarian" on our website and emails coming from LawHelpMN.org.) The image below demonstrates that in 2022 the library received email questions from almost every county in the state. While six counties are shown in grey, it is possible that residents of those counties did receive assistance from the law library by calling the library or sending an email directly to our specific email address (askalibrarian@courts.state.mn.us).



A Sampling of Interesting Questions

- We are interested in starting a family cemetery in St. Paul. This is a new journey for us.
 Can you direct or provide any guidance on zoning requirements, who to contact regarding looking for land, land surveyors, etc.? Any assistance would be greatly appreciated. Thank you in advance for your assistance.
- I have a question about whether there are any specific laws about loons in the State of Minnesota. If a person were to intentionally kill a loon what would be the charge and potential punishment? Or would this be a federal matter?
- I'm looking for a law from around 1900 against blowing whistle of steam engine and scaring horses.
- I am looking for records/investigations for an unsolved murder involving a family member from 1952.
- If after showing proof of age, the establishment (the same employees) refuse to sell to me on a daily basis without an i.d. are they violating my civil rights? I'm a senior citizen.
- Part of a big healthy white pine tree fell into our neighbor's yard and caused damage. This occurred during the terrific wind storm. We understood that this tree limb fell due to "An Act of God" and we, as the tree's owners are not responsible for the cleanup or damages. His insurance company should compensate him. He is insisting that we pay him for damages. Where in the Minnesota Statutes does it say we are not responsible?

- Is there such a thing as a motion to amend the charges from the defense side?
- Is there a difference between legal and religious annulment? Would it have been possible to obtain a legal annulment in 1949/1950 in the state of Minnesota? Would there be records of a legal annulment?
- How long may a County Attorney delay a decision to charge, and does it matter if the crime is stalking and the victim is in fear? - What confirmation does a party receive when a "hip pocket" [service] has expired due to statute of limitations? Is the status of an expired "hip pocket" public record and or searchable on a MN records website? If the hip pocket has expired due to statute of limitations is it "dismissed with prejudice"? When does parties involved with a "hip pocket" that has expired get confirmation of the dismissal?

Appellate Self-Help Clinics

Cases with at least one pro se party constituted 27% of all filings to the Court of Appeals in 2022. To assist, the State Law Library offers two appellate self-help clinics. The general Appeals Self-Help Clinic is offered once per month. In 2022, the clinic assisted 132 people. The top two types of cases seen at the clinic were family law (37%) and general civil (32%). The State Law Library also continues to offer an Unemployment Appeals Self-Help Clinic twice per month to assist people appealing a denial of unemployment benefits Court of Appeals. In 2022 the clinic assisted 41 people. The vast majority of these types of appeals (95%) involve an unrepresented party.

Online Presence

Website

The law library's website saw 506,939 unique page views and 183,640 new visitors in 2022. Our <u>legal research guides</u> had 199,163 views total, a 54% increase in views from 2021. The most popular guides in 2022 were Appeals; Neighbor Law; Child Custody and Parenting Time; Children, Minors, and Teens, Homeowners/Real Estate; Divorce/Dissolution of Marriage; and Landlord Tenant.

Opinion and Briefs Archives

Since 1996, the State Law Library has provided an online, <u>searchable database</u> of appellate court decisions. In 2022, the library added 1,053 opinions to the database.

The library also maintains a <u>searchable database</u> of appellate briefs from precedential Minnesota Court of Appeals and Supreme Court cases. Comprehensive coverage goes back to 2002, and staff adds additional older briefs or briefs from non-precedential cases as requested. Last year library staff added 4,662 briefs to the online archive. The database is complete back to 651 N.W.2d.

Social Media

The library now has 525 Facebook followers. The library's Twitter feed has 1,416 followers.

Current Awareness

Each month, the State Law Library complies a list of articles of interest to the courts and distributes the articles to all members of the Judicial Branch via email. The library also sends out a <u>list of new books</u> each month.

Interlibrary Loan

The State Law Library provides an interlibrary loan service for the Judicial Branch. This includes both books and journal articles. In 2022, the library obtained 44 items for the court and loaned 53 items to other libraries.

Continuing Legal Education

The State Law Library offers <u>free CLEs</u> for the judicial branch and other interested attorneys. In 2022, the library hosted thirteen public CLE programs (11.25 standard credits and 2.5 ethics credits). The library also offers several CLEs for on-demand credit via its website. This has been a popular feature. The library had 35 CLEs available for on-demand credit during 2022. 1587 lawyers reported attendance for these courses (for a total 7804.5 total CLE credits).

Judicial Law Clerk Assistance

The library communicates to the court's law clerks via a quarterly law clerk newsletter and has a dedicated law clerk assistance email account. It is a popular service, and the library regularly gets emails from law clerks all over the state. (38 counties in 2022!)

The State Law Librarian and Outreach Librarian taught several training sessions for the new appellate law clerks on how to conduct Minnesota legislative history research. In addition, the Outreach Librarian provided training for the new appellate clerks on the Minnesota legal resources available at the State Law Library.

The Outreach Librarian presented a CLE webinar on "Minnesota Legal Research" to district court clerks in August. In November, the Outreach Librarian presented a CLE on Minnesota legislative history research for district court clerks.

County Law Libraries

By statute, the State Law Librarian is tasked with assisting and advising county law libraries. The library has two programs for county law libraries. Members receive materials and assistance from the State Law Library. In 2022, 48 county law libraries (out of 82) opted in. 18 of those counties opted for a level of service that includes a visit from either the State Law Librarian or the County Law Library Program Coordinator.




Newsletters

The State Law Library uses three newsletters to connect to patrons. There is a newsletter for law clerks that goes out four times per year, a county law library version that goes out twice per year, and a general newsletter, <u>Inter Alia</u>, that is sent four times per year.

Display Cases

Library staff create new displays several times a year to engage visitors to the library and promote the library collections. Often the displays connect with events or exhibits. In 2022, the library celebrated pride month with a display of books in the collection. That was followed by an exhibit about the Minnesota Territory with a timeline, short biographies of the territorial justices, quotes of descriptions of Minnesota at the time, and books in our collection from and about the era.





Preserving Court History

The State Law Library has been working to establish our own digital archives management tool. This will allow us to post digitized copies of many of our archival materials, such as videos and documents. The site will launch in early 2023. Digitization work has been ongoing for the past several years and will continue as the library focuses on fragile materials that are in high demand.

The library continues work on the project to digitize historic appellate briefs from the microfiche collection. Staff have scanned, redacted, and uploaded 2,784 briefs from the early 1980s since 2019.

The library is working with <u>LLMC</u> to digitize the collection of historic handwritten briefs. This project is scheduled to take several years due to the fragile nature of the materials. 29 volumes were scanned by the end of 2022.

Managing the Collection

The Technical Services department is responsible for making all types of library materials available to the public and the judiciary. This department ensures that the library materials are relevant, current, and easy to find, both on and off-line. It is also responsible for making briefs available to the public in a variety of formats: print, microfiche, and through the online archive. In addition, the department preserves historic court materials and distributes a new books list. The Cataloger works with six county law libraries to make their materials searchable online.

Minnesota Legal Periodical Index

The <u>Minnesota Legal Periodical Index</u> (MLPI) is a database of Minnesota legal periodicals that the State Law Library has developed and maintained since 1984. In 2022, the Cataloger indexed 1,227 articles for the MLPI. Many of the added articles are from the earlier paper versions of the MLPI from before it went online which gives us a deeper set of resources to draw from when searching.

Appellate Briefs

The library provides access to appellate briefs in multiple formats. For Minnesota appellate decisions that are published in the Northwestern Reporter, the library binds the briefs and their addenda to ensure long-term access. These materials are heavily used by attorneys. This year the library added the feature to search by reporter number to its search interface. The library also continued a project to digitize older briefs from our microfiche collection using the scanner the library acquired at the end of 2018.

47 volumes of bound briefs were added to the collection.

- 2,580 briefs were redacted and added to the library's <u>online database</u>. The

 being added regularly.

Law Library Service to Prisoners (LLSP)

About the Program


Under an Inter-Agency Agreement between the Minnesota Department of Corrections (MNDOC) and the Minnesota State Law Library (MSLL), the Law Library Service to Prisoners (LLSP) program provides law library service to people incarcerated in a MNDOC facility or otherwise under MNDOC jurisdiction.

Legal information requests are accepted by "kite," a request form available to Incarcerated Persons (IPs) at their facility. In addition, IPs may submit requests via phone or letter. LLSP librarians also conduct video visits in which IPs meet via Zoom with an LLSP librarian to discuss their legal information request. Facility librarians and the IPs have provided positive feedback about these visits. LLSP is continuing efforts to get all eight facilities on a schedule for monthly video visits. As of this writing, the law librarians have regular monthly video visits with five of the eight facilities: Faribault, Lino Lakes, Shakopee, St. Cloud, Stillwater. The goal is to get Moose Lake, Oak Park Heights, and Rush City set up within the next year.

The Law Library Service to Prisoners Program experienced staffing changes in 2022 with Jean Anderson moving to part-time in May and then retiring in August. Ally Ososki increased her hours in May and then moved from part-time to full-time in August. Valerie Salazar joined the staff as the new part-time librarian in July.


