To the Members of the Duluth Firemen's Relief Association:

Contained herein is the record of operation of the Duluth Firemen's Relief Association for 1983. The State Auditor has issued a management and compliance letter covering the review made as part of their examination of the Duluth Firemen's Relief system of internal control and compliance with applicable legal provisions. The management and compliance letter will not modify or affect in any way this report on the financial statements.

Both funds show an increase in value, the Special Fund, \$1,757,378, and the General Fund, \$29,103. As a result, the funding ratio of the Special Fund has increased actuarily from 15% funded to 19% funded.

On December 31, 1983, we had 163 pensioners on the roll, including 87 service, 4 disabilities, 68 widow, and 4 children's pensions.

NOTES TO THE FINANCIAL STATEMENTS

1. Description of the Duluth Firemen's Association

The Duluth Firemen's Relief Association was incorporated August 31, 1887, to provide for the relief of sick, injured, and disabled members of the Fire Department of the City of Duluth who are members of the Association. The Association is governed by a Board of Trustees consisting of the Chief of the City of Duluth Fire Department and seventeen other members of the Association elected by their peers. The affairs of the Association are regulated by its articles of incorporation and its bylaws. Minn. Stat. Section 69.77 as amended provides for the orderly phase-out of the local police and salaried firefighters relief associations, and when all current members of the Duluth Firemen's Relief Association retire or terminate from active duty, the Association shall cease to exist. The assets of the Association will be transferred to a trust account to be established by the City of Duluth.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accrual basis of accounting is used by the Duluth Firemen's Relief Association for the Special Pension Trust Fund and the modified accrual basis is used for the General Fund.

Fund Accounting

The Association's operations are shown in two separate funds, a Special Pension Trust Fund and a General Fund. The Special Pension Trust Fund is used to account for the funding and payment of pensions and related administrative expenses. The General Fund was established to account for expenditures and contributions that are unrelated to pension payments and which are voluntary in nature.

Investments

Investments are reflected on the balance sheet at market value with gains or losses in value shown as increases or decreases on the Statement of Revenues, Expenses and Changes in Fund Balance - Special Pension Trust Fund and the Statement of Revenues, Expenditures and Changes in Fund Balance - General Fund. Fixed Assets

The Association follows a policy of expensing purchases of office equipment. Fixed asset purchases are considered insignificant to the operation of the Association as a whole.

Total Column on Combined Balance Sheet

The total on the Combined Balance Sheet is captioned Memorandum Only to indicate that it is presented only to facilitate financial analysis. Data in this column does not present financial position in conformity with generally accepted accounting principles. Neither is such data comparable to a consolidation. Inter-fund eliminations have not been made in the aggregation of this data.

3. Unfunded Accrued Liability

An actuarial valuation was made as of December 31, 1983, using the entry age normal cost method. The accrued liability on that date is \$36,359,572. The unfunded accrued liability on December 31, 1983 is \$30,048,419, which is an increase of \$1,496,891 from December 31, 1982.

4. Funding of Retirement Plan

Prior to 1971, the City of Duluth contributions were made without regard to actuarial requirements resulting in a substantial deficiency in the accumulations of reserves on an actuarial basis. The unfunded accrued liability is a deferred obligation of the City.

Tax levies for the firemen's retirement plan are made pursuant to Minnesota Statutes §69.77, Subd. 2(5). Full funding is required by the year 2010. State amortization aid is to be provided, as set forth in the law, to fully fund the unfunded accrued liability by the year 2010. The Duluth Firemen's Relief Association received \$316,395 in state amortization payments in 1983.

Section 69.77 also provides that the minimum employee contribution shall be 8% of the maximum rate of salary upon which retirement coverage is credited and service pension and retirement benefit amounts are determined.

The actuarial assumptions as prescribed in Minnesota Statutes §356.215 provide for an assumption rate of 3½% for salary increases on an annual basis and 5% for interest earnings.

5. Minnesota Public Employees Retirement Association

Pursuant to Minnesota Statutes §423A.01 Subd. 1, all new eligible employees employed after June 15, 1980, become members of the Minnesota PERA - Police and Fire Fund.
