2023 Allegations of Misconduct Minn. Stat. 626.8457 Annual Report

Overview:

Since July 1, 2021, the MN Board of Peace Officer Standards and Training (POST) has been collecting reports of alleged misconduct of peace officers via the reporting system mandated under Minn. Stats. 626.8457 Subd. 3(b) and 626.8455 Subd. 3.

The data includes alleged misconduct that would be a violation of a mandated department policy (*see Minn. Rules 6700.1615 for full list of policies*) and allegations of misconduct that would be a violation of the standards of conduct for licensed peace officers in Minnesota (*see Minn. Rules 6700.1600 for further detail*).

This report covers the calendar year from 1/1/2023 to 12/31/2023.


