#### ABSTRACT

This research and behavioral analysis will investigate, to the extent possible, the demographic, social, and economic trends in citations given and contested, as well as in judgments for speeding, impairment, distraction, and seatbelt violations.

In pursuing this work, the research team will seek to compare rates of citations given, contested, and judgment outcomes in the following ways, given the available data:

- Overall (statewide)
- Legally (Felonies vs. Misdemeanors, etc. plus accounting for diversion programs)
- Geographically (rural vs. suburban vs urban)
- By income
- By race
- By gender
- By age

The research will also note data shortcomings and make recommendations and justifications for improving data collection.

The team will also note how well enforcement appears to match up with the intent of the law. We will note instances of disconnect where the way the law is written and/or enforced may be leading to sub-optimal outcomes, and will make recommendations for possible changes.

#### **BACKGROUND AND OBJECTIVE**

In May of 2023, the Minnesota Legislature asked the Center for Transportation Studies (CTS) at the University of Minnesota to conduct an evaluation of the disposition in recent years of citations for speeding, impairment, distraction, and seatbelt violations.

Based on this directive, the research team will determine how extensive, complete, and accessible data is regarding the number of citations contested and adjudicated for speeding, impairment, distraction, and seatbelt violations in Minnesota, as well as analyze any differences and disparities in these outcomes by seriousness of the crime, geographic location, income, race, gender, and age (as the data allows).

This work will hopefully lead to safer travel for Minnesota citizens through: a) consistent and equitable enforcement of speeding, impairment, distraction, and seatbelt laws and b) examining potential disparities in how speeding, impairment, distraction, and seatbelt laws are enforced and adjudicated.

#### SCOPE

The Center for Transportation Studies team will provide all project management, research, analysis, and report writing services to evaluate traffic safety violation dispositions as noted in this workplan and in Minnesota statute.

Tasks in this project will be conducted based on direction and funding provided by the Minnesota Legislature to the Office of Traffic Safety (OTS) at the Minnesota Department of Public Safety. The project team will evaluate rates of citations issued compared to rates of citations contested in court (and the outcomes of the cases), amounts of fines imposed compared to counts and amounts of fines payments, and related changes in patterns of traffic enforcement from 2017 to 2022. The project team will also submit both an interim and final report on the work.

TASK #1

Task Name Discussion of Current Law

#### **Task Description**

This task will discuss the different types of violations to be studied (speeding, impairment, distraction, and seatbelt), noting the degree of the violation (administrative violation, petty misdemeanor, misdemeanor, felony etc.) and whether any diversion or exceptions exist.

This task will also include a discussion of the theoretical implications of the degree of the violation, the presence of any diversion programs or other exceptions, and other aspects that might have an impact on whether a violation is contested, as well as on deterring or encouraging the noted behaviors.

#### Task Name

Data Assessment

#### **Task Description**

This task will catalogue the data available regarding each violation, whether information about the violations is public, what types of information (race, gender income, etc.) is collected, where it resides / can be collected from (e.g., state database, county court records etc.), whether it is aggregated or needs to be assembled, and noting any costs for obtaining and/or aggregating the data.

The result of this task will be an assessment of whether collection and analysis of data from the entire state is feasible, or if samples need to be drawn, along with recommendations for data collection methods. This task will also note types of data that are not available or could be improved.

TASK #3

Task Name Interim Report

#### **Task Description**

This report will cover tasks 1 and 2, summarizing the nature of the violations to be studied and the available data. The report is expected to identify the draft research methodology to be used by the study, identify opportunities, and indicate potential limitations of the study based on the availability of data and scope of the study.

TASK #4

**Task Name** Data Collection and Analysis

#### **Task Description**

Based upon the results of tasks 1 and 2, the research team will assemble the available data and organize it to show the number and percent of violations that are then contested in court, the judgements for each violation (guilt vs acquittal), and sentences for those found guilty. This data will then be broken down by geography, race, income and age, to the extent the data allows. Cross-tabulations will also be sought.

The data collected will also include crash data to contrast citation rates to crash rates over time to establish the trends in risky driving behaviors.
