Re: Submission of Community Supervision Advisory Committee Report on Supervision Fees, as Required by Minn. Stat. § 401.17, subd. 3(c)

Minn. Stat. § 244.18 authorizes community corrections agencies in Minnesota to establish and collect correctional fees to defray the costs of providing correctional services. Currently, correctional fees are defined to include community service work placement and supervision; restitution collection; supervision; court-ordered investigations; any other court-ordered service; post-prison supervision or other form of release; and supervision or other probation-related services. The laws regarding correctional fees were amended in 2023 to update the definition of correctional fees such that starting in 2027, correctional fees will be defined to include "corrections services, including but not limited to drug testing, electronic home monitoring, treatment, and programming."

Minn. Stat. § 401.17. subd. 3(c) requires that the Community Supervision Advisory Committee submit, by June 30, 2024, a one-time report on supervision fees to the Commissioner of Corrections and the chairs and ranking minority members of the legislative committees with jurisdiction over corrections policy and finance. There was no specific direction included in the statute as to the form and content of the report except that the committee was directed to collect data on supervision fees and include the data in the report.

The Community Supervision Advisory Committee discussed the requirement to submit a report on supervision fees at its meeting on January 19, 2024. It was unclear whether CSAC was requested only to report on supervision fees or all correctional fees. Most counties establish a correctional

fee schedule so that the fees imposed for various services are transparent and uniform. As an example, in Anoka County, the correctional fee schedule includes a fee for being on probation supervision (\$145 to \$340, depending on offense level), for participating in work release (\$23/day), as well as fees for drug testing (\$90 per case), electronic monitoring (\$18/day), and cognitive skills programming (\$120).¹ The term "supervision fees" likely only applies to the fee for being on probation supervision. But while most counties can report the aggregate totals of all correctional fees imposed and collected, many counties are not able to disaggregate the totals in order to provide data by fee category. Moreover, it was noted that the Legislature directed community supervision agencies to develop a plan for sunsetting supervision fees by August of 2027, that many agencies are working to phase out their use, and that some have already. Therefore, the Committee determined that this report would include the aggregate total of correctional fees collected and imposed in calendar year 2022 and would generally describe the range of services for which those fees are utilized.

Table 1 shows the aggregate statewide total of correctional fees imposed and collected in 2022. It should be noted that individuals often make payments over time to satisfy the financial obligations that flow from a criminal conviction (including fines, fees, and restitution). Therefore, the fees imposed in 2022 may not have been collected until a subsequent year. And the fees collected in 2022 may have been for correctional fees imposed in years prior to 2022. In 2022, nearly \$13.8 million in correctional fees were imposed statewide while about \$6.4 million was collected.

Community corrections agencies that provide services within the CCA and CPO delivery systems utilize correctional fees for a variety of purposes, including:

- Providing cognitive behavioral programming;
- Drug testing;
- Electronic home monitoring;
- Purchasing equipment (safety, technology);
- Providing innovative programming (program for youth, juvenile restitution grant);
- Offsetting the county levy;
- Staffing; and
- Training and travel.
