# About the Funds

## Funding Sources

### Clean Water, Land and Legacy Amendment

In 2008, Minnesota's voters passed the Clean Water, Land and Legacy Amendment (Legacy Amendment) to the Minnesota Constitution to: protect drinking water sources; to protect, enhance, and restore wetlands, prairies, forests, and fish, game, and wildlife habitat; to preserve arts and cultural heritage; to support parks and trails; and to protect, enhance, and restore lakes, rivers, streams, and groundwater.

The Legacy Amendment increases the state sales tax by three-eighths of one percent beginning on July 1, 2009 and continuing until 2034. The additional sales tax revenue is distributed into four funds as follows: 33 percent to the clean water fund; 33 percent to the outdoor heritage fund; 19.75 percent to the arts and cultural heritage fund; and 14.25 percent to the parks and trails fund.

### Environment & Natural Resources Trust Fund

In 1988, Minnesota's voters approved a constitutional amendment establishing the Environment and Natural Resources Trust Fund (Trust Fund). The purpose of the Trust Fund is to provide a long-term, consistent, and stable source of funding for activities that protect and enhance Minnesota's environment and natural resources for the benefit of current citizens and future generations.

The money in the Trust Fund originates from a combination of contributions and investment income. Forty percent of the net proceeds from the Minnesota State Lottery are deposited to the Trust Fund each year; this contribution is guaranteed by the Minnesota Constitution until December 31, 2024. The Trust Fund may also receive contributions from other sources such as private donations.

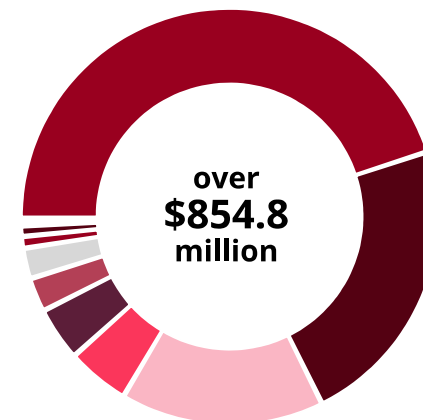


# Arts & Cultural Heritage Fund

The Arts and Cultural Heritage Fund receives 19.75 percent of the sales tax revenue resulting from the Legacy amendment to support arts, arts education and arts access, and to preserve Minnesota's history and cultural heritage. Based on current sales tax revenue, Minnesotans will invest more than \$1.2 billion in arts and cultural heritage fund projects and programs over the 25 year life of the tax.

A portion of the dollars appropriated from the Arts and Cultural Heritage Fund are being made available through grant programs.

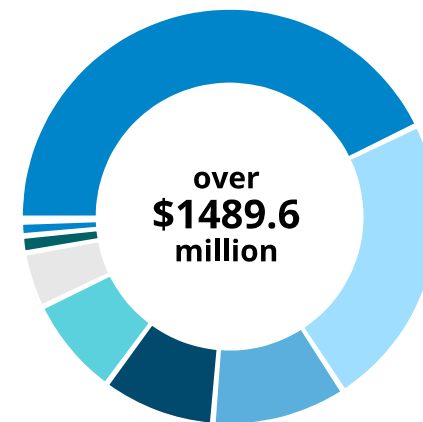


# Clean Water Fund

Thirty-three percent of the sales tax revenue from the Legacy amendment is allocated to the Clean Water Fund. Those funds may only be spent to protect, enhance, and restore water quality in lakes, rivers, and streams and to protect groundwater from degradation. At least five percent of the clean water fund must be spent to protect drinking water sources.

Protecting Minnesota's waters is a joint effort between seven partner agencies, who collaborate and partner on Minnesota's water resource management activities under the Clean Water Fund.

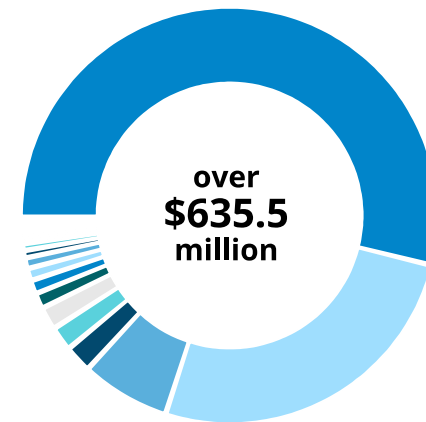

# Environment & Natural Resources Trust Fund

The Environment and Natural Resources Trust Fund (ENRTF) was established following voter approval of a constitutional amendment in 1988. The money in the Trust Fund is generated by the Minnesota State Lottery. The Trust Fund holds assets that can be appropriated, "for the public purpose of protection, conservation, preservation, and enhancement of the state's air, water, land, fish, wildlife, and other natural resources." Since 1991, the ENRTF has provided approximately \$1.027 billion to over 1,601 projects around the state.

# Who Administers this Fund?

## The Legislative-Citizen Commission on Minnesota Resources (LCCMR)

The Legislative-Citizen Commission on Minnesota Resources (LCCMR) (<https://www.lccmr.leg.mn/>) makes funding recommendations to the Minnesota Legislature for special environment and natural resource projects, primarily from the Environment and Natural Resources Trust Fund. The LCCMR is made up of 17 members: 5 Senators, 5 Representatives, 5 citizens appointed by the governor, 1 citizen appointed by the Senate, and 1 citizen appointed by the House.

## Proposal & Funding Process

The process begins when the LCCMR issues a Request for Proposal (RFP) for selected funding priorities based on its 6-year strategic plan and ongoing information gathering activities, including expert-led issue seminars and visits to natural resource sites around the state. The LCCMR reviews, evaluates, and ranks all proposals submitted. A selection of the highest ranked proposals are invited to present before the LCCMR.

Based on the total dollars available, a subset of the proposals are chosen to recommend to the legislature. The funding recommendations go before the Minnesota House and Senate in the form of a bill, and upon passage the bill goes to the Governor to be signed into law. Funding becomes available to projects beginning July 1 of the next fiscal year.

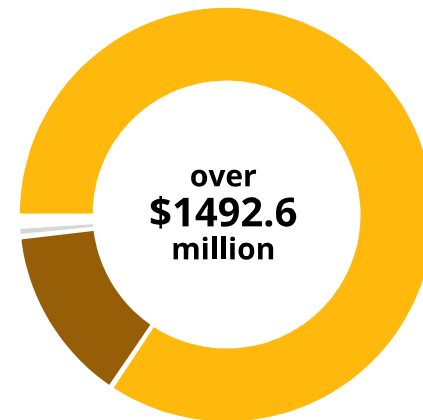


# Outdoor Heritage Fund

## About the Fund

Thirty-three percent of the sales tax revenue from the Clean Water, Land and Legacy amendment is distributed to the Outdoor Heritage Fund. Those funds "may be spent only to restore, protect, and enhance wetlands, prairies, forest and habitat for fish, game, and wildlife." Land acquired with Outdoor Heritage Funds must be open to public hunting and fishing during the open season in accordance with the state constitution.

## Who Administers this Fund?

### The Lessard-Sams Outdoor Heritage Council (LSOHC)

The [Lessard-Sams Outdoor Heritage Council](https://www.lsohc.mn.gov/) (<https://www.lsohc.mn.gov/>) (LSOHC) was established by the legislature to provide annual recommendations on how the Outdoor Heritage Funds should be used. The LSOHC makes recommendations on appropriations of money from the Outdoor Heritage Fund that are consistent with the Constitution and state law and that take into consideration recommendations of the Minnesota Conservation and Preservation Plan that directly relate to the restoration, protection, and enhancement of wetlands, prairies, forests, and habitat for fish, game, and wildlife, and that prevent forest fragmentation, encourage forest consolidation, and expand restored native prairie.

## Proposal and Funding Process

The LSOHC typically puts out a [call for funding](https://www.lsohc.mn.gov/) (<https://www.lsohc.mn.gov/>) in April. It then selects projects to recommend to the Legislature based on a review of the applications and applicant presentations. The LSOHC then puts together an annual funding bill to go before the House and Senate, and upon passage the bill goes to the Governor to be signed into law. Funding becomes available to projects beginning July 1 of the next fiscal year. 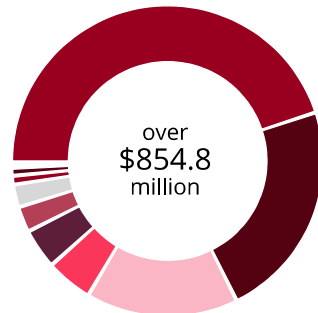
