



INTRODUCTION TO THE REGION NINE DEVELOPMENT COMMISSION

The Region Nine Development Commission, authorized by the Regional Development Act of 1969, was organized by local officials in 1972 "to facilitate intergovernmental cooperation and to insure the orderly and harmonious coordination of state, federal and local comprehensive planning and development programs for the solution of economic, social, physical and governmental problems of the state and its citizens."

(Minnesota Statutes, Section 462.383; Subdivision 2)

Forty-two leaders from across the Region serve on the RNDC. This includes 34 elected officials representing nine counties, 72 cities, 147 townships, school districts and the Minnesota Valley Council of Governments. The eight representatives of special interest groups include: agriculture; commerce; crime prevention; environmental quality; health and human welfare; minority populations; tourism and recreation; and transportation.

The Region Nine area is comprised of nine south central Minnesota counties: Blue Earth, Brown, Faribault, LeSueur, Martin, Nicollet, Sibley, Waseca and Watonwan. Their combined population is 224,936 of the state's 4,838,398 people according to the 1999 Census estimate. St. Peter, Fairmont, North Mankato, New Ulm and Mankato are the five largest cities with populations respectively from 10,038 to 32,347.

COMMUNITY DEVELOPMENT

Governing Body:

Region Nine Development Commission

Program Objectives:

• The primary objective of the Region Nine Community Development program is to provide assistance to local units of government in the areas of planning, financing and general technical assistance. For the most part, this effort has been to assist communities in obtaining state and federal funding for various infrastructure, housing and community development needs. The assistance provided by the Community Development staff takes many forms, including strategic planning, financial resource identification, grant and loan packaging and program administration. Without this assistance, many communities in the region would be unable to successfully compete for scarce federal and state funding for local projects.

- Housing

Without competing directly with other housing service providers in the region, the objective of this service is to provide technical and administrative assistance to communities as they seek to address a wide variety of housing needs.

- Disaster Assistance

The primary objective of this service is to provide technical assistance to individuals and communities so that they might recover completely from natural disasters. Region Nine has committed staff and financial resources to this effort since the rain and flooding disaster of 1993 and continues today by helping in the recovery from the 1997 flooding disaster and most recently the March 29, 1998, tornadoes disaster.

DAY

Fiscal Year 2000 Projects:

• Continued project administration assistance for ongoing projects in these communities:

- **Frost** (public facilities wastewater collection and treatment)
- **Dunnell** (public facilities wastewater collection and treatment)

• Completed housing program administration assistance in the communities of **Gibbon**, **Montgomery** and **St. James**. Assistance included the rehabilitation of 50 single family owner-occupied houses, 62 rental units and 51 commercial properties within these three communities.

• Region Nine continues to be involved in the Community Housing Awareness Information Network (C.H.A.I.N.) regional housing organization. In addition to providing fiscal agent services for the Home Stretch Home Buyer training program, staff also assisted with securing tax-exempt status for this young nonprofit group.

• Completed a comprehensive Housing Study for Sibley County which will help local elected officials in each of the communities make decisions regarding critical housing needs.

• Because the 1998 tornado disaster included major portions of **Brown**, **Nicollet** and **LeSueur** counties, a regional response was required. Region Nine accepted the challenge from the MN Recovers Task Force to coordinate that response. The Region Nine Disaster Assistance Team helped the communities of **St. Peter**, **Comfrey** and **LeCenter** and households in the rural areas with their applications for assistance. Region Nine also placed a full-time staff person in **Comfrey** City Hall almost immediately after the tornadoes to help with disaster assistance issues. In addition, three new staff persons were brought on board and consultants hired to develop and administer a regional housing assistance program. That effort includes nearly \$3 million for the rehabilita-

tion or replacement of damaged or destroyed housing including historic preservation. Region Nine helped the city of **Comfrey** with a comprehensive land use planning effort and then worked on helping the city find the gap financing required to replace their 26 units of subsidized housing as well as the new Municipal Facility.

ECONOMIC DEVELOPMENT

Governing Body: Region Nine Development Commission

Program Objectives:

• The primary objectives of the Economic Development Program are to stabilize and increase the number and quality of jobs in the region. To accomplish this, the staff works with local units of government, businesses and state and federal agencies.

- Assistance to Businesses

The Commission administers four revolving loan funds: the Six County RLF, the Nine County (formerly Disaster) RLF,

the Tornado RLF and the Rural Outbuilding RLF. The intent of these loan pools is to provide a source of long-term, low interest loan funds for business expansion and start-up. All loans have the participation of a local lending institution, and owner equity as well as Region Nine funds.

Since the inception of the RLF program in 1989, the Commission has made more than 125 loans lending in excess of \$7,373,044.

Within FY 2000, the Commission approved 42 loans valued at \$1,897,307. The breakdown of loans is as follows:

The Commission also assists businesses by helping them gain access to state and federal funds through the Minnesota Department of Trade and Economic Development, the Small Business Administration and other sources.

- Assistance to Communities

At times, a community has difficulty with economic development activities because of lack of adequate sewer, water or road systems. The Region Nine staff can assist with state/federal grants and loans to put those facilities into place, thus making economic expansion possible. Staff can also assist communities secure funding for industrial park creation or expansion if conditions within a community are favorable and federal funding is available. At other times, communities need other assistance to make economic development projects become a reality. Such assistance may come in the form of surveys, special studies, organizational assistance or assistance with land use planning. Within the last year, staff assisted the cities of **Blue Earth, Courtland, Montgomery** and **St. James** with local planning implementation activities. Region Nine staff members are always ready to assist communities in their efforts to improve the number of jobs within the region.

The Economic Development staff also assists communities in times of crisis. In FY 2000, the Commission continued to assist in the administration of disaster funds in **LeCenter** -\$1.1 million and **Comfrey** - \$450,000.

- Areawide Cooperation

Improving the economy of the region is a challenge which requires the cooperation and coordination of many agencies and organizations. Region Nine staff work closely with all providers of economic development services to insure that the businesses and communities within the region get the best assistance possible. The providers include local economic development authorities, The Initiative Fund of southeastern and south central Minnesota, the Minnesota Department of Trade and Economic Development, utilities and special interest groups.

Major Thrusts:

Economic Development Administration

Since 1986, the Commission has been designated as an economic development district by the federal Economic Development Administration (EDA). This designation is based on the region meeting certain distress thresholds and submitting an annual plan. The Commission is in the process of updating the Comprehensive Economic

Development Strategy that will state the Commission's overall economic development goals and strategies.

• Rural Outbuilding Revolving Loan Fund Program

In FY 2000, the Commission administered a Rural Outbuilding RLF to assist farmers and other rural businesses who lost outbuildings in the tornado of 1998. It was found that most of the lost buildings were either not insured or severely underinsured. With assistance from DTED and the EDA, the Commission was able to secure close to \$1,000,000 to make zero interest loans to replace lost buildings. A total of 26 loans were made.

• RLF Expansion

There is always more demand for the Commission's RLF funding than there are funds available to lend. Therefore, the Commission is always looking for ways to expand the program. Currently the Commission is considering the following:

- Micro-loans

The Commission is seeking ways to fund a loan pool which would make small (\$5,000 - \$10,000) loans to very small and start-up businesses.

- RLF Recapitalization

The Commission is seeking ways to expand its available funds. Possibilities include an EDA recapitalization or selling off some existing loans on the secondary market.

SMALL BUSINESS DEVELOPMENT CENTER

Governing Body:

Region Nine Development Commission Minnesota Dept. of Trade and Economic Development Small Business Administration

Program Objectives:

• The Small Business Development Center provides free customized consulting services to businesses within the nine-county region. Services, which are offered to both start-up and existing businesses include: business planning, marketing planning, market research, financial analysis, loan packaging, e-commerce, assistance with advertising and promotions, human resource issues and financial record keeping. The staff also provides general information to businesses, such as industry statistics, trade association listings, business directory listings and information on regulatory and tax requirements.

• The Small Business Development Center staff is required each year to:

- complete 3,000 hours of consulting
- complete 50 loan packages
- deliver 8 seminars and workshops

In addition, the staff is required to raise approximately one-half of the annual budget through local sources.

Calendar Year 1999 Projects:

• In 1999, 358 clients were served throughout the region, 52 loan packages were completed and 16 training seminars were attended by 268 people. The majority of the clients came to the SBDC seeking assistance in the areas of business planning, finance and marketing. Of the 1999 clients, 16% were service businesses, 5% were retail, 10% were manufacturing, 65% were start-up companies and the balance were wholesale and construction firms.

• The Small Business Development Center has been successful in its fundraising efforts. In 1999, contributors included banks, utility companies, cities, counties, economic development authorities and private foundations within the region. In addition to local financial support, the SBDC receives \$135,000 in federal and state funding.

LAND USE / TECHNICAL ASSISTANCE / OUTDOOR RECREATION

Governing Body: Region Nine Development Commission

Program Objectives:

• Local units of government are sometimes faced with problems or issues and they lack the staff or expertise to adequately address these issues. Often these concerns are in the area of land use – making the best use of land within their jurisdictions or providing adequate environmental safeguards. At other times the issues may be as far-ranging as capital improvement programming, recreational trail funding or park planning.

The goal of this program area is to be able to respond to local

units of government in a manner that allows for maximum assistance to the community for the least cost. An additional goal is to allow communities to learn from one another when faced with new issues.

Fiscal Year 2000 Projects:

• Applied for a Minnesota Planning Grant to assist local units of government with land use planning.

• Assisted the cities of **Courtland**, **Nicollet** and **North Mankato** and **Nicollet County** with land use issues related to highway 14 expansion.

• Established a regional Trails Council which will work on an areawide plan for recreational trails.

• Initiated a Shared City Administrator program. Worked with a number of interested communities. Three cities – **Courtland**, **Lafayette** and **Nicollet** – have hired a professional city administrator to serve all three communities. Other cities continue to be interested.

• Provided park planning information and assistance to a number of Region Nine communities.

• Worked on recreational trail development with the Trails Council and local units of government.

• Provided numerous consultations and assistance to communities in the Region Nine area.

TRANSPORTATION

Governing Body: Region Nine Development Commission **Advisory Body:** Transportation Advisory Committee

Program Objectives:

• The overall goal of the Region Nine Transportation Program is to work with Mn/DOT and local units of government to maintain and improve the transportation network in Region Nine. The transportation network includes highways, railroads, transit, trails and aeronautics. In Region Nine, most of the concern is with highways.

• By contractual agreement, Region Nine assists the Minnesota Department of Transportation (Mn/DOT) with substate transportation planning and programming. It accomplishes this by actively participating in the Area Transportation Partnership, contributing to Mn/DOT District 7 plans and programs, and preparing its own planning document.

• TEA-21, the federal transportation program, calls for input by local elected officials and citizens. Region Nine helps provide opportunities to accomplish this.

• Region Nine is very active in educating the public and legislators on the need for increased highway funding for rural areas.

• Region Nine assists local highway improvement organizations seeking to upgrade specific highways.

PREVENTION & HEALTHY COMMUNITIES: FETAL ALCOHOL SYNDROME CONSORTIUM

Governing Body: Region Nine Development Commission **Advisory Body:** Fetal Alcohol Syndrome Consortium of South Central Minnesota

The Fetal Alcohol Syndrome Consortium (FASC) of South Central Minnesota is a voluntary association of individuals and agencies interested in preventing fetal alcohol syndrome (FAS) and fetal alcohol effects (FAE), and also assisting families of FAS/FAE children through referral services.

The FASC was established in the fall of 1992 out of need identified by area service providers. The service area includes the following 11 counties: Blue Earth, Brown, Faribault, LeSueur, Martin, McLeod, Meeker, Nicollet, Sibley, Waseca and Watonwan. Consortium members include parents, service providers, media representatives, state and local government agencies and instructors.

The FASC has four committees that work to prevent FAS/FAE:

- The <u>Speaker's Bureau</u> includes parents of FAS/FAE children, service providers and professionals who diagnose the disease. Upon request, a Speaker's Bureau member will give a presentation on FAS/FAE prevention depending upon availability.
- The <u>Youth Committee</u> is responsible for coordinating FAS/FAE prevention events with the assistance of area youth. The committee members are currently working on a youth conference and a television public service announcement.
- <u>Media Committee</u> members also assist with public service announcements. The committee is working on a billboard

campaign that will run prior to and through the month of May in conjunction with Mother's Day. Also, through the use of the FASC library, items such as posters, brochures, videos, books, flyers and other information can be distributed to community members within the FASC service area.

• Members of the <u>Conference Planning Committee</u> are responsible for coordinating the annual FAS/FAE conference for professionals. Approximately 300 individuals are trained at the conference each year. Topics include an introduction of FAS/FAE, working with children and families after diagnosis.

In addition:

• FAS/E prevention materials are available to check-out from the FAS Resource Library. The library includes books, videos, slides, professional journal articles, brochures and three "Baby Think It Over" simulators (one FAS-affected, one drug-affected, and one normal simulator).

• There have been an average of three FAS presentations per month from the FASC Speaker's Bureau members within the last fiscal year.

• FAS/E information written in Spanish has been provided to Latino populations throughout the FASC service area.

• The annual FAS conference was held November 10, 1999, at SCTC in North Mankato. The conference was titled "Restless Journey: Living with Alcohol-Related Birth Defects." Approximately 300 youth, parents and professionals were trained by doctors and other leaders from the industry.

• In the spring of 2000 the FASC established a billboard campaign to run the months of May and June to complement Mother's Day and Father's Day. One billboard with an FAS prevention message was placed in each of the 11 counties served by the FASC.

• Information written in Spanish about FAS/E prevention has been continuously provided to Latino populations within the service area through local outreach efforts.

There are also legislative efforts with local and state officials to emphasize the importance of FAS/FAE prevention. The FASC has an established work plan that is reviewed annually to insure the prevention of fetal alcohol syndrome/fetal alcohol effects. The consortium meets on a quarterly basis.
