# Report on Minnesota Students in Travel Abroad Programs 2023-24

Minnesota Statutes, section 5A.03, subdivision 2, requires the Minnesota Department of Education to:

- Annually report information on the number of Minnesota student deaths and hospitalizations due to
  accidents and the illnesses that occurred while Minnesota students were participating in a foreign exchange
  or study or other travel abroad program that resulted from Minnesota students participating in the program.
  The name and type of foreign exchange or study or other travel abroad program and the city or region where
  the reported death, hospitalization due to accident or illness occurred must also be reported.
- 2. Include links to both the United States Department of State's Consular Information Program that informs the public of conditions abroad that may affect students' safety and security.

Publicly available reports on sexual assaults and other criminal acts affecting students participating in a foreign exchange or study or other travel abroad program must also be included.

# School Year 2023-24

During the 2023-24 school year, **no incidents of travel** related illness that required hospitalization or deaths were reported.

## Information on Areas Not Deemed Safe for Travel

<u>Central Intelligence Agency (CIA) World Fact Book</u> provides information about country profiles. The section of the World Fact book country profiles describes a country's historical relations with the U.S. and any recent military conflicts, which may inform a district or charter's decision to travel to that country. The website also provides periodic updates about changing conditions that may be relevant to traveler safety.

Office of Higher Education Study Abroad Health and Safety Report provides health and safety information for college students attending a Minnesota campus or studying abroad. The Study Abroad Health and Safety Data report on death and hospitalization incidents that occurred during and as a result of program participation from the previous academic year is updated annually.

<u>Students Abroad</u>, a U.S. Department of State consular affairs website, provides comprehensive information on specific destinations by country. The site includes information for students with special considerations – such as women, travelers with disabilities and LGBTI travelers. Travel advisories can be seen on a color coded map.

Additionally, you can search for the nearest <u>U.S. embassy or consulate</u> and a find a list of resources on their website.

<u>United Nations Office on Drugs and Crime</u> produces and disseminates accurate statistics on drugs, crime and criminal justice at the international level. Your search can be filtered by type of crime, region and country.

<u>U.S. Department of State</u> provides information about <u>international travel</u> including an option to <u>enroll in Smart Traveler</u> <u>Enrollment Program (STEP)</u>, a free service that allows U.S. citizens and nationals traveling and living abroad to enroll their trip with the nearest U.S. Embassy or Consulate.

Reports and data required by Minnesota Statutes, section 135A.15, subdivision 6, will be prepared and published as summary data, as defined in <u>Minnesota Statutes, section 13.02, subdivision 19</u>, and will be consistent with federal and state laws governing access to educational data and student privacy.

The Study Abroad Health and Safety Report is provided by the OHE to report study abroad health and safety incident data in addition to data on student participation. The annual report for 2015-19 can be seen by country on the <u>Study Abroad Health and Safety report</u>.
