Background

The Minnesota Department of Natural Resources' (DNR) mission is to work with Minnesotans to conserve and manage the state's natural resources, to provide outdoor recreation opportunities, and to provide for commercial uses of natural resources in a way that creates a sustainable quality of life. The DNR uses a wide range of programs to fulfill this mission, including permitting programs established by the Minnesota Legislature. Many of these have been in place for decades, while others are more recent. It is important to review regulatory programs over time to ensure that they continue to address the needs of the state. The DNR is committed to maintaining a modern, efficient, and effective regulatory system.

This report meets the requirements of Minnesota Statute (MS) 84.027, Subd. 14a.

Scope of Report: Environmental and Natural Resource Permits

The DNR is reporting on the following natural resource permits:

- Aquatic plant management permits
- Invasive aquatic plant management permits
- Water appropriation permits
- Public waters work permits
- Endangered or threatened species taking permits
- Metallic mineral mining permits (ferrous and non-ferrous)
- Peat mining permits

These permits are relevant to the concerns underlying MS 84.027 Subd. 14a. This report does not include other DNR permit programs that focus mainly on recreational activities, such as hunting and fishing.

Summary Statistics for 150-Day and 90- Day Goal Attainment

The DNR's goal is to approve or deny permit applications within 90 days of receiving a complete application (Tier 1 permit applications) or within 150 days of receiving a complete application (Tier 2 permit applications). Tier 1 permit applications, which are subject to the 90-day goal, include general permits for work in public waters in addition to water appropriation and aquatic plant management permit renewals that do not require a site inspection. The remaining permit types listed above fall into Tier 2 and are subject to the 150-day goal. The DNR manages a large number of permit applications. DNR permitting activity for fiscal year 2023 included:

- 1,061 permit applications in progress on July 1, 2022,
- 9,285 new applications received,
- 8,889 applications approved or denied,
- 779 applications withdrawn, and
- 678 applications in progress after June 30, 2023.

DNR continued do well in meeting the permitting goals. We found that low staffing levels contributed to several permit delays due to workload capacity issues. The number of permits and the complexity of the permits can impact workload. Permits with complex technical issues can take significant staff time to resolve, which can reduce the total hours available to process other applications. Vacancies in key permitting positions also contributed to workload capacity issues. Other delays were the result of project proposers submitting incomplete or inaccurate permit applications, or the need for additional information, environmental review, or resolution of compliance or technical issues. In some cases, the permit application was submitted in advance of a particular season and may not have been processed until closer to the start of the season or when seasonal conditions allowed certain requirements to be met. Table 1 summarizes how well DNR met the 90-day goal for Tier 1 applications and Table 2 summarizes how well DNR met the 150-day goal for Tier 2 applications.

Of the 5,270 Tier 1 permit applications for which a decision was made in fiscal year 2023:

- 5,051 Tier 1 permit applications, 95.8%, were approved or denied within 90 days of receiving an initial application,
- 5,159 Tier 1 permit applications, 97.9%, were approved or denied within 90 days of receiving a complete application, and
- 111 Tier 1 permit applications, 2.1%, took longer than 90 days to approve or deny following a complete application.

Of the 3,619 Tier 2 permit applications for which a decision was made in fiscal year 2023:

- 3,181 Tier 2 permit applications, 87.9%, were approved or denied within 150 days of receiving an initial application,
- 3,438 Tier 2 permit applications, 95.0%, were approved or denied within 150 days of receiving a complete application, and

• 181 Tier 2 permit applications, 5.0%, took longer than 150 days to approve or deny following a complete application.

Table 3 details the causes of delay for the 111 Tier 1 permit decisions that took more than 90 days from a complete application for a DNR decision. Table 4 details the causes of delay for the 181 Tier 2 permit decisions that took more than 150 days from a complete application for a DNR decision.

Many aquatic plant management permit applications are routinely submitted well in advance of the permitting season, which can cause increased delays from application submission since site inspections (required for Tier 2 permit applications) cannot occur until plant growth begins. This is a major cause of delays for aquatic plant management permits and is typically the reason they are marked "Other" in the reason for not meeting the goal.
