Introduction

The 1990 Minnesota Legislature appropriated \$2,817,000 for Fiscal Year (FY) 1991 Metropolitan Area regional park operations and maintenance grants (See note below). The funds, appropriated to the Minnesota Department of Trade and Economic Development, were distributed by the Metropolitan Council to regional park implementing agencies pursuant to Minnesota Statute 473.351. That statute requires the Council to report the amount granted to each agency and its estimate of the percentage of park operations and maintenance budget financed by these grants.

Grant Disbursements

The table below illustrates each regional park implementing agency's 1990 operations and maintenance budget, the FY 1991 state grant to the agency distributed in 1990, and the estimated percentage of the agency's 1990 park operations and maintenance budget financed by the state grant. The table illustrates that, on average, 9.1 percent of regional park operations and maintenance budgets were financed with these grants.

Note: The initial appropriation of \$3 million for this program made by the 1989 Legislature was reduced by the 1990 Legislature which allocated \$120,000 for fishing piers on the Mississippi River and cut the appropriation \$63,000 to conform to a general reduction pursuant to Laws of Minnesota 1990, Chapter 594, Section 24.
