Introduction

The 1991 Minnesota Legislature appropriated \$2,759,000 for Fiscal Year (FY) 1992 Metropolitan Area regional park operations and maintenance grants. The funds, appropriated to the Minnesota Department of Trade and Economic Development, were distributed by the Metropolitan Council to regional park implementing agencies pursuant to Minnesota Statutes 473.351. That statute requires the Council to report the amount granted to each regional park implementing agency and its estimate of the percentage of park operations and maintenance budget financed by these grants.

Grant Disbursements

The table below shows each regional park implementing agency's 1991 operations and maintenance budget, the FY 1992 state grant to the agency distributed in 1991, and the estimated percentage of the agency's 1991 park operations and maintenance budget financed by the state grant. The table illustrates that, on average 8.3 percent of regional park operations and maintenance budgets were financed with these grants.
