**Subject: Minnesota POST Board Annual Submission of Rulemaking Docket and Official Rulemaking Record, as Required by Minnesota Statutes, section 14.116(a)**

*Minnesota Statutes, section 3.197 states required reports sent to the legislature must contain the cost of preparing the report at the beginning of the document. The cost to prepare this report was approximately \$60.*

Dear Legislators:

Minnesota Statutes, section 14.116, unit (a) requires agencies to submit their rulemaking docket maintained under section 14.366 and the official rulemaking record required under section 14.365 for any rule adopted during the preceding calendar year to the legislature by January 15. This report must be submitted to the chairs and ranking minority members of the legislative policy and budget committees with jurisdiction over the agency's rules. Accordingly, attached to this report is a copy of the rulemaking docket kept by the Minnesota Board of Peace Officer Standards and Training (POST Board). The docket, which is updated on a regular basis to reflect the current status of our rulemaking projects, can also be found on the POST Board's website under "Current Rulemaking Activity" at <https://mn.gov/post/boardscommittees/rules/currentrulemakingactivity/>. The POST Board has two rulemaking projects open. The first is under Revisor's Number 4750 and the second 4850. A Request for

Comments has been posted in the State Register for both projects and the comment periods will remain open until February 2024.

Within the previous calendar year, under Revisor's Number 4641, the POST Board adopted rules within Minnesota Rules, chapter 6700 regarding peace officer standards and training. An Official Rulemaking Record was kept pursuant to Minnesota Statutes, section 14.365 to document the rulemaking process. The Official Rulemaking Record is not attached to this report due to its significant size. Please note that electronic copies of documents from the rulemaking record can be viewed on the Revisor's website via the "Minnesota Rule Status" webpage at <https://www.revisor.mn.gov/rules/status/>. Rulemaking documents can be searched on this website using the Revisor's Number, keywords, the agency name, rule, or statutory authority.
