MR. PRESIDENT: The Chair recognizes Mr. Holmquist.

MR. HOLMQUIST: Mr. President, I now move the Senate do adjourn until 2 p.m. tomorrow, Wednesday.

MR. PRESIDENT: Senator Holmquist has moved that the Senate do now adjourn to Wednesday, 2 p.m.

MR. HOLMQUIST: Mr. President.

MR. PRESIDENT: Mr. Holmquist.

MR. HOLMQUIST: Mr. President, I make this motion in view of the fact that the Senate has not been organized. That everyone has agreed that there of necessity must be a judicial determination and consequently with the Senate not being organized, that's the only order of business before us at this time.

MR. COLEMAN: Mr. President.

MR. PRESIDENT: The Chair recognizes Mr. Coleman.

MR. COLEMAN: Mr. President, I rise to speak against the motion to adjourn until 2 p.m. tomorrow. I rise to speak against the statements by the distinguished Senator from Meeker that we are not organized and that we are not ready to do business. Mr. President, those who remained in the Chamber after the other side of the aisle has walked out for the fourth consecutive day, will know that we have bills that have been introduced in the Minnesota State Senate; that we do have committees meeting; that we have received executive communications from the governor; that we have appointed committees; that we have passed a number of resolutions and are proceeding with the business of the Senate. I see no need to change that. The DFL caucus is ready to get on with the business of the state and I speak against the motion to adjourn at this time.

MR. HOLMQUIST: Mr. President.

MR. PRESIDENT. The Chair recognizes Mr. Holmquist.

MR. HOLMQUIST: I call for a roll call.

MR. PRESIDENT: Roll call vote. The Chair recognizes Mr. Dosland. MR. DOSLAND: Mr. President, at this very hour (inaudible)

MR. COLEMAN: Mr. President.

MR. PRESIDENT: The Chair recognizes Mr. Coleman.

MR. COLEMAN: Mr. President, the distinguished Senator from Clay has many virtues but reading minds is not one of them. I have not divulged my thoughts to anyone in particular and I do not do so at this time. I simply say, Mr. President, and its been said before that the position of the DFL caucus and it's my personal position that we have to get on with the business; that the courts do not have jurisdiction in this case and while it's proved that we did ask for additional time to present an oral argument and this time was granted until approximately 2 p.m. today, that was done solely for the purpose of adding additional information and additional weight to our argument that we are/coequal branch of government and must resolve our own difficulties and should not and cannot look to the courts to rescue any particular faction either now or in the future. The actions that are taken by the Senate may be judged at some later date but we are ready to go, we do wish to proceed this afternoon with the business of the State of Minnesota and I renew my plea not to adjourn at this time.

MR. COLEMAN: Mr. President and members of the Senate, the distinguished Senator from Clay, before he left the room in a mistaken interpretation of the count, brought to the attention of the body that there is allegedly an injunction against Mr. Flahaven serving as secretary of the Senate. One of our members went over and talked to Mr. Dosland and apparently it was signed by the Chief Justice of the Supreme Court on January 7 issuing an order that Mr. Flahaven appear before him on January 11 and that he be enjoined from performing his duties as Secretary of this Senate. Now if we need ask any more why the Court should not be in this, let's just look at that particular matter. We have opened the floodgates to the Court running the Minnesota State Senate and legislature by allowing the courts to interfere with what's going on in this Chamber. I'm not an attorney, I have served, however, in the Senate for eight years and I have never seen anything so crass in my life. Now that order was not served so maybe somebody lost heart at the last moment and got cold feet but I ask the members of this Senate and I ask the members of the public to just ask themselves what kind of a body are we going to be if the

Courts are going to tell us whom we may hire for everything from Page to Secretary of the Senate, if the Court is going to be interfering in our affairs at every moment. I ask you all to consider this very, very carefully and the very severe and the very dangerous constitutional in precedent that is attempted to be established in a motion/a move like that.
