

**Dear Governor Walz, Senators, Representatives, Ms. Yurich, and Revisor Inman:**

Minnesota Statute § 14.05, subdivision 5, directs state agencies to report to you by December 1 of each year whether any of their rules are obsolete, unnecessary, or duplicative of other state or federal statutes or rules. The Minnesota Board of Chiropractic Examiners has reviewed its rules and found that **Minnesota Rule 2500.1150, paragraph A** regarding the fee for Peer Review is obsolete and unnecessary. This rule became obsolete when the corresponding Minnesota Statute § 148.106 regarding Peer Review of services and fees was repealed; and it has been reported as obsolete in years past. Additionally, **Minnesota Rule 2500.2505** contains MBCE's prior address, the MBCE is now located at 335 Randolph Ave, Suite 280, St. Paul, MN 55102.
