Introduction

On May 23, 2023, the legislature signed into law legislation requiring the Department of Public Safety Driver and Vehicle Services division (DVS) to submit a report on special plates annually by Feb. 1 to the legislative committees with jurisdiction over transportation policy and finance (Laws of Minnesota 2023, Regular Session, Chapter 68, HF2887, Article 5, Section 15).

The report must identify the number of special plate issuances and total plate counts for each type of special plate, with a breakout by each alternative or additional design. This information was collected using MNDrive data and is outlined in Table 1.

For plates that require a one-time or annual contribution, DVS must also provide a fiscal summary of the contributions, including to specify the appropriate contribution account, identify the total contributions received in the two most recently completed fiscal years and identify the direct recipients of contribution funds. This information was obtained through the Statewide Integrated Financials Tool (SWIFT) and is outlined in Table 2.

DVS must also provide a description of how contribution funds were spent in the prior fiscal or calendar year, as provided by each direct recipient. For any entity that receives special plate contribution funds under Chapter 168 directly from the commissioner, they must submit information on contribution fund expenditures in the form and manner specified by the commissioner. Refer to the Contribution Fund Spending section for this information.

Special Plate Issuances and Counts – Table 1

In fiscal year 2023, there were 30 different special plate styles available. Including alternative and additional designs, the total is 114 special plate styles available.

There were a total of 822,174 special plates registered for fiscal year 2023. DVS issued a total of 161,902 new special plates during that same time frame.

Special Plate Contributions – Table 2

In fiscal year 2022, there were nine special plate types available where contribution fees were required either on a one-time or on an annual basis. Including alternative and additional designs, the total is 50 special plate styles available.

Contribution fees collected from special plates in fiscal year 2022 totaled \$10,829,802.79.

In fiscal year 2023, there were 10 styles available where contribution fees were required either on a one-time or on an annual basis. Including alternative and additional designs, the total is 51 special plate styles available.

Contribution fees collected from special plates in fiscal year 2023 totaled \$11,979,065.26.

Contribution Fund Spending

AGRICULTURAL PLATE 168.1285

Funds are paid out to the MN Future Farmers of America (FFA) Foundation to support the mission of the foundation and the U of M Extension Service to support Minnesota 4H programming and activities.

The funds paid to the MN Future Farmers of America (FFA) in fiscal year 2023 were used to support the MN FFA State Leadership Conference.

The funds paid to the U of M Extension Service in fiscal year 2023 were not spent. The contributions will be allocated towards a 4-H agriculture position beginning in 2025 when current grant funding ends.

COLLEGIATE PLATES 168.129

Funds collected are deposited by the commissioner in the scholarship account created in the state treasury. The funds are appropriated to the governing board of the institution to which it is attributable.

CRITICAL HABITAT PLATES 168.1296

Funds collected are credited to the Minnesota critical habitat private sector matching account established in section 84.943. Money in the account is appropriated to the commissioner of natural resources only for the direct acquisition, restoration or enhancement of land or interests in land as provided in section 84.944.

LAW ENFORCEMENT MEMORIAL PLATES 168.1294

Funds are paid out to the Minnesota Law enforcement Memorial Association, which must use the funds to further the mission of the association in assisting the families and home agencies of Minnesota law enforcement officers who have died in the line of duty.

The association submits a report to the commissioner of public safety and to the chairs and ranking minority members of the legislative committees with jurisdiction over transportation policy and finance by Jan. 15 of each year that includes an itemized list of each expenditure the association made with the funds received under this section for the previous calendar year. MINNESOTA 100 PLATES 168.1284

Funds collected are paid out to the Minnesota 100 Club to further the organization's mission and purpose of providing charitable gifts and contributions.

The Minnesota 100 Club did not receive any contribution payments until the end of fiscal year 2023; therefore, no spending of funds collected occurred during this time frame. The funds are distributed annually at the end of the fiscal year.

MINNESOTA GOLF PLATES 168.1299

Funds collected are paid out to the Minnesota Section PGA Foundation to be used to enhance and promote the game of golf throughout Minnesota.

The fund paid to the Minnesota Section PGA Foundation in fiscal year 2023 were used to fund various youth and veteran/military golf programs throughout Minnesota. See Table 3 for detailed information on these expenditures.

MINNESOTA STATE PARKS & TRAILS PLATE 168.1295

Funds collected are credited to the state parks and trails account established in section 85.056. Money in the account is appropriated to the commissioner of natural resources to operate and maintain the state parks and trails system.

PROUD TO BE A VETERAN PLATE 168.1255

Funds collected from the one-time contribution are paid to the World War II memorial donation match account. Funds remaining in the account after the state share of the construction costs of the World War II memorial has been paid in full is appropriated to the commissioner of veterans' affairs for services and programs for veterans and their families.

START SEEING MOTORCYCLES PLATE 168.1282

Funds collected are paid out to the motorcycle safety fund created under section 171.06, subdivision 2a and are annually appropriated to the commissioner of public safety to carry out the motorcycle safety education program as outlined in statute 171.335.

SUPPORT OUR TROOPS PLATE 168.1298

Funds collected are paid out to the Minnesota "Support Our Troops" account and appropriated equally to the Department of Military Affairs and the Department of Veterans Affairs for uses outlined in section 190.19.

The adjutant general and commissioner of veterans' affairs must report by Feb. 1 each year to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over military and veterans' affairs on the number, amounts and use of grants made by each agency from the Minnesota "Support Our Troops" account in the previous year.
