Dear Senators and Representatives:

This letter is to notify you of direct appropriation transfers approved by Minnesota Management & Budget (MMB) in the quarter that ended December 31<sup>st</sup>, 2023. All transfers are general fund, unless otherwise noted.

This letter is notification as required by Laws 2019, First Special Session, chapter 9, article 14, section 12. This notification also complies with the requirement for the Department to report transfers in Minn. Stat. §256.01, Subdivision 41, clause (2).

You can find the legal authority and accounting detail for each transfer itemized in this letter by the corresponding reference item number in the **Summary of Accounting Detail for Approved Direct Appropriation Transfers** attached to this letter. Service level and interagency agreements that were authorized between October and December 2023 are conveyed under a separate required quarterly report to the Legislature.

## FY 2024 Transfers – 2<sup>nd</sup> Quarter

- 1. A transfer from BACT 11 GF Operations to the Office of Enterprise Sustainability for \$60,000.
- 2. A transfer of \$304,356 was made from MN Dept of Corrections to BACT 33 Medical Assistance Grants for state share inpatient claims.
- 3. A transfer of -\$312,000 from BACT 11 GF Operations was made to BACT 16 MN.IT Systems to correct the base amount that was entered incorrectly.
- 4. A \$5,354,000 transfer from BACT 11 GF Operations to BACT 11 FMO Systems Operations for an operating adjustment.
- 5. A pair of transfers for \$1,427,485 for MFP Rebalancing:
  - One from BACT 33 Medical Assistance Grants to BACT 14 MFP Rebalancing Admin
  - One from BACT 33 Medical Assistance Grants to BACT 52 MFP Rebalancing Grant
- 6. Two transfers needed for correction on the Quality Rating and Improvement System:
  - Part one from MN Dept of Education to BACT 12 GF Operations for -\$806,900
  - Part two from MN Dept of Education to BACT 43 CC Development Grants (MDE) for \$806,900
- 7. A \$2,941,000 transfer from BACT 12 GF Operations to BACT 11 GF Operations for DCYF transition work.
- 8. A transfer from BACT 11 GF Operations to BACT 13 Admin-Standard MA (Rider) for \$500,000 as part of the MA Renewal outreach for the health care unwind effort.
- 9. A \$4,405,000 transfer from BACT 45 Indian Child Welfare Grant (Rider) general fund appropriation to BACT 12 Child Welfare Training special revenue account as part of a legislative grant increase.
