Postal Verification Card Report for elections held between January 1, 2023 – December 31, 2023

Cost of Report Preparation

The total cost for the Office of the Secretary of State to prepare this report was approximately \$624. These costs include staff time answering questions from the counties as they compiled the report, compiling the submitted data, and preparing the written report.

Estimated costs are provided in accordance with *Minnesota Statutes*, section 3.197, requiring the cost for preparing a report to be provided at the beginning of a report to the legislature.

Required Report

This report was prepared in accordance with *Minnesota Statutes*, section 201.121, subd. 3, which was updated during the 2021 First Special Session to require that this report be made each year and must include each election that may occur in a county. This statute states:

Within ten days after an election, the county auditor shall send the notice required by subdivision 2 to a random sampling of the individuals registered on Election Day. The random sampling shall be determined in accordance with the rules of the secretary of state. As soon as practicable after the election, the county auditor shall mail the notice required by subdivision 2 to all other individuals registered on Election Day. If a notice is returned as not deliverable, the county auditor shall attempt to determine the reason for the return. A county auditor who does not receive or obtain satisfactory proof of an individual's eligibility to vote shall immediately notify the county attorney of all of the relevant information. By February 15 of each year, the county auditor must notify the secretary of state of the following information for each election held in the previous year by each precinct:

- (1) the total number of all notices that were returned as nondeliverable;
- (2) the total number of nondeliverable notices that the county auditor was able to determine the reason for the return along with the reason for each return; and

(3) the total number of individuals for whom the county auditor does not receive or obtain satisfactory proof of an individual's eligibility to vote.

(b) By March 1 of every year, the secretary of state shall report to the chair and ranking minority members of the legislative committees with jurisdiction over elections the following information for each election held in the previous year by each precinct and each county:

(1) the total number of all notices that were returned as nondeliverable;

(2) the total number of nondeliverable notices that a county auditor was able to determine the reason for the return along with the reason for each return; and

(3) the total number of individuals for whom the county auditor does not receive or obtain satisfactory proof of an individual's eligibility to vote.

After a county auditor adds a new voter registration record or updates the record of a currently registered voter in the statewide voter registration system (SVRS), a confirmation notice is mailed to the voter. This mailed notice, known as a postal verification card (PVC), confirms the voter's registration and advises the voter of their polling place location and elective districts. The notice must be mailed non-forwardable, so its delivery can verify that the voter lives at that address.

If a postal verification card is returned as undeliverable, the record of the voter must be marked as "challenged" in the statewide voter registration system. As a result, should the voter vote at that address in the future, they will be asked questions under oath to must resolve the challenge before proceeding in the voting process. *Minnesota Statutes* section 201.121, subdivision 2.

This report reflects the returned postal verification cards from voters who registered to vote on Election Day as required by Minnesota Statutes 201.121, subdivision 3. State statute requires the county auditor to attempt to determine the reason for the postcard's return and determine if they can obtain satisfactory proof of an individual's eligibility to vote. To determine the reason for return, the county auditor may examine if there was a typo in the voter's name or address that made the postcard undeliverable, if an apartment or unit number was inadvertently omitted from the registration application, or if the voter may have moved since Election Day. If the county auditor cannot find satisfactory evidence of the voter's eligibility, they are required to turn the matter over to the county attorney for further investigation and potential prosecution.

Beginning in the 2010 general election, county auditors are required to report the number of notices referred to their county attorneys to the Secretary of State. This data is captured on the attached spreadsheet in column D.

The attached pages include a compilation of the reports that the Office received from county auditors. It provides the final disposition of the post cards (columns D, E, F), including the determined reason for return (columns G through Z), by precinct and county as required by statute. In the event any additional information is gathered from county auditors, this report will be updated.
